ORDER

Whereas M/s AVBS Digital Solutions Pvt. Ltd., New Delhi supplied a Photocopy Machine Toshiba E-Studio 756SE bearing Sr. No. CKA-210105 with five years warranty for Rs. 649237/- against Purchase Order No. 36 dated 07.05.2014.

Whereas Photocopy Machine Toshiba E-Studio 756SE was installed by the Engineer of M/s AVBS Digital Solutions Pvt. Ltd. at Legal Section, University of Delhi on 20.05.2014.

Whereas M/s AVBS Digital Solutions Pvt. Ltd. submitted a Performance Security Guarantee (Bond Form) for Rs. 64,924/- issued by Bank of Baroda valid upto 31.07.2019.

Whereas Performance Security Guarantee (Bond Form) was sent to the Bank of Baroda for verification.

Whereas the Bank of Baroda returned the Performance Security Guarantee (Bond Form) in original on 22.07.2015 with remarks "the Performance Security Guarantee has not been issued by the bank".

Whereas a letter was despatched as well as e-mailed on 31.07.2015 to M/s AVBS Digital Solutions Pvt. Ltd. demanding clarification against Performance Security Guarantee (Bond Form).

Whereas the University did not receive any reply till 24.08.2015 from M/s AVBS Digital Solutions Pvt. Ltd. a reminder letter was issued as well as mailed on 24.08.2015 to M/s AVBS Digital Solutions Pvt. Ltd., New Delhi with the direction to furnish the clarification within 10 days.

Whereas even after the issue of reminder letter dated 24.08.2015 M/s AVBS Digital Solutions Pvt. Ltd. failed to submit necessary clarification in this regard.

Whereas a Memorandum dated 15.10.2015 was issued to M/s AVBS Digital Solutions Pvt. Ltd. allowing them to submit the necessary clarification within 10 days time limit from the date of issue of the memorandum.

Whereas in reply to the memorandum dated 15.10.2015 M/s AVBS Digital Solutions Pvt. Ltd. failed to submit the necessary relevant facts regarding Performance Security Guarantee (Bond Form).

Now, University of Delhi has decided to blacklist your company namely M/s AVBS Digital Solutions Pvt. Ltd. for a period of 03 years from the date of issue of this order for not taking appropriate action required under Comprehensive Service Maintenance Contract (CSMC) Contract, and breach of trust. This does not prejudice the right of the University of Delhi to take any other legal action as per Law.
