PH.D. NOTIFICATION

Ph.D. Programme of Faculty of Law is governed by Ordinance VI-B dt. 21/7/15 of University of Delhi. Ph.D. is a full time course with a two years mandatory residency period in which the applicant cannot engage in any profession or occupation or practice etc. of Law. Further details may be seen in Ordinance VI-B.

The admission to the Ph.D. programme is by way of entrance test and/or interview by the Departmental Research Committee. Those who have cleared a National Level Examination like CSIR/UGC-NET-JRF, DVT-JRF, ICMR-JRF, DST-inspire or equivalent valid fellowship may appear for interview without appearing in the departmental test. Any other claim to the exemption should be taken by clearance (in writing) from the office of the Dean, Faculty of Law, otherwise the same would not be applicable. The next entrance test after this test would be held only after July, 2016.

The applications for entrance test alongwith research proposal in detail have to be submitted **latest by 24th September, 2015** together with the **Demand Draft of Rs. 700/- (Rs. 350/-for SC/ST/PWD/CW category candidates)** in favour of the Registrar, University of Delhi payable on any bank at Delhi.

Date of Test & Interview

The applicant would be required to appear for interview/Viva-Voce before the Departmental Research Committee in the office of the Dean, Faculty of Law. The date of the written test is likely to be within 02 weeks from the last date and shall be notified [on the notice board of the Law Faculty and University website] minimum of 10 days in advance. The date of interview will be notified/ displayed on the Notice Board of the Faculty as well as on the University Website (www.du.ac.in). No personal communication would be sent to any candidate.

Research Projects

All applicants for registration to Ph.D, whether appearing in entrance test or who are in exempted category have to submit their research proposal in consultation with Faculty members of this faculty.


More details for test and the syllabus for the entrance test shall be notified by 3rd September, 2015 which is likely to consist of :

- (i) Compulsory area of jurisprudence, Technique of Law and Governance.
- (ii) One portion would be objective,
- (iii) Minimum of 60 % of test would be descriptive answers.

The entrance test will be of 2 hrs duration. The candidate has to attempt three questions in all and one from each part from the following likely areas:

- 1) Cyber Law & Information Technology Law
- 2) Intellectual Property Right Law
- 3) Taxation, Finance and Corporate Laws
- 4) Environmental Law & Human Rights
- 5) Competition, Trade and Economic Laws.

- 8) Corporate Laws
- 9) International Law.
- 10) Arbitration, Conciliation & Negotiation (including their International aspects)
- 11) Insurance & Banking Law
