The Department of Business Economics offers Ph.D. in Business Economics.

Eligibility Criteria: M.Phil / Master's degree from the University of Delhi or any other recognized University in Economics/ Environmental studies/ Commerce/ Management with minimum of 55% marks or equivalent grading.

Admissions in the Ph.D programme will be governed by the detailed provisions given in revised Ordinance VI-B of the University of Delhi.

Selection Criteria: Candidates are required to appear for an entrance examination followed by interview in the Department of Business Economics, University of Delhi, South Campus, New-Delhi-110021.

Short-listed candidates will be called for second round of interview.

Following weightage will be given to various components for admission to the Ph.D. programme :

1. Past Academic Record

(Marks obtained in Post Graduation and M.Phil.)

10% weightage will be given to past Academic Record.

Since most of the candidates are expected from Economics and Commerce stream, following mechanism of equivalence of marks obtained by a candidate will be adopted:

2. Research Proposal*:

20% weightage will be given to the research proposal. This will be evaluated on the basis of research aptitude and subject clarity of the applicant.

*(60% weightage will be given to the research proposal for candidates who, as per Delhi University guidelines, are exempt from the Entrance Test)

3. Written Test:

40% weightage will be given to the written Test. To judge the analytical skill there will be three exercises based on analytical writing on topics related to Current Affairs, Economics and Business. Candidates will be required to attempt any two out of these 3 exercises.

4. Interview:

30% weightage will be given to interview

Course work for the Ph.D. Programme:

All those selected for admission to the Ph.D programme will be required to do course work of **two semester** duration, and will be evaluated at the end of each semester. These students will be given provisional admission.

Passing marks for each course is 50%. Evaluation will be done on the basis of written examination and term paper for each course.

Provisional admission to the Ph.D. programme of these students will be confirmed only after successful completion of course work and defense of the Ph.D thesis topic in a departmental seminar.

Admission Procedure:

Prescribed form is available from the office of the Board of Research Studies of the Faculty of Applied Social Sciences and Humanities, Department of Business Economics, Room No. 229, Arts Faculty Building, University of Delhi South Campus, Benito Juarez Marg, Dhaula Kuan, New Delhi-110021, **from Monday to Friday from 10.00 a.m. to 5.00 p.m. from 21st March, 2016.**

Candidates are required to submit a research proposal of around ten typed pages along with the prescribed form. Areas of study in which research proposal will be accepted are as follows:

Climate Change and Energy Economics; Economics of Education; Economics of Waste; Environment, Resource & Health Economics; Impact of International Trade & Capital Flows on Emerging Economies; Industrial Economics; Informal sector and Industry; Poverty and Income Inequality; Economic Growth and Development; etc.

The research proposal should be as per the format attached.

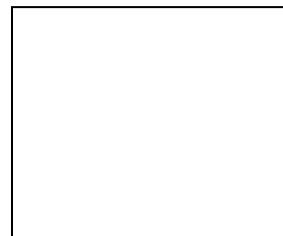
