## **DECLARATION ON SOLEMN AFFIRMATION**

her	reby solemnly affirm as under:
1)	That I have filled in this Application Form in my own handwriting
2)	That statements made above are correct and that inaccurate particulars would attract punishment under laws.
3)	That I am aware that I have to abide by all the Statutes, the Ordinances and Rules presently existing or made in future concerning the students of the University and the Faculty of Law; I accept to abide by the same.
4)	That I am aware as per A.C. Resolution 40 dated 24/04/1997 of University of Delhi, no student of the University shall be permitted to pursue two degree courses simultaneously either form the University of Delhi or from other University except for part-time diplomas/certificates courses of the University of Delhi. I hereby declare that I am not studying simultaneously for any other degree course in this or any other University or Institution.
