

NOTICE FOR LL.B. ADMISSION

Date: Oct.7, 2017

(In compliance with the order passed by the High Court of Delhi dated 26.09.17 in W.P.(C) 5118/2017)

As per the above order, Faculty of Law, University of Delhi has been directed by the High Court of Delhi to admit students on supernumerary seats over and above the sanctioned strength of 2310 seats in LL.B. Hence, additional admissions were announced to fulfil the seats that have fallen vacant as a consequence of adding the supernumerary seats to the total of 2310 seats. Counselling for additional seats took place on 3rd October 2017

It is hereby notified to all ST applicants, who have secured marks 01 to 51 in LL.B Entrance exam, 2017, that last counseling shall be held on

12th October at 11.30 am at Umang Bhawan, Faculty of Law (New Building), University of Delhi. This counseling is strictly for those applicants whose names have not appeared in any of the earlier admission lists released by the University of Delhi.

The counselling is strictly for those applicants who fall within the range of marks as notified above. The candidates are required to appear for counselling in person. Applicants are required to bring all the necessary original documents required for LL.B. admissions notified by University, failing which the admission will not be granted. Note:

1. The admission will be strictly on the basis of merit amongst the candidates reporting for admission and the availability of seats in the Centre in their category.
2. The call does not guarantee admission in LLB course as number of applicants called for counseling is more than the available vacant seats in the course.
3. The shortlisted candidates will be allowed to pay the fee online till 10 pm of 14 th October, 2017. No further time will be given to pay fee.
4. If the seats in ST category still remain unfilled, they will be given to those candidates who have appeared in person and submitted their original documents on 3rd October purely on merit basis as per seat conversion rule of Delhi University.

LIST OF DOCUMENTS REQUIRED FOR THE ADMISSION

The applicants shall be required to produce following documents in original with two sets of self-attested photocopies at the "Reporting Centre":

1. Class X Board Examination Certificate
2. Class X Marks-Sheet
3. Class XII Marks-Sheet
4. Class XII Original Certificate
5. Provisional Certificate and Marks-Sheet of the Qualifying Examination
6. Character Certificate (recent, six months)
7. SC/ST/PwD/CW Certificate (in the name of the candidate) issued by the competent authority
8. OBC (Non-Creamy Layer) Certificate (in the name of the Candidate) issued by competent authority
9. In case the OBC Certificate is older than 1st April 2016, then a proof for the Non Creamy Layer Status.

10. Migration Certificate: Required for those students who have passed qualifying examination from outside Delhi University
11. At least two passport size self-attested photographs.
