## **Admission Procedure and Guidelines**

- BMMMC Course is a Self- Financing program, offered only by IP College.
- Students are required check their names in the category-wise merit list displayed on the College Website/ BMMMC portal.
- Candidates whose name appears in the Admission list are required to write an email expressing their consent to take admission on the Email ID: [admission.bmmmc@ip.du.ac.in](mailto:admission.bmmmc@ip.du.ac.in)
- Candidates will receive a confirmation upon verification of documents with the instruction to pay the fee.
- Thereafter, they may proceed to pay the fees online on the link provided on the BMMMC Department portal.
- Fees are to be paid on the designated dates of admission and payment as per the schedule.
- Candidates who do not fulfill the eligibility criteria for the Entrance Test will be disqualified, even if their names are on the merit list of the results, and their candidature will not be considered by the college for admissions. (Kindly refer to the Entrance Test portal on the Website of University of Delhi for Eligibility to appear for the Entrance Test).
- Candidates qualifying in the reserved categories are required to produce their certificates for verification. The offer of admission will be cancelled incase their certificates are not found in order.
- Candidates who wish to take admission, as per the list displayed, are required to complete the admission process as per the Schedule announced.
- Candidates qualifying in the Reserved categories are required to have in their possession the relevant certificates as per the guidelines issued by the University of Delhi and have to submit them online, failing which this offer of admission will stand cancelled and the next candidate qualifying on the list will be offered admission.
- Applicants who do not have their relevant certificate in order may be allowed to take admission by submitting the self-attested copy of Acknowledgement Slip and Undertaking of ensuring the production of the Certificate within the stipulated period mentioned in the Undertaking. The Undertaking may be downloaded from the BMMMC Department portal and sent by mail to ID [admission.bmmmc@ip.du.ac.in](mailto:admission.bmmmc@ip.du.ac.in)
- Applicants who were eligible for admission in the previously declared admission list will not be given admission in the subsequent lists.

- Kindly note that the College will not adjust BMMMC fees against the fees paid by the candidate to any other Course/ College / University.
- Further admission lists will be released only in case of seats remaining vacant.
