

Terms and Conditions

1. The firm should submit a request letter along with their copy of registration certificate for obtaining tender form.
2. **The rates, amount and total should be in words and figures also.**
3. The overall lowest amount will be considered as L 1.
4. The work should be completed within 60 days from the date of award of contract.
5. It is mandatory to quote the complete tender enquiry number, name of work, tender due date & Time with complete tenderer's address over the above envelopes otherwise the tender will be rejected.
6. The tender in above order shall be put in the Tender Box available in dispatch section, 3rd floor of Multi-storied Building on or before Tender 25.09.2017 at 1.00 PM and will be opened on the same day at 2.30 PM on Committee Room of Administration Block (3rd floor)
7. The site may be inspected in all working days & hours.
8. The successful tenderer has to submit a Performance Guarantee amount equals to 5% of quoted amount in the form of Demand Draft in favour of "Director – V. P. Chest Institute". The performance guarantee will be released after submission of completion certificate of work.
9. VPCI reserve the right to accept or reject any or all tenders without assigning any reason whatever it may be.
10. The incomplete tenders are liable to reject without assigning any reason.
11. If any additional charges related to taxes should be mentioned separately or otherwise the total amount will be treated as all inclusive.
12. Rates and amount quoted against each items and the total should be in words and figures. Non-compliance of this condition will result in automatic rejection of tender.
