Delhi University Sports Council (DUSC), University of Delhi invites ONLINE bids on two bid system (Technical and Financial) for supply of Sports Kit/Sports Goodas per **Annexure I and Annexure II** from reputed & registered agencies/company/firm. Tender forms can be downloaded from the Central Public Procurement (CPP) Portal <http://eprocure.gov.in/eprocure/app> & website of the University of Delhi, <http://www.du.ac.in>.

**Note:** The bidders/venderers are requested to go through the tender document carefully and ensure compliance with all specifications/instructions herein. Non compliance with specifications/instructions in this e-tender document may disqualify the bidders/venderers for the tender exercise. Incomplete tenders/amendments and additions to tender after opening or late tenders are liable to be ignored and summarily rejected.

Amount of EMD: Rs. 10,000/- (Ten thousand only). Scanned copy of Earnest Money (Bid security) is to be uploaded online and Hard Copy of the same must be sent to Office of the The Director (Physical Education), Delhi University Sports Council, University Sports Complex, Delhi-110007 on or before last date and time of submission of e-tender. - (i) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement (CPP) Portal (URL: <https://eprocure.gov.in/eprocure/app>) by clicking on the link “Online bidder Enrolment” on the CPP Portal.
- (ii) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- (iii) Bidders are advised to register their valid e-mail address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- (iv) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate issued by any Certifying Authority recognized by CCA India (e.g. Sify/TCS/nCode/eMudhra etc.), with their profile.
- (v) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- (vi) Bidder then logs in to the site through the secured log-in by entering their user ID /password and the password of the DSC / e-Token.

### **Instructions:**

1. All details regarding the e-tender (bidding documents) are available on the Central Public Procurement Portal for e-procurement <https://eprocure.gov.in/eprocure/app> and website of the University <https://www.du.ac.in>. Bidders may download the e-tender (bidding documents) from the above websites. Bidders shall ensure that their bids, complete in all respect should be uploaded **online before the last date and time of submission of e-tender** as indicated in the important dates. Any change/modification in the Tender document by DUSC, University of Delhi if any, will be intimated through above websites only. **Bidders are therefore requested to visit the websites regularly to keep themselves updated.**
2. Bids (Technical and Financial) shall be submitted through online only at CPP Portal: <https://eprocure.gov.in/eprocure/app>. Tenderers/Bidders are advised to follow the instructions provided for the e-submission of the bids online through the CPP Portal for e-procurement at <https://eprocure.gov.in/eprocure/app>.
3. The bidders shall submit soft copies of their bids (Technical and Financial) electronically on the CPP portal, using valid Digital Signature Certificates and submit offline the “Earnest Money Deposit” in a sealed cover in the Office of the Director (Physical Education), Delhi University Sports Council, University Sports Complex, Delhi-110007 before the last date and time of submission of e-Tender.
4. **Manual bids shall not be accepted.**

5. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
6. Bidder has to select the payment option as “offline” to pay the EMD as applicable and enter details of the instrument.
7. For submission of E-bids, bidders are required to get themselves registered with <https://eprocure.gov.in/eprocure/app> (CPP Portal).
8. Bidder is advised to follow the instructions provided in the Instructions to the Contractors/Bidder for the e-submission of the bids online through the Central Public Procurement Portal for e-procurement at <https://eprocure.gov.in/eprocure/app>.
9. The following scanned and signed documents are to be furnished by the bidder alongwith Technical Bid and Financial Bid as per the tender document. **Incomplete bid is likely to be rejected.**
  - a. Proof for payment of Earnest Money Deposit. (Appendix I)
  - b. Bidder Profile alongwithRegistration Certificate, proof of ownership, copy of GST registration, Copy of PAN card, Copy of TIN/VAT, copies of ITR for last three (03) preceding years, attested copies of balance sheet duly certified by CA alongwith an undertaking that the quoted items are fulfilling the specifications in the tender document and NEFT/RTGS details for the purpose of payment to the bidder.
  - c. An undertaking that the agency hasn't been blacklisted by a Central/State/UT Government etc. and there has been no litigation with any Government department on account of its services.

**TERMS & CONDITIONS**

1. Delhi University Sports Council (DUSC), University of Delhi invites online bids as per two bid systems (Technical and Financial) from eligible bidders through CPP Portal <https://eprocure.gov.in/eprocure/app> for supply of good quality Sports Kit/Sports Good. (Annexure I and Annexure II)
2. Each bidder shall submit only one bid. A bidder who submits or participates in more than one bid will be disqualified.
3. Bidder may download the tender document from the CPP Portal <https://eprocure.gov.in/eprocure/app> or from the website of the University, <https://www.du.ac.in>. He shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited.
4. Corrigendum, if any, will be published on CPP Portal and DU Website.
5. **Manual bid will not be accepted.**
6. There should not be any overwriting or corrections in the quotation. If a figure is to be amended, it should be neatly scored out, the revised figure should be written above and the same should be attested with full signature by the same signatory with stamp, who signed the quotations. In the absence of the attested corrections the quotations is liable to be rejected.
7. In the event of furnishing false/incorrect/incomplete/forged information/documents by the bidder, the EMD in respect of such bidder shall be forfeited. Further during the performance of the contract, if it is detected that the contract has been obtained by furnishing the false/incorrect/incomplete information in the tender, the agreement is liable to be terminated and performance security and other payments due to the contractor shall be forfeited without prejudice to the contractor liable to be blacklisted accordingly and is liable to be banned from doing business with the University of Delhi.
8. EMD of unsuccessful bidder will be returned and no interest will be paid by the University of Delhi. The successful bidder will deposit Security Money/deposit (Performance Bank Guarantee) i.e. 10% of the total contract value to the Office of the Director (Physical Education), Delhi University Sports Council, University Sports Complex, Delhi-110007 within a week, preferably in the form of **performance Bank Guarantee** in favour of "The Registrar, University of Delhi" payable at Delhi before the last date of submission of e-tender at the rate of 10 % of the total value of approved Sports Kit/Sports Good items likely to be supplied. University of Delhi will not pay any interest for such deposit.
9. Rates of successful bidder will remain valid for **twenty four (24) months** from the date of execution of the contract/agreement and no increase of rates, on any account will be considered.
10. Rates must be quoted for complete set/pair in case of Sports Kit/Sports Good, Track Suit etc. Samples also should be submitted accordingly, i.e. set/pair wise.

11. Approved sample of successful bidder shall be retained by the DUSC, University of Delhi. In case of any dispute regarding quality of goods supplied arises, the same shall be compared with the sample so retained by DUSC, University of Delhi. In case of any deficiency in the supplies are found, the same shall be made good by the bidder as per sample approved by the DUSC, University of Delhi. **It shall be the responsibility of the bidder to collect the samples from DUSC, University of Delhi after the expiry of the validity of the tender.**
12. DUSC, University of Delhi shall have the right to give its own colour/patterns/design etc, if required for the Sports Kit/Sports Good, Track Suit.
13. The bidder should be in the trade for the last three preceding years. (Documentary evidence should be submitted)
14. EMD of Rs.10,000/- (Ten thousand only) is required to be made as per **Appendix I** along with the Technical Bid in the form of DD/Bankers Cheque/FDR favouring “The Registrar, University of Delhi”, payable at Delhi. **Tenders submitted without EMD will not be considered and will be summarily rejected.**

The firms registered with DGS&D / National Small Industries Corporation (NSIC) for all these items only, are exempted from EMD. However, they have to enclose valid self attested registration certificate(s) along with the tender to this effect.

15. Successful bidder is to submit an affidavit as per **Appendix V** certifying that the quality of Sports Kit/Sports Good quoted are correct and is liable to pay penalty/damages, in case of any defect. DUSC, University of Delhi may impose penalty as deemed fit and have the right to make recovery from security deposit or bills due.
16. **The Technical Bid and the Financial Bid should be submitted through ONLINE only at CPP Portal as details mentioned in the E-Procurement Tender Notice. The Financial Bid of those bidders would be opened only whose sample/s are technically cleared by the Purchase Committee of DUSC, University of Delhi on the basis of the specifications and samples supplied for each variety of the quoted item/goods. The bidder should provide sample(s) indicating the Brand / Make, Name of the manufacturer etc duly stamped by the bidder.**
17. The Technical Bids will be opened in the first instance, at the prescribed date and time as indicated in Important Dates. These Bids shall be scrutinized and evaluated by the Purchase Committee of DUSC, University of Delhi with reference to parameters prescribed in the Bidding Document.
18. During the Technical Bid opening, the Bid opening official(s) will read the salient features of the Bids like brief description of the services offered, Completion period, Bid Security and any other special features of the Bids, as deemed fit by the Bid opening official(s). Thereafter, in the second stage, the sample selection process of the technically eligible firms will take after selection of sample by the Purchase Committee of DUSC, University of Delhi. Then, the third stage the Price Bids (financial bid) of only the Technically eligible firm & sample selection acceptable offers (as decided in the first stage & second stage) shall be opened for further scrutiny and evaluation after the evaluation of the Technical Bid & sample selection.

19. Only those bids which qualify all the initial eligibility criteria as mentioned in the e-tender document will be evaluated technically.
20. After, the technical evaluation of the bids, the University will open the 'Financial Bid' of all the bidders who have technically qualified as per the terms and conditions of the e-tender document at notified time, date and place in the presence of the qualified bidders or their representatives, if any. The lowest financial bid in respective category shall only be considered for award.
21. Lowest bidder will be decided from the bid for the entire quantity.
22. Cost of the Sports Kit/Sports Good shall include GST/all other taxes and statutory levies with a brand / motto name of the manufacturer etc and proper break up for the same.
23. Payment will be made to the bidder/vender after completion of the delivery of Sports Kit/Sports Good at the scheduled destination i.e. DUSC, University of Delhi and in good condition and according to approved quality / specifications / samples. Any condition relating to advance payment of the ordered material will not be entertained. All the payment will be subject to deduction of GST/all other taxes and statutory levies as imposed by Central / State Govt. from time to time.
24. If the tender is accepted, the payment of the Bill as per the approved rates of the articles will be made through NEFT/RTGS only. The TDS will be deducted as per Income Tax Act & Rules, as applicable.
25. The DUSC, University of Delhi is not bound to purchase all the items from the bidder for which rates have been quoted. The rates will be accepted on the basis of competitive Bidding and quality of materials. **The purchase will be strictly done based on the availability of fund hence the DUSC, University of Delhi has the right to reduce or increase the quantity while placing order for Sports Kit/Sports Good.**
26. The DUSC, University of Delhi does not bind it to accept the lowest quotation for its execution and reserves the right to accept the quotation in whole or in part i.e. with respect to all the articles mentioned in the attached statement or in respect of any one or more than one article specified in the attached statement.
27. The DUSC, University of Delhi, may, at its discretion, relax any minor non-conformity or any minor infirmity in an offer.
28. In the event of any default, failure (including the failure to supply within the prescribed delivery period) or negligence by the bidder/vender in complying with the order to the complete satisfaction of the DUSC, University of Delhi the authorities shall be entitled to deduct/forfeit from the security deposit for the loss / damage.
29. After completion of the tender process, the DUSC, University of Delhi will place order for quantities as and when required from time to time. The successful bidder shall comply with the order for delivery within the stipulated period. **The quantities may be increased or decreased as per the requirement at the time of placing order.**
30. The right to accept the tender will rest with DUSC, University of Delhi which reserves the right to reject any or all the bids without assigning any reason thereof.

31. If any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with the construction, meaning, operation, effect, interpretation or breach of the contract which parties are unable to settle mutually, the same may first be referred to conciliation through a committee as agreed to by both parties.
32. If the parties are not able to resolve the dispute through the committee or do not opt for conciliation through the committee, the aggrieved party may invoke the arbitration clause as provided in the contract.
33. In the event of any question, dispute or difference whatsoever arising between the parties out of or in relation to the construction, interpretation, application, meaning, scope, operation, performance or effect of this tender contract or the validity or breach thereof, the matter shall be referred to the sole arbitrator agreed to by the parties. The award of the arbitrator shall be final and binding on the parties.
34. The arbitrator may, from time to time, with the consent of parties, change the time for making and publishing the award. The Arbitration and Conciliation Act, 1966 and the rules made thereunder, as amended from time to time shall be deemed to be applicable to the arbitration proceeding under this clause.
35. The proceedings of the arbitration shall be carried out in Delhi which shall be subject to the jurisdiction of courts in Delhi.
36. Conditional tenders shall not be accepted. Any tender containing addition / alternation in the above terms and conditions and the specifications of items / materials will also not be considered except where Purchase Committee of the DUSC, University of Delhi recommends so in the interest of University of Delhi.
37. The rate accepted shall be operative till the close of the financial year for which tenders are invited or such date as may be decided by the DUSC, University of Delhi and no revision of rates will be allowed in between. The party, whose rates are approved, will be bound to supply material on approved rates, to other branches / offices / Colleges of the University.
38. Maximum 15 days will be allowed for the delivery of material from the date of order. Therefore period of delivery of material beyond 15 days is not acceptable. The Bidder should make immediate free replacement in case any discrepancy is found in regard to quality of the material to be supplied by them under this contract.
39. Delay in supplies will attract liquidated damages. Liquidated damages will be levied @ 0.5% of the Purchase Order Value per week or part of a week subject to maximum of 100%. The Chairman (DUSC), University of Delhi may impose penalty, condone delay or extend delivery period (on reasonable grounds given by party). An appeal against imposition of penalty however can be made to the Pro Vice-Chancellor of the University, whose decision shall be final and binding.
40. The bidder must submit an undertaking/declaration as per **Appendix III** on its letter head that they have not been black listed by any Government Department/Autonomous or Semi Government Department in the past.
41. The firm must be reputed and must be registered with Sales Tax/Income Tax Authority.



42. Any dispute or disagreement will be interpreted and addressed under Indian Laws in the Hon'ble Courts of Delhi Jurisdiction only.
