Also mention the Model and make of the machine.

The Financial Quotations should contain price of the equipment, discount if any, packaging and forwarding charges, Air Freight and insurance charges. The price quoted should be F.O.R destination price in INR against customs duty exemption certificates provided by the buyer and inclusive of standard installation.
- 4. Manual bids shall not be accepted. Do not submit manual bids by hand.
- 5.
