SECTION I: INVITATION FOR BIDS (IFB)

(A) Scope of Work : Catering Services for Prof. Panchanan Maheshwari Memorial Function as per Annexure A

(B) Eligibility Criteria :

The pre-qualifications of the bidders are as under:

- (i) The bidders should be from Delhi.
- (ii) The bidders should be registered under GST and copy of the same should be enclosed.
- (iii) The bidders should be an Income Tax Assessee for the last three years. Income Tax Certificate with copy of PAN should be enclosed.
- (iv) The bidders should have provided catering services to at least three reputed institutions in the last one year. The details of at least three such services provided by the bidders must be enclosed.
- (v) Bidder should enclose letters from these three institutions claiming the food quality to be satisfactory.
- (vi) Tender fee of Rs. 250/- in the form of Demand Draft in favor of "The Registrar, University of Delhi" payable at Delhi.

Before submission of the bid, the bidders must verify the eligibility criteria and ensure fulfillment of all the terms and conditions. In the absence of documents/ certificates under eligibility criteria above, the bid is liable to be rejected.

(C) Bid Submission:

Bid must be uploaded on the e-tender website of NIC <u>http://www.eprocure.gov.in/eprocure/app</u> along with signed and scanned copies of related documents. The bid must be uploaded in two parts as

(D) Opening of Technical & Price Bid

(E) Evaluation of Technical & Price Bid

(i) The Purchase Committee of the Department of Botany, University of Delhi will examine the bids to determine their completeness in all respect as per the requirements and shall evaluate the Technical Bids based on the documents submitted for this tender.

(ii) If the bid is incomplete and/or not accompanied by all required documents it will be rejected during technical evaluation. The bidder may not be approached for clarifications during the technical evaluation.

(iii) The bid will be rejected if it is not in conformity with the terms and conditions as stipulated in this document.

(iv) If any price details are found in the Technical Bid, the bid will be rejected.

(v) Price Bid of only those bidders, whose Bids are found responsive, shall be opened and evaluated.

(vi) Evaluation shall be done based on the total price (inclusive of all the applicable taxes & duties) of all the items quoted.
