**TENDER NOTIFICATION**

**Bids are invited under 2 bid system through e-procurement for Safety Cabinet for storing flammable and corrosive liquids as per specifications described below**

3 safety cabinets for storing flammable and corrosive liquids such as acids and alcohols (low and median flash point liquids, flash point <37.8).

Double Door and 160-180 liters Capacity with 2 adjustable shelf : 01 no.

Double Door and 110-120 liters Capacity with 2 adjustable shelf : 02 nos.

1. FM and CE certifications in strict compliance with FM approval standard for storage cabinets
2. Safety storage cabinets should have 18-gauge steel, all-welded, double fireproof steel panel, insulating air barrier
3. Fireproofing vents should be there at both sides of the cabinet (one on the top and another on the bottom) to effectively reduce the concentration of volatile substances and prevent fire hazards.
4. Reinforced shelves should be adjustable and feature built-in troughs and leakproof wells to contain spills.
5. The manually-closing doors should be fully opened to 180° for easy access
6. Three-point linkage latch should be padlocked to ensure complete closure for better security.

**Eligibility Criteria**

- Bidder should be Manufacturer/ Authorized Partner/ Reseller of the manufacturer and a Letter of Authorization from manufacturer for the same and specific to the tender should also be enclosed. The bidder should also be the Authorized Service Provider.
- Bidder should be financially sound to execute the order. Certificate to this effect should be issued by any nationalized/ scheduled bank showing its annual turnover of at least 25Lakhs each in the last three financial years.
- The Bidder shall provide the Registration number of the firm along with the LST/CST/ WCT No. and the PAN Number issued by the concerned authorities.
- The bidder should enclose similar orders provided to various reputed Government Institutes/Research labs/ICAR/CSIR institutes throughout India in the last 5 years.
- Separate technical and price bid should be uploaded.
- Technical Bid must contain a Technical Compliance sheet. Technical compliance sheet must have the page number of a published catalogue/operating manual/ manufacture website as proof for compliance with the instrument and accessories for each technical points. Relevant copies of catalogue/operating manual/ manufacture website pages that have been listed as proof should be attached.
