**CALL FOR QUOTATIONS**

The Department of Botany invites sealed tender offers eligible manufacturers/authorized distributors/dealers for the supply of a **Single Beam Scanning UV-VIS Spectrophotometer** in the Department of Botany, University of Delhi, Delhi. The vendors intending to bid may download the specifications and the other details from the University website and submit their bid to **Dr. J. Dinakaran, Principal Investigator, DST-FAST Fast Track Research Project, C/o. Prof. K.S. Rao, Department of Botany, University of Delhi, Delhi-110007** within 21 days of this call.

**Single Beam Scanning UV-VIS Spectrophotometer**

Microcontroller Based, Range 190-1100 nm with basic PC Software and 4 position cell changer. Must have a graphic LCD for display of kinetic, concentration graphs. PC connectivity through USB port & direct printer connectivity using the parallel port interface. Extensive elaborate keyboard for ease of operation. Sample compartment could accommodate up to 100 mm cuvettes (optional). Basic modes like %T, Abs, Concentration, Kinetics must be included. It must have the wavelength scanning and DNA/Proteins can be done using the advanced professional PC Software

**Instructions to the suppliers**

Two kinds of quotations may be submitted, one **technical quotation** consisting of all technical details along with commercial terms and conditions, and one **financial quotation** containing item wise price for the items mentioned in the technical quotation. Both the quotations should be sealed by the supplier in separate covers duly super scribed and both these sealed covers are to be put in a bigger cover which should also be sealed and super scribed. The company should attach a user's list and performance certificate. The supplier shall bear all costs associated with the preparation and submission of its quotation including samples, literatures, etc.

**Conditions of the Contract**

**The bidders will have to quote all the items together, partial quotes will not be considered.**

Quantity, make, model and technical specifications should be mentioned clearly. It may be stated if the rates are inclusive of taxes applicable and charges for on-site installation. Validity period of the quotation should be 180 days from the due date. Any alteration/overwriting should be initialed. Kindly enclose a written authorization or certificate from the manufacturer. The supplier may mention the period of warranty in the quotation including the cost of comprehensive warranty for a period of two more years as an option. The period of warranty will start only after successful installation and satisfactory operation.

The bidders have to provide the following information with their technical quote

- Manufacturer authorization form.
- Details of support and service centre's.
- Warranty compliance statement.
- Complete user list with name, address and telephone number for the past three years.
