- The work should be completed within 15 days from the date of award of contract.
- The quotations in a sealed cover shall be put in the Tender Box available in dispatch section, 3rd floor of Multi-storied Building on or before **06.07.2015 at 1.00 PM** and will be opened on same day at **2.30 PM** at Committee Room at Administration Block (3rd floor).
- The site may be inspected in all working days & hours.
- Other than the working contractor of VPCI, the tenderer has to submit a copy of their registration certificates, their work experience profile and the documents related to the eligibility criteria as mentioned above along with the Tender. Otherwise, the tender of the form should be rejected.
- VPCI reserve the right to accept or reject any or all tenders without assigning any reason whatever it may be.
