'PT. UDHO RAM RAM PAL CHARITABLE TRUST SCHOLARSHIP'

1. There shall be one scholarship known as 'Pt. Udho Ram Ram Pal Charitable Trust Scholarship' of the value of Rs.100/-p.m. to be awarded after every third year out of the annual income accruing from the Endowment Fund of Rs.24,000/- donated by Shri S.N. Ram Pal, Managing Trustee, Pt. Udho Ram Ram Pal Charitable Trust, No. Sainik Farm, Khanpur, New Delhi-62.
2. The Scholarship shall be tenable for a period of three years renewable yearly on the basis of satisfactory performance of the awardee.
3. The scholarships shall be awarded to meritorious and needy students who have passed the Senior Secondary School Examination of the Central Board of Secondary Education or an Examination recognized equivalent thereto with Ist division and join the B.A.(H) 1st year course in Psychology/English/Sanskrit/Philosophy/Hindi or B.Sc.(H) in Anthropology. The awarded will be made to students whose parents income including his/her own income does not exceed to the amount from where it starts attracting income tax.
4. No student shall be eligible for the award of scholarship if he/she already holds a scholarship awarded by the Delhi University or any other University of the Central Government or any State Government or Private Body other than freeship.
5. In case any scholar accepts any other scholarship financial assistance from any other source, he/she shall be required to refund the amount received by her/him on this account from the date he/she accepts the other scholarships/financial assistance.
6. If it should appear at any time during the tenure of the award that the scholar has failed to make satisfactory progress or has been found guilty of gross misconduct or has been irregular in attendance he/she after due warning in writing be reported by the Principal/Head of the Institution/Department to the Academic Council which may reduce, suspend or withdraw the Scholarship.
7. The scholarship shall be awarded by the Academic Council on the recommendations of a Selection Committee constituted as follows:-
 1. Dean, Faculty of Arts (Chairman)
 2. Dean, Faculty of Science
 3. One of the Head of the Department of English/Hindi/Philosophy Psychology/Anthropology to be nominated by the Vice-Chancellor every three years.
8. Application for the scholarship in the prescribed form obtainable from the office of the Registrar(Scholarship Cell) should reach the Registrar, University of Delhi, Delhi-7 through the Principal/Head of the Institution, concerned by the date mentioned in the notification issued by the Registrar in this behalf.
9. The payment of the scholarship amount shall be made to the scholars through the Principal of their College/Head of the Department from May each year on presentation of a bill and a certificate to the effect that during the period covered in the bill, the scholar was not in receipt of any other scholarship/financial assistance from any other sources.
10. The unutilized amount in any year shall be added to the corpus of the endowment fund.
