"SHRI BALAK RAM SCHOLARSHIP"

- 1. There shall be a scholarship called "Shri Balak Ram Scholarship" of the value of ₹75/- p.m. payable out of the interest on the funds amounting to ₹11,400/- endowed by Sh. L.C. Suri, C/o Sh. R.B. Suri, A-6, Naval Officers Flats, Colaba, Bombay on behalf of Smt. Nischinta Balak Ram.
- 2. The Scholarship shall be awarded to a meritorious student whose parents income including their own income does not exceed to the amount from where it starts attracting income tax and who joins the <u>first year of the B.A. (Hons)</u> B.Sc. (Hons.) Course in Mathematics in this University.
- 3. The Scholarship shall be tenable for a period of three years, renewable yearly on the basis of satisfactory performance of the awardee.
- 4. a. No student shall be eligible for the award of this scholarship if he or she already possesses a scholarship awarded by the University of Delhi or any other University or the Central Government, or any State of India or a private body, other than Freeship
 - b. In case a scholar under endowment is awarded any other scholarship or gets financial aids from any other source, he shall be required to refund the amount received by him/her on this account from the date hashe was awarded any other scholarship or gets financial aid.
- 5. If it should appear at any time during the tenure of the award that the scholar has failed to make satisfactory progress or has been found guilty of gross misconduct or has been irregular in attendance, he/she shall, after due warning, in writing, be reported by the Principal/Head of the Institution of his/her College to the Academic Council which may reduce, suspend or withdraw the Scholarship.
- 6. The scholarship shall be awarded by the Academic Council on the recommendation of the Selection Committee constituted as clows:
 - i) The Dean, Faculty of Mathematics (Chairman)
 - ii) The Head of the Department of Mathematics
 - iii) One or more Senior member (S) from the Department of Mathematics (to be nominated by the Vice-Chancellor on the recommendation of the Head of the Department of Mathematics).
- 7. Applications for the scholarship, in the prescribed form obtainable from the office of the Registrar (Scholarship Cell) should reach the Registrar, University of Delhi, Delhi 07., through the Principal of the concerned college by the date mentioned in the Notification issued by the Registrar in this behalf.
- 8. The payment of the scholarship amount shall be made to the scholar through the Principal of his/her college on presentation of bill and a certificate to the effect that during the period covered in the bill, the awardee was not receipt of in any other scholarship/financial assistance from any other source.
- 9. Any amount accruing from interest from the endowment not spent in any year shall be added to the corpus of the endowment fund.
