Eligibility criteria for Ph.D.

- 1. For admission to Ph.D. minimum 55% marks in Masters Degree (or its equivalent grade 'B' in the UGC7-point scale) in the same or allied subject from a recognized University with 5% relaxation for OBC (non-creamy layer)/SC/ST and Persons with Disability. The allied subject for admission to Ph.D in a particular Department shall be decided by the DRC of that respective Department.
- 2. No Candidate shall be eligible to register for the Ph.D. programme if he/she is already registered for any full-time programme of study in any University/Institute.
- 3. The candidates belonging to various categories of the University of Delhi Ordinance VI (Amended 9th August 2017).
- 4. Any other conditions laid down by the University from time to time.

Admission criteria

- 1. To qualify a candidate must secure 50% marks in the Entrance Test.
- 2. Merely qualifying the Entrance Test does not guarantee the award of fellowship and admission to Ph.D Course.
- 3. The Candidate shall select one of the Sub-disciplines offered by the Department at the time of advertisement and online application.
- 4.
