RULES FOR ALLOCATION OF LAW CENTRES IN FACULTY OF LAW, UNIVERSITY OF DELHI FOR LL.B. COURSE.

1. MERIT CUM PREFERENCE.

The seats will be allocated in the Centres, category wise only on the basis of merit-cumpreference according to list prepared by the DUCC, University of Delhi.

- 1.1. The candidate will be allocated a seat in a Centre according to first, second, third preference subject to the availability of seats for each category in a particular Centre.
- 1.2. If more than one applicant obtains same marks and there is only one seat available in the Centre, the seat will be allocated to the one who has got more marks in the qualifying degree for entrance exam. If the applicant has more than one degree which qualifies the applicant to appear in the entrance, the degree in which he/she has obtained more marks will be considered as qualifying degree.
- 1.3. The declaration of allotment of the Centres will be made after the issuance of each list, subject to the availability of seats category-wise in each Centre.

2. <u>RESERVED CATEGORIES</u>

- 2.1 In case a reserved category candidate (SC, ST, OBC, EWS, PWD, CW) obtains marks making him/her eligible for a seat in the unreserved list, she/he will be treated as an unreserved candidate for the purpose of centre allocation, and the Centre will be allotted to him on the basis of merit-cum-preference in the unreserved list.
- 2.2 After taking the admission against the unreserved seat in the Centre, he/she will not be treated as unreserved candidate for the remaining purposes.
- 2.3 The reserved category candidate whose name appears in unreserved category as indicated above, may exercise an option to seek admission in the reserved category (as indicated in his/her application form) in order to take advantage of the Centre-preference at the time of taking admission. This option will be exercised within the time period specified by the Admission Committee and will be subject to the availability of a seat in the particular category in the Centre. The vacant seat on account of exercise of such option will go to the unreserved category and not to reserved category. An option for such change, once exercised shall not be a subject of revision.

3. FINALITY OF ALLOCATION.

Centre once allocated shall be final and not subject to any change under any circumstances.

4. FORFEITURE OF SEAT.

If any candidate, whose name is declared in the merit list to be eligible for admission, fails to complete the admission formalities within the specified period, then such candidate shall forfeit his claim to the seat.
