MINUTES

A meeting of the Inspection Committee constituted by the Hon'ble Vice-Chancellor, University of Delhi in terms of Statute 30(1)(c)(iii) of the Statutes of the University was held on **Tuesday, 15th March, 2022 at 11:30 am** in the office of the Principal, University College of Medical Sciences to conduct re-inspection of Department of Dentistry for starting of **MDS (Orthodontics & Dentofacial Orthopaedics)** Course at UCMS.


2. The Inspection Committee had conducted the previous inspection on 20.10.2021 of the College to ascertain availability of Infrastructures, equipment, teaching faculty etc. for starting MDS (Orthodontics & Dentofacial Orthopaedics) at UCMS.

3. The Inspection Committee had recommended that the Unit of Orthodontics & Dentofacial Orthopaedics, Department of Dentistry, UCMS may start MDS (Orthodontics & Dentofacial Orthopaedics) Course with intake of two seats per year subsequent to the fulfilment of the following suggestions (F/A).


- (i) Senior Lecturer/ Senior Resident (One) may be appointed in the specialty of Orthodontics & Dentofacial Orthopaedics to fulfil the unit requirements.
- (ii) Other requirements to be fulfilled as per checklist of Dental Council of India performa.
- (iii) The Institution will obtain necessary permission of the concerned Regulatory Bodies, wherever required as per rules of the Dental Council of India / Ministry of Health & Family Welfare.
- (iv) The permission of Regulatory Bodies (Atomic Energy Regulatory Board) shall be obtained, if necessary.

4. It was noted that the Department now fulfills the required conditions as suggested by the Inspection Committee for starting of MDS (Orthodontics & Dentofacial Orthopaedics) Course at UCMS (**Annexure - I**)

5. **RECOMMENDATIONS:** Keeping in view the availability of sufficient infrastructure viz. required equipments, Faculty members, Library /journal, technical staff, OPD, laboratories etc in the Unit of the Orthodontics & Dentofacial Orthopaedics, Department of Dentistry, the Insection Committee recommended that **MDS (Orthodontics & Dentofacial Orthopaedics)** Course with intake (02) seats per year may be stated from the academic year 2022-23 at UCMS.
