
The Committee constituted by the Competent Authority met on 5<sup>th</sup> October 2020 to study the matter with regard to Office Memorandum issued vide No. IAUS-III/314-2/2016/923 dated 31 Oct, 2016 issued by the University and applicability of GFR-2017 and to recommend the way forward in the interest of transparency, accountability which will ultimately strengthen all the activities including the Research activities of the University.

The committee noted the above mentioned University O.M. dated 31.10.2016, which provides that all the procurements worth an estimated value of Rs.15, 000/- and above shall be processed through e-procurement mode to improve transparency and to promote competition.


The Committee also noted that the Executive Council in its meeting held 12.3.2018 approved the relevant provisions of the GFR-2017 issued by the Govt. of India, Ministry of Finance (Department of Expenditure) vide O.M. No. F.No.14 (3)/2015-E-II (a) dated 8.3.2017.

Taking in consideration of the above and in order to remove the ambiguity among the stakeholders of the University, the committee recommends that the GFR-2017 shall be implemented in totality in all respects and will prevail over the O.M. dated 31.10.2016 issued by the University.

OFFICE MEMORANDUM

**Sub: Implementation of e-procurement in the University of Delhi for the Financial Year 2016- 17.**

This has reference to O.M. No.26/12/2014-PPC dated 21<sup>st</sup> January, 2015 issued by Procurement Policy Division, Department of Expenditure, Ministry of Finance and O.M. No.FO/IAUS-III/314-2/2016/497 dated 31<sup>st</sup> March, 2016 issued by the University of Delhi to introduce e-procurement in respect of all procurements with an estimated value of Rs.2.0 lakh or more in a phased manner. The UGC vide D.O. No.F.75-1/2013 (E-Governance) dated 22<sup>nd</sup> April, 2015 had also stressed to introduce e-Governance in order to transform the quality of services provided in the field of Higher Education through a service oriented approach and deployment of ICT applications and systems.

2. In this context, it has been decided by the Competent Authority that in order to further improve transparency, promote competition and introduce better accountability henceforth, all the procurements worth an estimated value of Rs 15,000/- and above SHALL also be processed through e-procurement mode. All the Heads of Departments are, therefore, requested to take necessary action to ensure that all procurements above Rs 15,000/- are essentially processed through Central Public Procurement (CPP) Portal.
