NOTIFICATION

Whereas, the Hon'ble High Court of Delhi in the matters (i) WPC 54/2023 (Preeti & Ors. Vs. University of Delhi & Ors.), (ii) WPC 1384/2023 (Ranjan Kumar & Ors Vs. University of Delhi & Ors.) and (iii) WPC 711/2023 (Tanshi Bharti Vs. University of Delhi & Ors.) has referred to the Report of the Results Grievance Committee, Faculty of Law dated 22.11.2022 and the recommendations made therein.

2. Whereas the Petitioner's Counsel in all the WPC's has also agreed to the said recommendations and has prayed for implementation of the same.


3. Whereas the Hon'ble High Court of Delhi while Disposing the writ petitions on 11.02.2025 has ordered to implement the recommendations of the Results Grievance Committee.

4. Therefore, following is notified for proper implementation, for future course of action;

- I. *The order issued by Hon'ble Court in above stated WP(C) be perused by all the faculty members.*
- II. *A proper Orientation program should be conducted for all faculty members/examiners in order to avoid the recurrence of students in future.*
- III. *A joint evaluation meeting must always be conducted by the Conveners of all subjects in their respective subjects from time to time, especially before paper setting and before starting the evaluation exercise in order to ensure uniformity in evaluation.*
- IV. *The advance notices may be issued for such meetings making the attendance of faculty members mandatory.*
- V. *It is strongly recommended for all faculty members/examiners, including Guest Faculty to attend the subject meetings.*
- VI. *Subject Conveners should be requested to supervise evaluation work in their respective subjects, in order to ensure uniformity in evaluation.*
- VII. *Students should be encouraged to mention correct question numbers in their scripts, while attempting each question in the examination.*

5. All concerned are hereby requested that the directives stipulated in the Order of Hon'ble High Court of Delhi be complied in true spirit. The copy of the order/directions dated 11.02.2025 is enclosed herewith.
