The Executive Council was appraised of the action taken by the University in the matter of proposed construction of a high rise group housing society by a private builder on the land originally owned by the Ministry of Defence on the North Campus of the University.

The Council noted the developments and seriousness of the matter and re-affirmed and reiterated Academic Council Resolution No. 56 dated 20.03.2012, Academic Council Resolution No. 173 dated 21.03.2012, Academic Council Resolution No. 40 dated 16.08.2013, Executive Council Resolution No. 31 dated 28.02.2017/07.03.2017 and Executive Council Resolution No. 9 dated 01-02.07.2019. The Council therefore appealed to the Visitor (Hon'ble President of India), the Chancellor (Hon'ble Vice-President of India), Pro-Chancellor (Hon'ble Chief Justice of India), Chief Rector (Hon'ble Lieutenant Governor of NCT of Delhi) and others to intervene in the matter on an urgent basis to save the interests and rights of the University and its students, faculty, staff and other stakeholders as stipulated in letter No. F.59-6/41 E., dated the 25<sup>th</sup> October 1943, from the Joint Secretary to the Government of India, Department of Education, Health and Lands, (**Appendix-VI**) and other applicable laws and provisions.

The Council also asked the Administration to take all necessary steps in this matter to safeguard the interests and rights of the University.

After considering the case, the Executive Council decided to constitute Two Member Committee consisting of Justice (Retd.) S.L. Bhayana and Ms. Aakanksha Kaul, Advocate with the following terms:-

- (1) to look into the Report of the ICC and Appeals of the Complainant and the Respondents against the report of the ICC.
- (2) call the affected parties and hear them on the mertis of the report of the ICC as well as quantum of punishment suggested by the ICC.
- (3) keeping in view the relevant law applicable in this case, decide the appeals on merits and also decide whether the findings of the ICC stand the scrutiny of law and facts.
- if the Committee upholds the findings of the ICC, suggest what punishment should be meted out to the Respondents.
- if the Committee finds that the report of the ICC suffers from jurisdictional error or from procedural error or that ICC had no jurisdiction to improve upon its own findings, then suggest whether the report of the ICC is to be rejected on these grounds and, if so, suggest further course of action required to be taken in the case.

The Committee be requested to submit its report withing 3 weeks from the date of its first meeting.

<u>59/-</u> The Executive Council recalled its resolution No. 39 dated 20/21.07.2019 and resolved that the Trusts of Trust Maintained Colleges be asked to contribute their 5% mandatory share as indicated by the University Grants Commission in its yearly budget sanction letters to the respective colleges.

The Executive Council noted that on the basis of UGC letters (Appendix-XV) the University has requested Chairperson, Governing Body, Daulat Ram College vide letter no. CB-II/5% Trust/72 dated 14.10.2019 (Appendix-XVI) to deposit the balance amount of Rs 5,38,30,115/- (Rupees Five Crore Thirty Eight lakh Thirty Thousand One Hundred Fifteen) of the Trust Share without further delay.

The Executive Council reiterated that in case a Trust fails to contribute its share, the process of getting 100% grant-in-aid from the UGC and converting that Trust Maintained College into a University maintained institution be initiated.
