**Subject: Institution of Gold Medal in the Memory of Late Prof. Ashwani Kumar Bansal – Reg.**

The Dean, Faculty of Law, vide email dated 11.09.2023 requested for instituting three Gold Medals in the memory of Late Dr. Ashwani Kumar Bansal which is placed at (F/A).

2. In the said email, Mr. Anil Kumar Bansal (Brother), Ms. Sanju Aggarwal, and Dr. Anupam Gupta (Sisters) of Late Prof. Ashwani Kumar Bansal expressed their desire to award three Gold Medals to meritorious law students, as under:

- i. One final year student of LL.B.
- ii. One final year student of LL.M. (2-Year Programme)
- iii. One final year student of LL.M. (3-Year Programme)

3. In this connection, a Standing Committee (Scholarship/Medals/Prizes) was constituted by the Hon'ble Vice-Chancellor, which in its meeting held on 12.02.2024. The Standing Committee examined the request of Ms. Sanju Aggarwal, elder sister of Late Prof. Ashwani Kumar Bansal, for instituting three Gold Medals in the field of LL.B. and LL.M. based on merit, in memory of Late Prof. Ashwani Kumar Bansal.

4. The Committee further considered the matter and decided to issue a letter to the donor for depositing an amount of Rs. 10.00 lakh for instituting a Gold Medal in the field of Intellectual Property Rights (Paper-I and Paper-II combined). The donor was also given the option to deposit an additional Rs. 10.00 lakh if they wished to institute a Gold Medal for LL.M. students as well.

The Hon'ble Vice-Chancellor approved the proposal of the Standing Committee on 20.02.2024 (F/B).

5. Accordingly, a request letter was sent to Dr. Anupam Bansal on behalf of Ms. Sanju Aggarwal vide email dated 29.04.2025 for depositing the amount for instituting a Gold Medal in the memory of Late Prof. Ashwani Kumar Bansal in the field of Intellectual Property Rights (Paper-I and Paper-II combined) (F/C).

6. The donor has deposited an amount of Rs. 10.00 lakh for instituting one Gold Medal in the memory of Late Prof. Ashwani Kumar Bansal in the field of Intellectual Property Rights (Paper-I and Paper-II combined) vide Cheque No. 542652 dated 06.05.2025 in the account of the Registrar. The Section Officer (Finance-X) has confirmed receipt of the payment on 01.07.2025 (F/D).

7. In view of the above, the note may be sent to the Scholarship Section for placing the agenda before the Academic Council and the Executive Council for amendment in Ordinance XXVIII regarding the institution of the above-mentioned Gold Medal.
