

Further, the Committee deliberated in detail on the case of Mr. Ashish Singh (Sl. No. 24) and observed that his year of admission is 2018. He has exceeded the maximum permissible span period. However, his results for the examinations held in November–December 2024 were withheld, pending the decision of this Committee.

Since the November–December 2024 examinations fall within the prescribed span period, the Committee recommends that his results for this examination be declared accordingly.

04/ The Committee considered the request of Ms. Chelshi Sharma, ex, student of B.A. (Hons.) Psychology (Roll No.20029528058) at Indraprastha College for Women admitted in the year 2020-2021 for re-admission in Final Year of B.A. (Hons) Psychology Course.

The Committee after due consideration resolved that the span period of Ms. Chelshi be extended to the examinations to be held upto May June 2026-2027 as per A.C. Res. No. 11 dated 19.07.2016 and subsequent E.C. Res. No. 11 (11-4) dated 28.02.2017/07.03.2017 and EC Resolution No. 24(24-23) dated 12.07.2025 i.e. N+2+2+1. She may be allowed to appear in the examinations accordingly.
