44/- Disciplinary Matter

44-1/ The Executive Council approved the action taken by the Vice-Chancellor on 12.12.2024 and 08.07.2025 in approving prosecution sanction in respect of Prof. K.N. Tripathi, Department of Electronics Science, University of Delhi (Retired on 28.02.2011).

“The MoE vide letter No. C-34013/4/2024-Vig. dated 07.11.2024 forwarded the request of CBI vide letter No.4989/RC2182018A0005/CBI/AC-III/New Delhi dated 04.10.2024 seeking prosecution sanction in respect of Prof. K.N. Tripathi related to illegal approval of courses in Institutions/ Deemed to be Universities including Vinayaka Mission’s Research Foundation, deemed to be University, Salem, Tamilnadu (VMRF) caused wrongful gain of Rs.22,86,30,000/- to VMRF. Prof. K.N. Tripathi was one of the Members of Expert Committee constituted by the then Chairman-DEC (IGNOU) in the matter. The CBI registered the case on 07.03.2018 against VMRF and unknown public servants of Distance Education Council-IGNOU (DEC), UGC, AICTE, MoE in compliance of Order dated 03.11.2017 of Hon’ble Supreme in the matter.

The Hon’ble Supreme Court vide judgement dated 03.11.2017 has found the entire exercise of grant of ex-post-facto approval to be incorrect and illegal vide which the ex-post facto approval was granted to 04 Institutions/ Deemed to be University including VMRF in respect of courses leading to the degree in Engineering through distance education mode. The Court set aside the ex-post facto approvals granted by UGC and their concerned authorities in the present case which were given for the candidates enrolled during the academic session 2001-2005 and stand suspended all the degrees in engineering awarded by concerned deemed to be universities including VMRF. The Hon’ble Supreme Court directed the CBI to carry out thorough investigation into the conduct of the concerned officials who dealt with the matter and went to grant permissions against the policy statement and into the conduct of institutions who abused their position to advance their commercial interest illegally”.

The University vide letter No. Estab. (T)/V/001/1985/Elec.Sci./1798 dated 18.12.2024 has conveyed the sanction for prosecution against Prof. K.N. Tripathi to MoE in the above matter.

44-2/ The Executive Council approved the action taken by the Vice-Chancellor on 03.09.2025 in approving prosecution sanction in respect of Prof. K.N. Tripathi, Department of Electronics Science, University of Delhi (Retired on 28.02.2011).

“The Under Secretary, MoE vide letter No.4-10/2024-CU-II dated 07.08.2025 forwarded the request of CBI vide letter No. 2644/RC2182018A0004/CBI/ AC-III/N.D. dated 06.06.2025 seeking sanction for prosecution in CBI Case No. RC2182018A0004/CBIAC-III/New Delhi against Prof. K.N. Tripathi related to case of illegal approval of courses in Allahabad Agricultural Institute- Deemed University (AAI) caused wrongful gain of Rs.13,81,75,740/- to AAI . Prof. K.N. Tripathi was one of the Members of Expert Committee constituted by the then Chairman-DEC (IGNOU). The CBI registered the case on 07.03.2018 against Allahabad Agricultural Institute-Deemed University (AAI) and unknown public servants of Distance Education Council-IGNOU (DEC), UGC, AICTE, MoE in compliance of Order dated 03.11.2017 of Hon’ble Supreme Court of India in the matter.

The Hon’ble Supreme Court vide judgement dated 03.11.2017 has found the entire exercise of grant of ex-post-facto approval to be incorrect and illegal vide which the ex-post facto approval was granted to 04 Institutions/ Deemed to be University including Allahabad Agricultural Institute- Deemed University in respect of courses leading to the degree in Engineering through distance education mode. The Court set aside the ex-post facto approvals granted by UGC and their concerned authorities in the present case which were given for the candidates enrolled during the academic session 2001-2005 and stand suspended all the degrees in engineering awarded by concerned deemed to be universities including AAI. The Hon’ble Supreme Court directed the CBI to carry out thorough investigation into the conduct of the concerned officials who dealt with the matter and went to grant permissions against the policy statement and into the conduct of institutions who abused their position to advance their commercial interest illegally”.

The University vide letter No. CR-VIG/069/2024/A/04/2023 dated 08.09.2025 has conveyed the sanction for prosecution against Prof. K.N. Tripathi to MoE in the above matter.

44-3/ The Executive Council considered the report of the Internal Complaints Committee (ICC) submitted vide letter No. ICC/DU/2025/200 dated 08.05.2025 on the Complaint dated 07.10.2024 filed by Ms. Apeksha Yadav, Ph.D. Scholar, Department of Social Work (Complainant) against Mr. Subham Thapa, M.A. Student, Department of Social Work (Respondent), University of Delhi.

In its report, the ICC has made the following recommendations:-

“The ICC unanimously agrees that no intention to harass was substantiated on the part of the Respondent. Although, the UGC Regulations assert on the impact and not on the intention to substantiate the guilt. The ICC records the lack of awareness and sensitization in behavior of the Respondent and in order to inculcate a sense of accountability in him for his action, recommends:-

- (i) That the Respondent, through the Head of the Department, must tender an unconditional written apology to the Complainant for his conduct towards the Complainant, and duly signed copies of the same must be submitted in the office of the ICC and in the office of the Head of the Department, Delhi School of Social Work, University of Delhi.

- (ii) That the Respondent must mandatorily attend a Gender Sensitization program of the duration of maximum 2 hours and submit proof of the same to the office of the ICC and the Head, Delhi School of Social Work, University of Delhi.
- (iii) That the post-graduation degree of the Respondent from the Delhi School of Social Work is to be withheld until the apology letter and the proof of successful completion of a Gender Sensitization program is submitted, duly signed by the Respondent, in the above said manner.

The confidentiality of the report should be strictly respected by all parties involved and under no circumstances should any discussion on this regard be carried forward to people/ spaces/ platforms outside the formal channels of communication, the failure of which shall be dealt with utmost seriousness by the ICC, University of Delhi."

The Executive Council noted that the Complainant and the Respondent have not filed any Appeal, as per the provisions of SHWW (PPR) Act – 2013 and UGC Regulation – 2015. The Executive Council after deliberations resolved to accept the report of the ICC and its above recommendations.

The departments of the University offer Ph.D. Programmes in their respective disciplines. As mandatory part of this programme, Ph.D. coursework is being conducted by every department. It has been noticed that there are variations in pattern of the course works which are being taught in various disciplines. Thus, to bring uniformity in the Ph.D. coursework across the disciplines, the following guidelines have been formulated to be made effective from the Academic Year 2025-26.

1	The total credit required for Ph.D. coursework ranges from 12 to 16 credits. The distribution of minimum 12 credits is as follows:	
	a. Research Methodology Or Advanced Research methodology (for students who have already studied Research Methodology)	4 Credit
	b. Research Publication Ethics	2 Credits
	c. Research Tools	2 Credits
	d. Discipline Specific Elective Course (Relevant to the research areas)	4 Credits

The Council considered the guidelines for identifying journals for academic purposes with an aim to uphold standards and ensure alignment with the University’s academic and research objectives.


The Council decided to refer the guidelines to the Academic Council for consideration before being placed in the Executive Council.
