Note: The Finance Committee in its meeting held on 09.12.2025 considered the recommendation of the Building Committee made at its meeting held on 03.12.2025 and recommended for placing before the Executive Council for its consideration and approval.

2.1 Provision of Air Conditioning system in Umang Bhawan building.

Connections of chiller, cooling tower, heat pump, laying of hot and cold-water pipeline completed. Cooling tower are installed. The air conditioning system has been commissioned. Testing of equipment's had completed. A group of students of Law faculty made a complaint to CVC. The CVC has referred the matter to Chief Technical Examination (CTE) to examine the same. The CTE has visited the site and their report is awaited. CPWD has informed that the executing agency is pressuring to release the balance payment and requested to release the balance payment at the earliest to avoid the arbitration proceeding.

After detailed discussion the Building Committee decided that after taking the undertaking from CPWD, the remaining payment shall be released to the agency and also advise the CPWD not to release the performance guaranty (P.G./ Security) until unless matter is finally resolved.

2.2 Construction of Electronics Science & Life Science at South Campus**2.2.1 New Electronics Science Building**

M/s RITES Limited has completed the building works. M/s RITES Limited were also advised to provide the furniture and air-conditioning in the building. M/s RITES Limited has informed that they are not in position to provide the furniture and air-conditioning. The University should take the work at their own. Further the HOD, Department of Electronic Science has visited the building and requested Engineering Branch due to space crunch the said building may be handed over to the department for the research work by using the available old furniture till the new furniture and air-conditioning are provided.

The Building Committee discussed and approved the estimates to invite the e-tender by the Engineering Department.

- (a) Estimate Rs.2,10,39,685/- for furniture work.
- (b) Estimate Rs.40,00,000/- for air-conditioning work.

The expenditure will be met out from the saving of the building project.

2.2.2 Life Science Building:

M/s RITES Limited has informed that structure work has been completed. The finishing work is in progress and likely to be completed by February, 2026. M/s RITES Limited was advised to provide the furniture and air-conditioning in the building. M/s RITES Limited has informed that they are not in a position to provide the furniture and air-conditioning. The University should take the work at their own.

The Building Committee discussed and approved the estimates to invite the e-tender by the Engineering Department.

- (a) Estimate Rs.4,16,43,715 for furniture work.
- (b) Estimate Rs.50,00,000 for air-conditioning work.

The expenditure will be met out from the saving of the building project.

2.3 Construction of Rooms & lecture Hall at Terrace (2nd Floor Level) with LGSF Structure at Faculty of Arts.

The Building Committee discussed and approved the proposal for Construction of Rooms & lecture Hall at Terrace (2nd Floor Level) with Light Gauge steel framing Structure (LGSF) at Faculty of Arts and recommended for inviting e-tender by Engineering Department of University of Delhi.

- (a) Estimate Rs.2,17,63,945 for Civil work.
- (b) Estimate Rs.75,00,000 for Electrical works.
- (c) Estimate Rs.50,00,000 for Air-conditioning work.
- (d) Estimate Rs.65,00,000 for installation of glass lift work.
- (e) Estimate Rs.70,00,000 lakhs for providing and placing furniture for Classroom and faculty Rooms.

2.4 Provision of Broadcasting studio in Adjoining Building at Vice Regal Lodge, University of Delhi

2.4.1 The Building Committee discussed and approved the proposal for Provision of Broadcasting studio in Adjoining Building at Vice Regal Lodge, University of Delhi at an estimated cost of Rs.2,32,08,537.

2.4.2 The Building Committee suggested to include comprehensive annual maintenance contract for period of 05 years after defect liability period. Further the CAMC can be extended for 02 years on the performance basis beyond 05 years.

2.4.3 The Building committee also suggested to assign the operation work to the same agency to avoid any dispute later, by engaging 01 no. camera operator/audio operator and 01 no. Video editor.

The Estimate of Rs.82.95 lakhs were also approved on the above clause i.e. 06/3.2.2 & 06/3.2.3.

2.5 Allocation of site of allotment of land at Dhaka Complex, University of Delhi

Delhi University allotted the land at Dhaka Complex to Delhi School of Social Work, School of Correspondence Course/School of Open Learning (SOL) and Vallabhbai Patel Chest Institute (VPCI) in the year 1975, vide letter no. I/B.C./Dhaka/75/24977-80 dt. 14.08.1975. The construction of work was not done within 3 years, the possession of allotment land would, thereafter, be reviewed. Details of allotted lands are as under:

The SOL had fully utilized the allotted land, whereas VPCI had only utilized the 01-acre land and 02 acre land are unutilized. There are girls hostel complex along with the vacant land in position of VPCI. For security of Girls students, it is proposed to retain 02 acres land of VPCI and 1.7 acres vacant land from Delhi School of Social Work (**Total - 3.7 Acre vacant lands**) to utilize the retaining 3.7 acres land for construction of Girls Hostel.

The Building Committee recommended to retain the vacant land of 02 acres from VPCI and 1.7 acres from School of Social Work.

The Council considered and approved the recommendations of the Committee constituted vide Notification dated 03.09.2025 for establishment of Centre for Odia Studies under Ordinance XX of the Ordinances of the University. The Centre shall be a constituent of the Faculty of Arts.

The Council further resolved that the deliberation of the Committee meeting held on 10.12.2025 in terms of tentative financial aspects, keeping the academic aspects intact and proposed a total tentative expenditure of Rs. 39.00 crores comprising of Rs. 25.00 crores tentatively for the building infrastructure, Rs. 3.00 crores tentative for the establishment of Library, ICT and other items necessary for initiation and continuance of academic programmes in the Centre and Rs. 11.00 crores tentative annual recurring expenditure towards salary, scholarships, fellowships, Research Grant, Innovation Grant and other maintenance activities of the Centre be accepted.

The brief details are as under:

- i. the new Centre is expected to expand the horizons of deliberations on the Odia language, literature, culture, civilization and ethos both in posterity and also in contemporary perspective for a better understanding in this knowledge domain. This academic endeavour is expected to help in furtherance of this knowledge domain in future.*
- ii. the Centre for Odia Studies shall be a constituent of the Faculty of Arts in order to facilitate the curriculum design and implementation of the academic programmes as well as enrolment of the students for the Doctoral Studies.*
- iii. there will be a course M.A in Odia to be run by the Centre as two years Postgraduate Programme in the Semester Mode.
