
MINUTES of the meeting of the Standing Committee of the Academic Council under Clause-5 of Ordinance-II of the Ordinances of the University was held online (via Zoom Application) on October 19th, 2020 at 3:00 PM.

The Chairman, Standing Committee welcomed the members and requested the Deans Faculties of (i) Commerce & Business Studies and (ii) Medical Sciences to place their respective agenda before the house. The following items were approved after due deliberations:

1. The committee considered the recommendations of the meeting of the Commerce and Business Courses Admission Committee held on 21-9-2020 regarding doing away with Group Discussions Personal Interviews (GD & PI) for admission to MBA (HRD) and MBA (International Business) under Department of commerce from the academic year 2021-2022. The admission criteria to these courses on basis of weightage of CAT Score (80%), Marks obtained in class X (10%) and Marks obtained in Class XII (10%). Foreign Nationals with foreign degrees are required to submit both GMAT as well as TOEFL scores. The committee resolved to approve the recommendations. (ANNEXURE-I: page no.1-6).
2. The Committee considered the recommendations of the online meeting of Commerce and Business Courses Admission held on 17-10-2020 regarding revision of the M.Com. Entrance Examination syllabus from the next academic year 2021-2022 and resolved to approve the same. (Annexure-II: page no.7-11)
3. The Committee considered the note dated 14-10-2020 of the Dean Faculty of Medical Science forwarding therewith the eligibility conditions, seats matrix, bulletin of Information (BOI) for admission to super specialty (DM/M.Ch) for the session 2020-23 and starting of three years Doctor of Medicine (DM) Course in Endocrinology from the academic year 2020-2021. As informed by the Dean, Medical Sciences that the eligibility conditions and BOI same as per last year therefore the Committee resolved to approve the same (Annexure-III: page no.12-37)
4. The Committee considered the note dated 15-10-2020 of the Dean Faculty of Medical Science forwarding therewith the eligibility conditions, seats matrix, bulletin of Information for admission to Undergraduate (MBBS/BDS) Courses for the session 2020-2021. As informed by the Dean, Medical Sciences that the eligibility conditions and BOI same as per last year therefore the Committee resolved to approve the same (Annexure-IV: page no.38-80)
