Minutes of the meeting of the Committee re-constituted by the Vice-Chancellor to examine the existing Statute 7 (1) (xiii) and to suggest suitable amendments in the Statute consequent upon introduction of several new post-graduate (PG) and under-graduate (UG) degree courses and also to propose modalities for simplification of the procedure of election of five student members on the Academic Council, for consideration by the Academic Council/Executive Council, held on 10-4-2019 and on 22-4-2019 in the Office of the Dean (Examinations), University of Delhi, Delhi-07.

The Deputy Registrar (Academic) apprised the committee about the provisions of \$tatute 7 (1) (xiii) and the Appendices to the Statute.

After detailed discussions, the Committee unanimously resolved to recommend that the following suggestions be incorporated in of the process of selection of five studentrepresentatives on the Academic Council:

- As several new degree courses have been introduced and nomenclature of some of the degree courses has been changed in the University, the Statute 7 (I) (xiii), alongwith its Appendix, should be amended, by incorporating the following changes:
 - Instead of specifically mentioning the names of the degree courses in the Appendix 'C', the provision should provide that the electoral college should be constituted from amongst the students other than teachers, pursuing the regular under-graduate & post-graduate degree courses and the Appendix 'C' should be amended accordingly.
 - For first electoral college the list be compiled on the basis of esults of Masters program which makes him/her eligible for the Ph.D

In view of the above recommendations, the Committee proposed amendments to Statute 7(1) (xiii) for approval of the Competent Authorities, vide Annexure-I.

(v)	Any two electors college any nominate as a candidate any other electoral college for election therefrom to the Academic council by sending to or delivering at the office of the Registrar a nomination paper duly filled in before the expiry of the time fixed for the receipt of nominations. (vi)	Nomination paper shall be in the prescribed form. It shall contain the names in full of the two electors and of the candidate nominated and shall be dated and signed by the said electorals. (vii)	As soon as possible, after the last day fixed for the receipt of nomination, at a time and place fixed by the Vice-Chancellor and notified in the notice of election, any person or persons nominated by the Vice-Chancellor shall scrutinize the nominations.
