MINUTES

Minutes of the meeting of the committee constituted to examine the case of Mr. Aashish Gupta S/o Durga Prasad who pursued two degree courses simultaneously, held on 12.05.2017 at 10.00 A.M. in the office of the Dean, Faculty of Science.

Dr. Rohan Rai, Deputy Registrar (Academic) assisted the committee in its deliberations.

The Chairman welcomed the members and asked the DR (Academic) to present a brief of the case. The Committee considered the brief of the case as under:

1. The Academic branch received a complaint that Mr. Aashish Gupta S/o Durga Prasad has pursued two regular degree courses simultaneously while he was pursuing LL.B. from LC II, Faculty of Law, University of Delhi during 2011-14.
2. A show-cause notice was served to Mr. Aashish Gupta vide memorandum No. Aca.-I/2014-15/905 dated 26th November, 2015, asking him to show cause as to why action for cancellation of all the LL.B. examinations taken by him in the University of Delhi and withdrawal of the LL.B. degree awarded to him by the University should not be initiated by the University under Statute-15 of the Statutes of the University.
3. Mr. Aashish Gupta vide letter dated 10.12.2015 stated that he was not aware of the University rule with regard to pursuing two degree courses simultaneously not permissible/allowed in accordance with A.C. Resolution No. 40 dated 24.04.1997 and A.C. Resolution No. 49 dated 14.05.1975, at the time of admission.
4. The University Grants Commission vide Public Notice dated 15th January, 2016 has stated as under:

"The Commission had sought the comments of the Statutory Councils. The responses, so far, received do not endorse the idea of allowing the students to pursue two degree simultaneously. Therefore, the universities shall conduct their programmes in accordance with the First Degree and Master Degree Regulations, 2003 prescribed by the UGC and also follow the norms and parameters prescribed by the Statutory Council, wherever relevant".



The Committee after detailed deliberations, resolved that Mr. Aashish Gupta pursued two degree courses i.e. MBA Regular from Bhai Parmanand Institute of Business Studies GGSIPU University, Delhi in the year 2010-2012 vide Enrolment number 02211403910 and LL.B. from University of Delhi in the year 2011-14 vide Roll no. 118002 which is in violation of the resolution no. 40 dated 24.04.1997 and resolution No. 49 dated 14.05.1975 of the Academic Council of the University of Delhi.

Further the Committee recommended that the degree of LL.B. conferred on Mr. Aashish Gupta in the year 2011-2014 may be withdrawn in pursuance of the provisions of Statute-15 of the Statutes of the University of Delhi quoted below:

“The Court may, on the recommendation of the Executive Council, by a resolution passed with the concurrence of not less than two-thirds of the members voting, withdraw any degree or diploma conferred by the University”.
