Counselling Process for Special Scholarship Scheme for UTs of J&K and Ladakh (SSSJKL) under Pradhan Mantri Uchchatar Shiksha Protasahan Yojana (PM-USPY) - Academic Session 2025-26 is in process. Students who are already registered on the SSSJKL portal and have taken admission "*On their Own*" in one of the following types of institutions:

1. Medical College through NEET
2. Delhi University
3. Aligarh Muslim University
4. Jamia Millia University
5. Central Universities after qualifying CUET Examination and in IITs / NITs / NLU through CLAT (Except in the institutions of J&K and Ladakh) are required to upload the proof of admission e.g. joining letter / fee receipt etc. to the "*On My Own Tab*" on the SSSJKL Portal.
6. For admission in Indian Institute of Space Science & Technology (IIST), Thiruvananthapuram, students need to qualify JEE Advance 2025, conducted by IITs and secure the minimum prescribed marks (please see the link of IIST : <https://bit.ly/4FLR90i> for detailed information). The students will send the details of results to AICTE on email jkadmission2025@aicte-india.org for onwards submission to IIST for finalizing the merit and only those students will be issued AICTE allotment letter for taking admission in IIST.

It is further informed that above students will be issued allotment letter on the basis of their admission taken "*on their own*" after due verification of their documents by the SSSJKL Cell, AICTE to ascertain eligibility subject to norms of AICTE and availability of scholarship.
