Subject: Projects under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram (PMJVK) to University of Delhi for the year 2025-26 –Administrative Sanction- regarding.

Sir,

With reference to the subject mentioned above and the project proposals received in this Ministry from University of Delhi through online PMJVK Portal, Administrative Approval of the Competent Authority is, hereby, conveyed for the Phase-I of the project at an estimated cost of Rs. 46,49,24,196/- (Rupees Forty Six Crore Forty Nine Lakh Twenty Four Thousand One Hundred Ninety Six only) as approved by the Empowered Committee (EC) of PMJVK in its 48th Meeting held on 09.07.2025 under the scheme "Pradhan Mantri Jan Vikas Karyakram" for the University of Delhi for the financial year 2025-26. The details of the approved project components under Phase-I are enclosed at **Annexure-I**.

2. As per the decision of the 48th EC, the University may approach this Ministry for Administrative Sanction of Phase-II of the project (as detailed at **Annexure-II**), subsequent to submission of the utilization certificate for at least 75% of the amount sanctioned under Phase-I.
3. The execution works of the approved units will be subject to inspection and audit by an independent Third Party to ensure quantities and qualities of the work.
4. The Central Government Organization (CGOs)/ Universities are also requested to provide project completion timeline for completion of the works taking release of this letter as zero date, **immediately**.
5. The approval is subject to the condition laid down by the Empowered Committee(EC) as detailed in the minutes of the meeting, conveyed vide Letter No. MSDP-13/14/2025-MSDP-MOMA-Part(1), dated 23.07.2025.
6. CGOs/ Universities is advised to ensure strict compliance to the provisions relating to submission of Utilization Certificates in the prescribed format, Quarterly Progress Report along with the photographs of the work execution, on PMJVK Portal.
7. The sanction is issued on the commitment given by the CGOs/ Universities that villages/locations having a substantial minority population will be/has been selected for the

projects mentioned hereinabove and that there would be **no duplication / overlapping** with the works approved under any scheme / project / Plan of any authority including the State Government, Central Government / CPSE/ SPSEs etc. or any other developmental works.

8. The project will be executed with due implementation of the concept of **Universal Access and disabilities issues**.

9. The concepts/initiatives "**Vocal for Local**", "**Make in India**" are to be given due consideration while executing the project.

10. The funds will be utilized only for the purpose for which they are released. The CGOs/ Universities shall not rent/lease or transfer the property without the permission of the MoMA, Government of India.

11. CGOs/ Universities would undertake the responsibility for maintenance of facilities for which the funds are released and no reimbursement on account of losses incurred, if any, would be made by the CGOs/ Universities.


12. Cost over-run due to delay in physical execution of the approved work, where is attributable to the them, will be borne by the CGOs/ Universities only.

13. The Institute will provide atleast 15 days prior information to this Ministry about Foundation Stone Laying/ Inauguration Ceremony.

14. The CGOs/ Universities should ensure that a board containing information as per Template enclosed at **Annexure-III** is displayed at the site. After completion of projects, a permanent display would be installed.

15. Fund utilization by the CGOs/ Universities for the sanctioned works is subject to the terms and conditioned at **Annexure-IV**.

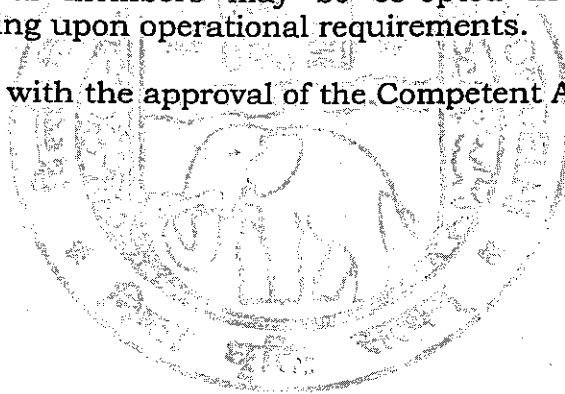
