(H) for academic session 2025-26 which is stated below: Candidates must appear in CUET in the following subjects: Any one Language from List A + Mathematics/ Applied Mathematics + Any two subjects from List B 2. The Department has dropped the option based on Accountancy for admission to academic session 2025-26. 3. In this regard, the following are stated: (a) After the publication of the changed eligibility on NTA website, thousands of queries are being raised by the prospective candidates on the email of Office of the Admission/UG Help Desk/Dean (Admission)/Joint Dean (Admission)/Deputy Dean (Admission) and at NTA for reconsideration of the eligibility. (b) It is the pertinent to mentioned that the Judgement dated 14.06.2019 of Hon'ble High Court of Delhi in the W.P.(C) No. 6751/2019 & CM CM APPL. 28336/2016, Charanpal Singh Bagri Versus University of Delhi & Ors. and W.P.(C) No. 6770/2019 & CM APPL. 228382-28383/2019, Khushi Srivastava Versus University of Delhi and W.P.(C) No. 6774/2019 & CM APPL. 28395/2019 Manas Shukla Versus University of Delhi & Ors. the direction issued in **Point No.20** says: "The above directions, however, shall not preclude the University of Delhi from making the changes in the eligibility criteria for the forthcoming years to its undergraduate courses as required, to keep education in tune with the necessities of the present day as also for maintenance of high standards of education, but the same can only be done in accordance with law, which would require a minimum of six months of public notice to the public at large of the eligibility criteria for admission to its under-graduate courses." 4. Considering the above, in the best interest of the candidates, maintaining the spirit of NEP-2020 and in light of the above-mentioned Judgement of the Hon'ble Court, it is suggested that past eligibility for B.Com. (H) may be continued i.e.: Candidates must appear in CUET in any of the following subject combinations: Combination I: Any one Language from List A + Mathematics/ Applied Mathematics + Any two subjects out of which at least one should be from List B1 OR Combination II: Any one Language from List A + Accountancy/Book Keeping + Any two subjects out of which at least one should be from List B1 5. In light of the above, the Competent Authority may be requested to kindly consider and grant approval for continuing with the past eligibility for B.Com. (H) as stated in Point No.4. 6. If approved, the NTA may also be informed to make the correction at their website.
