The applicants securing less than 55 marks for Colleges will not be included in the list of shortlisted candidates. A relaxation of 05 marks be given to candidates belonging to SC/ST/PwBD.



b. 40 candidates (including bunching effect) for the first vacancy and 20 candidates for every additional vacancy shall be called for interview in order of their ranks in the list prepared by the Screening Committee on the basis of marks scored by the candidates for each category as per the table prescribed by UGC for shortlisting of candidates for the post of Assistant Professor in Colleges and adopted by the University as detailed below.

c. If 40 candidates are not available, then, the applicability of 55 marks as cut-off be relaxed till the specified number of candidates are available, subject to a maximum relaxation of upto 5 marks i.e., 50 marks for UR and 45 for SC/ST/PwBD.

**Criteria for evaluation of candidates for determining their eligibility for their shortlisting for the interview.**

Society gave teachers, or gurus, what they needed to pass on their knowledge, skills, and ethics optimally to students. The quality of teacher education, recruitment, deployment, service conditions, and empowerment of teachers is not where it should be, and consequently the quality and motivation of teachers does not reach the desired standards. The high respect for teachers and the high status of the teaching profession must be restored so as to inspire the best to enter the teaching profession. The motivation and empowerment of teachers is required to ensure the best possible future for our children and our nation”. (NEP para 5.1)

NEP recognizes that as the “teachers will require training in high-quality content as well as pedagogy, teacher education will gradually be moved by 2030 into multidisciplinary colleges and universities. As colleges and universities all move towards becoming multidisciplinary, they will also aim to house outstanding education departments that offer B.Ed., M.Ed., and Ph.D. degrees in education. (NEP Para 5.22).

The Integrated Teacher Education Programme (ITEP) is a four-year integrated dual-major professional programme of teacher education offered after Grade 12 (or equivalent). The design of the ITEP is based on the design of teacher preparation stated in the National Education Policy (NEP) 2020. It combines rigorous educational understanding, disciplinary depth and a strong focus on school practice while taking into account existing ground realities.

The ITEP proposes to prepare teachers for all stages of School Education. NEP 2020 restructures the curriculum and pedagogy of school education into four School Stages. The ITEP will prepare teachers for each of these Stages- students will choose a particular Stage to specialize in so that their programme is tailored to the requirements of that particular Stage of School Education.
