- For specialization in Art History it will be based on Analysis / Premise and View / Critique
- For other five specializations it will be based on Drawing and relevant Specialization (weightage will be 50 : 50)

Merit will be calculated by considering the combined 'CUET score (50% weightage) and Practical-based test score (50% weightage)'

# UNDER-GRADUATE PROGRAM IN FINE ARTS

## Bachelor of Fine Arts (B.F.A.)

This program is run in the College of Art, an institute established in 1942 for advanced training in Creative and Visual Art (Six specializations in Applied Art, Art History, Painting, Printmaking, Sculpture and Visual Communication). Affiliated to the University of Delhi, the BFA degree is of four-year duration. The objective of the teaching programs and training are to achieve overall refinement of the student's perception, not confined to the skills of the profession alone, but also to create the right kind of intellect as well as emotional cultivation to arrive at level of composite creativity of thought.

This refers to letter no. F.5(120/ACD/Misc/1393 dated 13.03.2023 and F.5(120/Acd/Misc./1258-59 dated 27.03.2023 regarding entrance examination fee for BFA Practical Exam in College of Arts (COA).

The College has communicated that every year it receives approx 2200 applicants for BFA admissions. The expenditure on one applicant for conducting the Entrance Exam was approx. Rs. 500/-.

From this year onwards, admission to BFA will be through the combined merit obtained from CUET and Practical Test to be conducted by College of Art. Hence, the College has requested to provide a platform for candidates to submit an additional fee of Rs. 400/- (irrespective of any category) along with CSAS registration fee, non-refundable, from each candidate opting for admission to BFA.

The amount so obtained will be utilized by the College for the expenditure incurred during the Practical Test.

Keeping in view of the above, if the request of the College is approved, a provision may be made in the CSAS for taking as additional fees of Rs. 400/-, non-refundable (irrespective of any category) from the candidates who apply for admission in BFA program.

It is submitted herein that in the Standing Committee of Academic Council under Clause-5 of Ordinance-II of the Ordinances of the University, it was proposed that since the admission process of Master of Physiotherapy and PG Diploma in Cyber Security and Law was not decided at that moment, the Competent Authority was authorized to decide on the admission related policies of the above programs.

In this context, the following are proposed:

1. For admission to Master in Physiotherapy in Amar Jyoti Institute of Physiotherapy, the Institute has requested to include the course under CUET PG 2023 for this year (email dated 15.02.2023, Annexure-I). In this regard, the Program Specific Eligibility, CUET paper and seat matrix sent by the Institute are as under:

This has reference to the distribution of Post Graduation seats in Zakir Hussain (Eve.) College in the following three programs:

As per the letter dated 12.09.1987 to the Vice Principal of the College, Point no. 2, "only employed students will be allowed to join these courses provided that they fulfil the eligibility conditions as laid down by the Academic Council for admissions to the concerned Post Graduate course"

The matter was sent to the Head, Department Hindi, DU for her kind observation. The Head suggested that the Clause no. 2 which is related to "only employed students" may be withdrawn in the larger interest of students for admission to MA Hindi in Zakir Hussain (Eve) College.

Dear Prof. Gandhi,

I am writing to request that the increase in the number of seats from the existing 16 to 26 for the M.Sc. programme in Plant Molecular Biology and Biotechnology be included as a reporting agenda item in the upcoming academic council meeting.

The ten seats that we have been promised by the Department of Biotechnology, Government of India (DBT) come with the following advantages for the University and the Department of Plant Molecular Biology:

1. We will get to select 10 students from a pool of about 500 most talented biology students who have passed the DBT's National Biotechnology entrance exam.
2. These students get a fellowship of ₹ 5000-7500 pm for the course duration.
3. The department gets some recurring grants to upgrade the laboratories.
4. We get to increase the intake of students from the existing 16 to 26 without putting much load on the University's finances.

A copy of the Sanction Letter from the Department of Biotechnology, Ministry of Science and Technology, Government of India along with the Consent of the University Authorities including the honourable Vice Chancellor, Director South Campus, Registrar, Dean Academics and Dean FIAS is attached herewith for your kind perusal.

Acceptance of this agenda by the Academic Council will pave the way for the implementation of increase of seats for our Master's programme from the coming admission session.

This is with reference to your **M.Sc. Plant Molecular Biology and Biotechnology** proposal submitted to Department of Biotechnology, Ministry of Science & Technology, GoI, for financial support under DBT PG Teaching Programme. I am happy to inform you that the DBT-Steering Committee on HRD and Skill Vigyan has considered your proposal and recommended for financial support during 15<sup>th</sup> Finance Commission (2022-23 to 2024-25). The Recommendations of DBT-Steering Committee are as follows your kind perusal and necessary action:

***"The Committee recommended the proposal for financial support subject to adoption of DBT's Mandatory Terms & Conditions for DBT PG Programme."***

The Committee has also recommended **10 seats/annum** under PG Teaching Program at your institute under DBT support. Institute may work out on number of seats to be offered under DBT support as per infrastructure facilities and inform DBT the number of seats/annum that will be offered under DBT support at your institute during 2022-23 academic session. The University/Institute will admit the students under DBT support through Centralized selection process only i.e., GAT-B National level entrance exam conducted by DBT.

The DBT support for **M.Sc. Plant Molecular Biology and Biotechnology** at your institute **is subject to acceptance of Mandatory Terms and Conditions and financial concurrence of Department of Biotechnology**. The Mandatory Terms and Conditions are enclosed as attachment. If you are ready to join the DBT PG Teaching Programme as per DBT Mandatory Terms and Conditions, kindly submit the signed copy through email within 10 days (**i.e., on or before 25<sup>th</sup> March 2023**), otherwise it will be presumed that your institute is no longer interested in DBT support for proposed PG Teaching Program. You are requested to submit the original hard copy of the same in due course of time. It may however, be noted that no change in any clause of the mandatory terms and conditions will be accepted, if same has been found at any point of time, the support will be withdrawn without any notice.

An early response, latest by **25<sup>th</sup> March, 2023** should reach us for further action at our end.

## University of Delhi South Campus Department of Plant Molecular Biology

This is to state with pride that our application against a nationwide call by the Department of Biotechnology (DBT) for financial support to institutions starting/conducting Biotechnology Post-graduate programs has been selected for financial support. (Annexure I). However, this support is subject to acceptance of **Mandatory Terms and Conditions and financial concurrence of Department of Biotechnology on or before 25th March 2023**. The Mandatory Terms and Conditions are enclosed as Annexure II.

Salient Terms and Conditions are as follows (for details, see Annexure II):

- (1) **Number of Seats:** The DBT Committee has initially recommended 10 seats/annum for the PMBB Program. However, it is also mentioned that the Institute may work out the number of seats to be offered under DBT support as per infrastructure facilities and inform DBT for the 23-24 academic session. By this, we would be increasing the intake of our students from the existing 15 (+2 supernumerary) to 25 (+2 supernumerary).
- (2) **Selection and Admission of Students:** The 10 students under DBT support will be admitted through the Centralized selection process, i.e., the National level entrance exam conducted by DBT recognized/approved agency only. While the existing set of 15+2 students will be admitted via the CUET route as per prevailing university norms.
- (3) **Reservation Policy and Norms:** Admission of students under DBT-supported PG Teaching Courses and those admitted through CUET will be made as per the University of Delhi's reservation policy (which follows the norms of the Government of India). As the students would be admitted through different entrance examination streams.
- (4) **Uniform Fee Structure:** The upper limit of the fee prescribed by the DBT for the 2-year degree program is ₹ 50,000. This is well within the range of the currently proposed fee structure of ₹ 17,000 per year for the DU's PMBB PG program. The Fee structure would be as per the existing norms of the University in this regard.
- (7) **Constitution of Biosafety Committee:** The University of Delhi South Campus already has a DBT-recognized Institutional Biosafety Committee (IBSC) in place.
- (13) **Course curriculum:** Although the DBT has directed the Universities/Institutes to ensure the adoption of the Model Course Curriculum, the PMBB's course content is already in line with the DBT mandate.
- (15) **Hostel Facility:** The DBT has recommended hostel accommodation on the campus for all outstation students. However, keeping in mind the seat crunch in south campus hostels, the university authorities would be requested an increase in hostel quota for PMBB students.

Annexure II is submitted herewith for kind perusal and forwarding by the Head of the institution (Vice Chancellor/Director) to accept the Mandatory Terms and Conditions and financial concurrence of the Department of Biotechnology to execute this program in the Department of Plant Molecular Biology.
