- <u>1/-</u> The Minutes of the meeting of Executive Council held on 25.03.2022 (**Appendix-I**) were confirmed with the following corrections:
  - 1-1. Resolution No.67/- be read as follows:

The Vice Chancellor constituted the following Committee to put the issues for consideration raised by the Executive Council members during Zero Hour:

1 to 6 (No Change)

1-2. Resolution No. 77-4-2, clause (c) be read as follows:

No new academic and administrative activity/ responsibility in University of Delhi will be allotted to him even after his retirement.

- 2/- The Action Taken Report on the decisions made by the Executive Council at its meeting held on 25.03.2022 (Appendix-II) were noted.
- <u>3/-</u> The Executive Council considered and approved the Separate Audit Report (SAR) received from the Director General of Audit, (Home, Education and Skill Development) on the Annual Accounts of the University for the year 2020-21 (Appendix-III).

The Executive Council also resolved that the Internal Audit mechanism as observed by the C&AG shall be strengthened in the Maintained Institutions of the University of Delhi.

- 4/- The Executive Council considered the common judgment passed by the Hon'ble Supreme Court of India on 10.5.2022 in the matters related to CPF/ GPF in respect of category-I (N.C Bakshi batch) and category-II (Shashi Kiran Batch). The E.C noted the following:
  - (i) The Govt. of India O.M. No.4/I/87-PIC-I dated 1<sup>st</sup> May 1987 stipulate that all CPF beneficiaries, who were in service on 1.1.1986 and who are still in service on the date of issue of these orders will be deemed to have come over to the pension scheme unless to give an option to remain in CPF which is required to be submitted on or before 30.09.1987.
  - (ii) Ministry of Finance (DoE) Notification No.5/7/2003-ECB&PR dated 22<sup>nd</sup> December,2003 replaced the defined benefit pension system (old Pension) with New Pension Scheme for all new recruits to the Central Government service from 1.1.2004.
  - (iii) Govt. of India O.M. No.28/30/2004-P &PW (B) dated 26-7-2005 provides that the employees who entered into service on or before 31.12.2003 and who were governed by CPF scheme or any pension scheme of central or state Govt., other than the pension scheme under CCS(Pension) Rules, 1972, on submission of technical resignation to take up new appointment on or after 1.1.2004. cannot be allowed to join the old pension scheme under CCS (pension) Rules 1972, however, those who were governed by old pension scheme under the CCS(pension) Rules,1972 will continue to be governed by the same pension scheme and same rules.

After detailed deliberations, the Council resolved that:

(1) It is obligatory on the part of the University of Delhi to implement the order of 30.4.2014 of the Single Judge of Hon'ble High Court of Delhi in respect of Category-I (N.C.Bakshi Batch) since University of Delhi's appeal (LPA) filed at Division bench of Hon'ble High Court of Delhi & SLP at Apex Court as against the order of 30.4.2014 of the Single Judge of Hon'ble High Court of Delhi were dismissed.

- (2) In respect of Category-II (Shashi Kiran Batch), while disposing the SLP filed by the University of Delhi, the Hon'ble Apex Court observed and ordered that "the decision rendered by the Division bench of the High Court in Shashi Kiran batch of cases does not call for any interference except to the extent of direction for recouping of the contribution under CPF with 8% simple interest per annum". Hence, it is imperative that the University requires to implement the order of 24.8.2016 of Division Bench of Hon'ble High Court of Delhi.
- (3) Further, the Hon'ble Supreme Court of India directed that "it is possible that at this length of time, some of the employees in Shashi Kiran batch of cases may not be interested in switchover to GPF. But an option must be afforded to them in such manner as the authorities deem appropriate". As observed by the Hon'ble Apex Court that an option for switching over from CPF to GPF may be obtained from the employees of the University and its constituent colleges who are in service/retired from service before processing the case.
- (4) As directed by the Hon'ble Apex Court and taking into consideration of the O.M. No.4/1/87.PIC-I dated 1<sup>st</sup> May 1987 Ministry of Finance (DoE) Notification No.5/7/2003-ECB&PR dated 22<sup>nd</sup> December, 2003 an option from the employees both in service /retired who are/were in the University/College services as on 1.1.1986 and up to 31.12.2003 placed under the CPF may be submitted option form for shifting from CPF to GPF.
- (5) In order to reduce the financial burden to some extent on the Central exchequer, the Executive Council has also resolved that:
  - (a) The employer contribution along with 8% simple interest per annum to be refundable to the University/ Colleges in complying with the court order may be adjusted with the pension arrears payable to the pensioners.
  - (b) University of Delhi and its colleges will approach the UGC for requirement of funds if any, after adjustment of employer contributions which is / to be kept under the UGC refundable account for disbursement pension.
- (6) The Executive Council authorized the Vice Chancellor to take a decision for smooth and speedy disposal of the cases.
- (7) The decision of Executive Council about the implementation of the order of the Hon'ble Apex Court be intimated to the MoE/UGC.
- 5/- The Executive Council considered the recommendations of the Committee constituted by the Competent Authority of the University of Delhi vide Notification No. Estab.II(i)/2021/51 dated 6<sup>th</sup> January, 2021 and Estab.II(i)/010/2021/01/1327 dated 10<sup>th</sup> June 2021 to examine the case(s) for appointment on compassionate ground as under:

The University invited updated information in prescribed proforma from all the eligible candidates vide notification dated 23.08.2021. A total of 181 applications along with relevant details were received in response to this Notification, which were duly examined by the committee on the basis of a Point Based Merit System (PBMS) to award weightage points in accordance with the latest guidelines of the DoPT. List of applicants who could be considered for appointment on this ground along with the PBMS devised by the Committee was also notified by the University vide the Notification dated 03.03.2022. Through the notice, the stake holders were also asked to submit their grievances if any. In response to the same 38 grievances were received. In addition, one Mr. Sumit son of Mr. Nasib Singh. Daftry had filed a writ petition WP(C) 5847/2022 claiming compassionate appointment.

The grievances and the case of Shri Sumit were examined by the committee and the final report of the committee was submitted on 20.05.2022.

The committee has observed that Shri Sumit did not respond to the notice seeking information, vide notification dated 23.08.2021, which had given the last date of receipt of information upto 17.09.2021 for consideration by the committee. His case was not considered as the requisite information was never provided by the candidate. However, in line with the order of the Hon'ble High Court, one vacancy is to retained and not filled up. This implies that only 47 applicants can be accommodated.

Final recommendations of the committee inter-alia are as under:

- 1. The total applications examined by the Committee is 181 out of which 93 were not found eligible. The Committee has assessed the cases with a cut-off date of 31.12.2020. Therefore, 14 cases which were received after this cut-off date were not considered.
- 2. Remaining 74 candidates found eligible for consideration were awarded merit points in order of merit. The list of these 74 candidates is annexed at (Appendix-IV).
- 3. Against the 47 vacant positions as of now, the offer of appointment on compassionate basis may be issued to the 47 eligible candidates securing highest points based on the merit list of 74 candidates.
- 4. The offer of appointment is to be given at the Entry level of Non-teaching direct recruitment, i.e. Multi-Tasking level after due verification and submission of all details by the applicants. In case of bunching of candidates, the order of preference to be used for tie-breaking is as under:
  - In the first instance, a widow would be given preference.
  - In the second instance, the tie-breaking factor will be total of first three financial parameters i.e. Pension-annualized, total terminal benefits and annual family income + property income, divided by the total number of dependents. The lessor the per dependent available income, the higher the rank amongst the applicants whose scores had a tie.
  - In the third instance, applicant whose deceased relative against whom the appointment is being considered had a longer left-over service would be given preference.
  - In the fourth instance, applicant whose family has physically mentally challenged dependents and unmarried daughter(s) will be given preference.
  - In the fifth instance, applicant who is elder in age will be given preference.
- 5. The applicants who are not eligible and/or not found suitable for awarding the merit-based weightage points may be treated as settled / closed.

The fresh applications pertaining to the period after the cut-off considered by the Committee, i.e. 01.01.2021 would be considered with reference to the vacancies arising in this period as a separate lot.

The recommendations of the Committee dated 01.02.2022 and 20.05.2022 are attached herewith as "Appendix-V" and "Appendix-VI" respectively.

After considering the matter in all respects, the council constituted a committee consisting of the following E.C. members to relook into the matter and submit its report to the Vice-Chancellor, for placing in ensuing Executive Council meeting:

- The Executive Council considered and approved the recommendations of the Committee constituted by the Competent Authority of the University of Delhi to frame a policy for retention of University accommodation for persons who retired from the University of Delhi and holding a distinguished post/position after retirement as under:

#### Allowing retention for the period of 18 months beyond the permitted period of six months:

"The University Faculty who hold a prestigious position as Vice Chancellor of Central University /Secretary of Govt. of India/Director of a National Institute (not below rank/position of Vice Chancellor) under Central/State Govt. during the service and continues the tenure of the same after retirement and who retains the University Accommodation, may be allowed to retain the University Accommodation for a maximum period of 18 months beyond the permitted period of six months. The license fee during the extended period of 18 months will be charged as per category given below:

#### Category-I

A faculty member who becomes the Vice Chancellor of University of Delhi can retain the University Accommodation at 25% of 50 times for Type-V /40 times for Type-IV of applicable Normal License Fee i.e. (License Fee + Servant Qtr + Garage) + Other applicable charges like Water Charges, Electricity Charges etc.

#### Category-II

A faculty member who becomes the Vice Chancellor in other Central Universities/ Secretary to the Government of India/Director of a National Institutes (but not below the rank of Vice Chancellor) can retain the University Accommodation at 50% of 50 times for Type-V /40 times for Type-IV of applicable Normal License Fee i.e. (License Fee + Servant Qtr + Garage) + Other applicable charges like Water Charges, Electricity Charge etc.

#### Category-III

A faculty member who becomes the Vice Chancellor in other State Universities' Secretary/Principal Secretary/Commissioner to the State Government of India (but not below the rank of Vice Chancellor) can retain the University Accommodation at 75% of 50 times for Type-V /40 times for Type-IV of applicable Normal License Fee i.e. (License Fee + Servant Qtr + Garage) + Other applicable charges like Water Charges, Electricity Charge etc.

#### <u>7/-</u> Disciplinary cases.

7-1. The Executive Council considered reply vide email dated 19.04.2022 received from Dr. Sandhya Aneja, Assistant Professor, Institute of Informatics & Communication. University of Delhi, attaching therewith her letter dated 19.04.2022 in response to show cause notice vide Memorandum CR-VIG/069/2017/A/52/5331 (1 to 4) dated 13.04.2022 served on her in terms of EC vide Res. No. 77 (77-5) dated 25.03.2022.

The Executive Council noted that the Executive Council vide Res. No. 77 (77-5) dated 25.03.2022, while considering the report of the Inquiry Committee was of the view that unauthorized absence from services by Dr. Sandhya Aneja since 04.04.2016 amounts to serious misconduct and an act unbecoming of a teacher. The Executive Council had accepted the report of the Inquiry Committee and taking a serious view of the misconduct on the part of Dr. Sandhya Aneja, the Executive Council unanimously had resolved that Dr. Sandhya Aneja be issued a show cause notice asking why her services may not be terminated in terms of Ordinance XI of the University. Accordingly, show cause notice was served on her vide Memorandum CR-VIG/069/2017/A/52/5331 (1 to 4) dated 13.04.2022. The Executive Council did not find any merit in the reply submitted by Dr. Sandhya Aneja in response to the show-cause notice dated 13.04.2022.



After detailed discussion, the Executive Council unanimously resolved that services of Dr. Sandhya Aneja, Assistant Professor in the Institute of Informatics & Communication, University of Delhi be terminated with immediate effect and her period of unauthorized absence be treated as diesnon.

7-2. The Executive Council noted that Dr. Basudeb Saha, Associate Professor, Department of Chemistry, University of Delhi was served show-cause notice in terms of EC Res. No. 77 (77-6) dated 25.03.2022, vide Memorandum No. CR-VIG/069/2017/A/48/5332(1-4) dated 13.04.2022, asking therein why his services may not be terminated in terms of Ordinance XI of the University.

The Executive Council noted that the Executive Council vide Res. No. 77 (77-6) dated 25.03.2022, while considering the report of the Inquiry Committee was of the view that unauthorized absence from services by Dr. Basudeb Saha since 01.01.2015 amounts to serious misconduct and an act unbecoming of a teacher. The Executive Council had accepted the report of the Inquiry Committee and taking a serious view of the misconduct on the part of Dr. Basudeb Saha, the Executive Council had unanimously resolved that Dr. Basudeb Saha be issued a show cause notice asking why his services may not be terminated in terms of Ordinance XI of the University. Accordingly, show cause notice was served on him vide Memorandum No. CR-VIG/069/2017/A/48/5332(1-4) dated 13.04.2022. The Executive Council also noted that Dr. Basudeb Saha has failed to submit his reply to the show cause notice dated 13.04.2022 within the stipulated period.

After detailed discussion, the Executive Council unanimously resolved that the services of Dr. Basudeb Saha, Associate Professor, Department of Chemistry. University of Delhi be terminated with immediate effect and his period of unauthorized absence be treated as dies-non.

7-3. The Executive Council considered the report of the Internal Complaints Committee (ICC) vide letter No. ICC/DU/2022/818 dated 24.03.2022 on the complaint dated 27.05.2021 of sexual harassment filed by Ms. Smriti Yadav. student of M.A. Political Science (Sem-IV) (Complainant) against Mr. Ravi Singh, student of M.A. Political Science (Sem-IV). Department of Political Science (Respondent). The ICC has made the following recommendations:

"The fact that both the Respondent & the Complainant have passed out and are no more student of University.

- (i). The Respondent should be issued a warning not to repeat sharing phone number on social media for any female in future without her consent.
- (ii). He may also be asked to send a written apology to the Complainant for the emotional and mental hurt caused to her.
- (iii). He should not be provided a character certificate or recommendation by the Department/ University for two years."

The Executive Council accepted the report and the recommendations of the ICC.

Ambedkar University, Delhi in view of the Hon'ble High Court's order dated 17.05.2022 in WPC No 6739/2022 – Sh. Rahul Thakur Vs Lt Governor. GNCT of Delhi & Ors. Para 6 of the order dated 17.05.2022 of the Hon'ble High Court states that "pendency of this petition shall not come in the way of the college of Arts starting Bachelor of Fine Arts (BFA) and Master of Fine Arts (MFA) courses for the academic session 2022-23 as a part of Dr. B.R.Ambedkar University, Delhi".

The Council recommended to file appropriate pleadings seeking modification/ review of the said order / proceedings on urgent basis.

12-2. The Executive Council took note of the violation of admission policies by St. Stephens College for the Under Graduate Programme for academic session 2022-23

Considering the seriousness of the matter, the Executive Council resolved that the College should align its admission procedure with the admission policies of the University of Delhi.
