#### ELIGIBILITY

## **Essential Qualifications:**

- Good academic record as defined by the concerned university with at least 55% marks (or an
  equivalent grade in a point scale wherever grading system is followed) at the Master's Degree in
  Biomedical Sciences/ Life Sciences/Chemistry/ Medicinal Chemistry/
  Pharmacology/Toxicology/Statistics/relevant subject from an Indian University or an equivalent
  degree from an accredited foreign university.
- 2. Relaxation in minimum marks will be applicable as per UGC rules.
- 3. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- 4. The candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test as graded by the UGC.
- 5. The candidates who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET for recruitment and appointment of Assistant Professor or equivalent positions in University / Colleges / Institutes. Provided further, the award of degree to candidates registered for the M.Phil. / Ph.D. programme prior to 11th July 2009, shall be governed by the provisions of the then existing Ordinances / Bylaws/ Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges / Institutes subject to the fulfillment of the following conditions:
  - a. Ph.D. degree of the candidate awarded in regular mode only;
  - b. Evaluation of the Ph.D. thesis by at least two external examiners;

- c. Open Ph.D. Viva voce of the candidate had been conducted;
- d. Candidate has published two research papers from / based on his / her Ph.D. work out of which at least one must be in the refereed journal;
- e. Candidate has made at least two presentations in conferences/ seminars, based on his / her Ph.D. work.

The fulfilment of these conditions is to be certified by the competent authority of the University concerned.

Desirable: Candidates should have few years of teaching experience in the University /colleges/institute and must have taught them at the Post Graduate level.
