**53/- WELCOME**

The Council welcomed the Dr. Gyantosh Kumar Jha, Professor Principal, Atma Ram Sanatan Dharma College for becoming the member of the Executive Council in the Principals Category under **Statute 5(1)(ix)**.

The Chairman congratulated and honoured all the women members present in the meeting on account of the International Women's Day.

**54/- APPRECIATION**

The Council placed on record its deep appreciation of the services rendered by the Dr. Poonam Verma, Professor Principal, Shaheed Sukhdev College of Business Studies as members of the Executive Council in the Principals Category under **Statute 5(1)(ix)**.

**55/-** The Minutes of the meeting of Executive Council No. 1268th held on December 15<sup>th</sup>, 2023 (**Appendix-1**) were confirmed.

**56/-** The Action Taken Report on Minutes of the 1268th meeting of the Executive Council held on December 15<sup>th</sup>, 2023 (**Appendix-2**) was noted and confirmed by the Executive Council.

**57/-** The Executive Council approved the following recommendations made by the Academic Council at its meeting held on 30.11.2023. The recommendations of the Academic Council are reproduced below. Further, the Executive Council has also recommended that the consequential amendments to the relevant Ordinances of the University be made accordingly:

**57-1/** Ref.: A.C. Res. No. 38 dated 30.11.2023

**Resolved that the provisions for special moderation of 10 marks in respect of students who have a single remaining paper to complete the course be accepted.**

**Note:**

1. There is a provision of span period for completion of degree programmes in the University within which students must complete their degree programs. With the implementation of the NEP UGCF-2022, there is now some relief available for students who are unable to complete the degree course within the specified span period. In such instances, they are eligible to receive a certificate or diploma, as applicable, even if they fail to complete the full degree program. Furthermore, here, a span period of 7 years is provided for degree completion.
2. The situation becomes particularly challenging for students who have passed all course requirements except for a single paper, due to the adverse circumstances faced by student/s preventing them from completing the Degree. Eventually, the entire duration of time spent in pursuing the course is wasted, in such cases, the University may consider granting special moderation for a single left-over paper, as stated above.
3. This provision may provide for the special moderation, exclusively for those students who have a single remaining paper, to the extent of a maximum of 10 marks. This special moderation may be in addition to any moderation already applied to that paper. This provision may exclusive be made applicable for students who have passed all course requirements except for a single paper, preventing them from completing the Degree, subject to the satisfaction of the University after careful consideration of the reasons submitted by the student. This special relief may be extended even to students who have exhausted all their opportunities for special chance examinations as granted/as may be granted by the University.

57-2/ Ref.: A.C. Res. No. 39 dated 30.11.2023

**Resolved to grant a special chance to students who have exceeded their span period to appear in the remaining papers required to complete their degree (in respect of only those students whose span period was over in 2021-22 and 2022-23) be accepted.**

**Note:**

1. The COVID-19 pandemic introduced unforeseen challenges, such as remote learning, limited access to resources, and health-related concerns. These circumstances adversely affected students' academic progress, making it unjust to penalize them for factors beyond their control.
2. Many students who exceeded their span period are likely to be under significant stress and anxiety due to their academic situation. Providing them with this opportunity would contribute to their mental well-being and relieve their academic burden.
3. The following steps may be taken to implement the proposal: -
  - Constituting a committee comprising academic advisors, faculty members, and administrators to evaluate requests from students who have exceeded their span period.
  - Allowing eligible students to submit an application explaining the reasons for their span period extension, with a focus on the impact of the pandemic.
  - Evaluate each application on a case-by-case basis, considering the extenuating circumstances and the feasibility of granting the special chance.
  - Conducting special chance examination for these students to facilitate their degree completion.

This opportunity would provide these students with a fair chance to overcome the obstacles they encountered during the pandemic and fulfil their academic aspirations.

**The Council also resolved that the above provisions may also be made applicable for M.Phil Students and for the students who appeared in Centenary Chance with a limit of four papers.**

58/- **The Council considered the recommendation of the Committee (Appendix-3) constituted to frame the guidelines for grant of Study Leave to the faculty members of the University of Delhi and resolved that the recommendations of Committee for pursuing the Ph.D. from abroad be accepted as under:**

- (i) The QS World Ranking of the University from where the non-Ph.D. faculty wish to pursue Ph.D. degree should not be less than that of the University of Delhi.
- (ii) The type of stipend/Fellowship and the amount thereof should also be mentioned in the application of the faculty member who wish to pursue Ph.D. from other Universities in the country and abroad.
- (iii) If the faculty member is getting some Fellowship, it should also be declared at the time of application for Study Leave.
- (iv) The salary of the faculty member will be decided as per existing Rules and Regulations of the University of Delhi.

**59/-** Resolved that the decision of the University Grants Commission (UGC) taken vide Public Notice F.No.9-5/2023(PS/Misc.) dated 30.01.2024 (Appendix-4), in extending the validity for offering M.Phil. in Clinical Psychology and M.Phil. in Psychiatric Social Work till 2025-26 academic session, in view of the vital role played by the Clinical Psychologists and Psychiatric Social Workers in delivering mental health services, in partial relaxation to the UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022 notified on 07.11.2022 for discontinuance of M.Phil. Programme keeping in line with recommendation of the National Education Policy, 2020 be accepted.

Further, the Council also considered the request of the Director, IHBAS vide email dated 23.02.2024 and granted permission to resume admissions from academic session 2023-24 onwards in M.Phil. Clinical Psychology for 2023-25 batch.

Note: The Academic Council and the Executive Council of the University vide its Resolution dated 24.08.2021 and 31.08.2021 had decided to discontinue M.Phil. Programme from the Academic year 2022-24 keeping in line with NEP, 2020. Also, the Gazette Notification dated 07.11.2022 on UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022 clearly states that HEIs shall not offer M.Phil. Programme.

Also, the UGC vide its public notice dated 26.12.2023 UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022 notified in the Gazette Notification on 07.11.2022 requested the Universities to take immediate steps to stop admissions to M.Phil. program for the 2023-24 and also advised the students not to take admission in M.Phil. Program

However, subsequently, the University, after taking cognizance of the apprehensions made by the Dean, Faculty of medical Science, vide its letter dated 11.08.2023 followed by another dated 06.10.2023 addressed to the Secretary, UGC, New Delhi while stating therein that the University of Delhi has decided to discontinue the M.Phil. Course from the Academic Session 2022-23 upon implementation of National Education Policy (NEP) sought the direction of the Commission for resumption of M.Phil. (Clinical Psychology) Course at IHBAS as an interim arrangement in the interest of students and patient care till necessary final decision is taken by the Rehabilitation Council of India (RCI).

Now, the Secretary, UGC vide Public Notice F.No.9-5/2023(PS/Misc.) dated 30.01.2024 considering the vital role played by Clinical Psychologists and Psychiatric Social Workers in delivering mental health services has decided to extend the validity of M.Phil. in Clinical Psychology and M.Phil. in Psychiatric Social Work till 2025-26 academic session only in partial modification to UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022 notified on 07.11.2022.

The Director, IHBAS vide email dated 23.02.2024 has requested for permission to resume admissions from academic session 2023-24 onwards in M.Phil. Clinical Psychology for 2023-25 batch.

**60/-** The Council considered the request of Shri Prashant Choudhary, Assistant Commissioner of Police (ACP), North District Delhi, Delhi Police for granting special chance for completing LL.B. Degree from Faculty of Law.

The Council deliberated the matter at length and it was resolved that request of Sh. Prashant Choudhary to pursue the LL.B. may be accepted without quoting as precedent. The approval to Sh. Choudhary shall be subject to submission of NOC and sanction of study leave for remaining duration from parent department to complete the statutory requirement for the course i.e. two (2) years.

Further, the Council authorized the Vice-Chancellor to constitute a sub-committee to look similar cases in future.

- (i) Shri Prashant Choudhary had joined the evening LLB Program from Faculty of Law, University of Delhi, North Campus in the year 2011-12 (Exam Roll No. 74428, Class Roll No. 504)
- (ii) Shri Choudhary appeared for 2<sup>nd</sup> term in 2012-13 (Class Roll No. 907).
- (iii) Shri Choudhary could not complete his LLB Degree as he was preparing for Civil Services Exam. He Got selected in DANIPS in 2014 and later posted in A&N Island.
- (iv) Shri Choudhary is requesting to allow him to appear again for the left part of LLB Degree.
- (v) Shri Choudhary assured that he would abide by all the codal formalities and requirements needed in completing his LLB Degree.

**61/- The Council considered and approved the following recommendations of the Finance Committee made at its meeting held on 16<sup>th</sup> February 2024.**

**61-1/ Resolved to adopt the Audited Annual Accounts along with Separate Audit Report (SAR) on the Annual Accounts of the university for the financial year 2022-23 issued by the office of director general of audit (central expenditure) be accepted. (Appendix-5).**

Note:

(a) The Finance Committee in its meeting held on 16.02.2024 has considered the Separate Audit Report (SAR) on the Annual Accounts of the University for the Financial Year 2022-23.

(b) The unaudited Annual Accounts for the Financial Year 2022-23 has already been considered and approved by the Finance Committee and Executive Council at its meeting held on 17.8.2023 and 25.8.2023 (EC Resolution No. 28 dated 25.8.2023) respectively.

**61-2/ Resolved that the revised Budget Estimates for the financial year 2023-2024 and budget estimates for the financial year 2024-2025 be accepted. (Appendix-6).**

Note: The Finance Committee in its meeting held on 16.02.2024 has considered the Financial Estimates (Revised Budget Estimates for the financial year 2023-24 and Budget Estimates for the financial year 2024-25) of the University.

**61-3/ Resolved that the matter of payment of wages to all category of staff engaged in the university through outsourcing agencies in terms of the rates notified from time to time by the Chief Labour Commissioner, Ministry of Labour & Employment, Government of India or NCT of Delhi, whichever is higher be accepted (Appendix-7).**

Note: The Finance Committee in its meeting held on 16.02.2024 considered the matter of payment of wages at rates notified by the Chief Labour Commissioner, Ministry of Labour & Employment, Govt. of India or NCT of Delhi, whichever is higher, from time to time in respect of all categories of staff engaged in the University through outsourcing agencies w.e.f. 01.4.2024.

**61-4/ To report the letter No. F.No.4-2/2022 CU-II dated 13<sup>th</sup> April, 2023 regarding creation of teaching and non-teaching posts for Faculty of Technology, received from Ministry of Education, Govt. of India (Appendix-8).**

Note: The Finance Committee in its meeting held on 16.02.2024 acknowledged the letter for creation of teaching and non-teaching posts for the Faculty of Technology.

**61-5/ To report the sanction of funds for execution of 2 projects for funding from HEFA. (Appendix-9).**

Note: The Finance Committee in its meeting held on 16.02.2024 noted the approval of 7 Projects for funding from HEFA amounting to Rs.938.33 crores conveyed vide MoE letter dated 11th October, 2023. Subsequently, Term Loan of Rs.261.33 crores was sanctioned by the HEFA for the execution of two Projects viz. (1) Construction of New Building for the Faculty of Technology and (2) Wi-Fi connectivity and expansion of the network at the University of Delhi vide HEFA sanction letter No.SAN/UOD/765/2023-24 dated 23.01.2024.

**62/- The Council considered and approved the draft of the 100<sup>th</sup> Annual Report of the University for the period from 1st April, 2022 to 31st March, 2023 (Appendix-10).****63/- Disciplinary Matter**

**63-1/ Ref: EC Res. No. 18 dated 09.06.2023  
EC Res. No.46 (46-1) dated 15.12.2023**

The Executive Council considered reply vide email dated 24.01.2024 of Prof. Manisha Yadav, Professor in Dr. B.R. Ambedkar Centre for Biomedical Research (ACBR), University of Delhi, submitted by her in response to the show cause notice vide Memorandum No. CR-VIG/069/2023/A/09/7856 dated 04.01.2024, issued to her in terms of EC Res. No.46 (46-1) dated 15.12.2023. She was asked, therein, to show cause as to why her services be not terminated w.e.f. 16.08.2023 for her act of insubordination, dereliction of duties and unauthorized absence.

After considering reply dated 24.01.2024 of Prof. Manisha Yadav to the show cause vide Memorandum dated 04.01.2024, the Executive Council did not find any merit in her reply and reiterated its earlier findings made in its meeting held on 15.12.2023 vide EC Res. No.46 (46-1) that Prof. Manisha Yadav is guilty of acts of insubordination, dereliction of duties and unauthorized absence from duty w.e.f. 16.08.2023 which tantamounts to gross misconduct and are in gross violation of the provisions of the Act, Statutes and Ordinance XI of the University and highly unbecoming of a teacher of the University. Therefore, the Executive Council unanimously resolved that services of Prof. Manisha Yadav, Professor in Dr. B.R. Ambedkar Centre for Biomedical Research (ACBR), University of Delhi, be terminated w.e.f. 16.08.2023.

**63-2/ Ref: Executive Council Res. No. 29(29-2) dated 25.08.2023**

The Executive Council considered the Report dated 17.11.2023 of the Committee constituted in terms of Executive Council Res. No. 29(29-2) dated 25.08.2023 to look into the Report of the Internal Complaints Committee (ICC) vide letter No. ICC/DU/2023/1052 dated 20.02.2023 on the complaint received on 02.06.2022 from Ms. Jyoti Roy, Ph.D. Scholar in the Department of Hindi against Prof. Anil Rai, Department of Hindi, University of Delhi and also the Appeal/Representation dated 23.03.2023 received from Prof. Anil Rai against the report of the ICC, and to suggest further course of action.

The Executive Council noted that the Committee in its report had concluded that the Committee is not in unison with the recommendations of the ICC in considering the respondent, Prof. Anil Rai as being guilty of sexual harassment as per the definition of the same as laid out in Section 2(k)(i) of UGC Regulation-2015.

After detailed deliberations, the Executive Council unanimously resolved to accept the recommendations of the Committee constituted in terms of Executive Council Res. No. 29(29-2) dated 25.08.2023.

However, the Executive Council accepted that there was a need to conduct gender sensitization workshops in the Departments for the students, teachers and non-teaching staff to sensitize them about the issues concerning providing a healthy work environment for females.

**63-3/ Ref: EC Resolution No. 46 (46-2) dated 15.12.2023**

The Executive Council considered the case of Shri Mohit Soni, Assistant, University of Delhi South Campus with regard to the disciplinary action initiated against him by issuance of article of charges vide Memorandum No. CR-VIG./Disc./B/069/2016/2228 dated 17.01.2018 and additional articles of charges served on him vide Memorandum No. CR-VIG./Disc./B/069/2016/2475 dated 30.01.2020.

The Executive Council noted that in terms of EC Resolution No. 46 (46-2) dated 15.12.2023, show casue notice vide Memorandum No. CR & VIG./069/B/Disc./2016/7857 dated 04.01.2024 was served on Shri Mohit Soni asking him as to why the penalty of reduction to lower post for a period of 3 years or till his retirement, whichever is earlier, should not be imposed on him, in terms of Rule 63(vii) of the University Non-teaching Employees (Terms & Conditions of Service), Rules-2013.

Shri Mohit Soni submitted a letter dated 16.02.2024 (received on 01.03.2024) requesting therein to provide entire enquiry proceedings. He has also requested to allow him to inspect the entire files of disciplinary proceedings initiated against him vide Memorandum dated 17.01.2018. He sent another letter dated 04.03.2024 seeking six weeks time to file his defence only after receiving the entire records of enquiry.

The Executive Council further noted that copies of the Enquiry Reports dated 07.12.2018 and 07.10.2022 have already been provided to Sh. Mohit Soni along with the above show-cause notice dated 04.01.2024. Further, all the documents relevant to the enquiry have also been provided to him along with the article of charges vide Memoranda dated 17.01.2018 and 30.01.2020. It was also observed that Shri Mohit Soni had participated in the inquiry proceedings and accordingly the proceedings were shared with him during the process.

After detailed deliberations, the Executive Council resolved that Mr. Mohit Soni may still be allowed inspection of the relevant documents in the case and be asked to submit his reply within 10 days to the above show-cause notice dated 04.01.2024. The Executive Council authorized the Vice-Chancellor to take decision in the matter in light of the fact that the Executive Council has already approved the penalty to be imposed on him in its meeting dated 15.12.2023.

As per Academic Council Resolution No. 9 dated 27.11.2020; University Notification No. Aca.-I/Ward Quota/2021/40 dated 13.08.2021; University Notification No. Aca.-I/Ward Quota/ 2021/ 888 dated 28.10.2021 and University Notification No. Aca.-I/Ward Quota/2022/655 dated 01.08.2022 wherein the order of preferences for Ward quota are started from Academic Session 2022-23.

It was notified that wards of employees of the University of Delhi are entitled to the benefit of a preferential quota ("the Ward Quota") for admission to its colleges. Each college has an External Ward Quota ("EWQ", hereinafter), of wards of employees of other colleges or of the University, and an Internal Ward Quota ("IWQ" hereinafter), of wards of employees of that college itself. The EWQ and IWQ are further sub-divided into Teaching and Non-Teaching Ward Quotas.

In pursuance to the Academic Council Resolution No. 09 dated 27.11.2020 and further Notification No. Aca.-I/Ward Quota/2021/40 dated 13.08.2021 and University Notification No. Aca.-I/Ward Quota/2022/655 dated 01.08.2022 the admissions of the wards of the employees of the University and its Colleges, the order of preference shall be as under:

1. Permanent Staff \* and those staff who left for : Teaching and Non-Teaching  
untimely Heavenly Abode while in Service

The 8 supernumerary seats under EWQ are sanctioned for each i.e., teaching and non-teaching wards of employees of University of Delhi.

These are further divided Program-Cluster-wise (Stream-wise) across colleges, 2 (Two) for Sciences, 3 (Three) for Humanities and 3 (Three) for Commerce where all three Streams are offered in a College. The Seats are proportionally distributed in similar manner in Colleges where Two/One Stream are offered. Ward quota allocations are done Program-Cluster-wise. Combined merit for each program in three streams are considered for allocations in UoD Ward quota.

Allocations of Ward Quota is based on merit scores of candidates in Program clusters and the order of preferences given by the candidates. The seats under ward quota allocated for teaching and non-teaching will not be interchangeable. However, allocations may be considered within the Program Clusters to maximize the benefit.

**Decision:**

The Hon'ble Court found no illegality in the University adopting the stream-wise allocation procedure, as envisaged by the Admission Branch decision dated 4 November 2022. It was also decided, in the AC meeting, that a similar procedure would be followed for the academic session 2023-24. That decision was approved both by the AC as well as the Executive Council of the University. There cannot, therefore, be said to have been any illegality in the respondent following the Cluster-based allocation system while effecting Ward Quota admissions in the University.

The writ petition was, therefore, devoid of merits. It was dismissed, albeit without cost.

**Subsequently, the following has been explicitly mentioned in the Bulletin of Information (UG) 2024-25 for Ward Quota Supernumerary allocations:**

Admission to the wards of University and its College employees, both teaching and non-teaching will be done as per Academic Council resolution 9 a & b dated 27.11.2020 and subsequent amendments thereof. Candidates must be in possession of a valid Employment Certificate issued by due officials at the time of registration. Only the Employment certificate uploaded at the time of registration will be considered. I-cards, Aadhar Card and/or any other document will not be accepted. Admissions under ward quota for each college will be determined in three Program Clusters namely viz. Humanities, Commerce and Sciences. The allocation will also depend upon the number of Programs offered in a College/Department. Allocation of Ward Quota will be based on merit scores of candidates in program clusters and the order of preferences given by the candidates. The seats under ward quota allocated for teaching and nonteaching will not be interchangeable. However, allocations may be considered within the Program Clusters to maximize the benefit. Appropriate proration in CUET scores may be done to ascertain cluster-based merit.
