- To consider the Syllabi of B.A.(H) Sociology for Semester VI. The committee deliberated upon the agenda item with respect to the Semester VI syllabi of B.A (Hons.) Sociology and approved the same as proposed by the Head, Department of Sociology as per the CBCS-LOCF Structure as approved by the Academic Council and Executive Council of the University.

Item 4 Department of English

Item 5 Department of Germanic & Romance Studies

- To consider the change in nomenclature of General Elective (GE) papers in B.A.(H) French/German/Spanish/Italian, (Sem-1,2,3 and 4) of the Department of Germanic & Romance Studies.

The committee deliberated upon the agenda item with respect to the nomenclature of General Elective Papers as mentioned in the agenda and observed that the issue raised by the Department does not come under the purview of the Oversight Committee as it is not an oversight in the course structure or syllabi in terms of the CBCS (LOCF) Structure.

In case the department desires to change the nomenclature of the General Elective Papers under reference, it may take up the matter to appropriate mode for its consideration by the Statutory Bodies of the University as a germane proposal of the department as per the procedure laid down in the Statutes and Ordinances of the University. This was communicated to the Head, Department of Germanic & Romance Studies who was a Special Invitee.

Item 6 Department of Anthropology

- To consider the rectification of B.Sc. (Hons.) Anthropology (CBCS-LOCF) syllabus of the Department of Anthropology.
