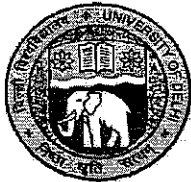

The University of Delhi has constituted the Faculty of Open Learning as per the provisions of Statute 9(3), consisting of following members:-

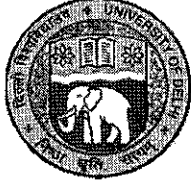
i	Dean	Prof. Payal Mago
