In continuation of note at page No.- 4, in this connection, it is submitted that an Explanation below the Clause M-26, Ordinance-VI related to procedure for award of Master of Philosophy (M.Phil) and Doctor of Philosophy (Ph.D.) Degree was added as follows:

"Explanation: The expression 'M.sc. In Medical subjects' in Clause E of Postgraduate Medical Education Regulations, 2000 regarding admission to Ph.D. Programme includes M.Sc. in such subjects which are relevant to a department of the Faculty of Medical Sciences as may be recommended by the Departmental Research Committee concerned to the Board of Research Studies (Medical Sciences) from time to time."

The above Explanation was also approved by the Academic Council vide Resolution No.-18-14 Dated 03.08.2022 and by the Executive Council vide Resolution No. 30 (30-7).

- However, as per the Ordinance-VI of the University approved by the Executive Council at its meeting held on 15.12.2023 (E.C. Resolution 39-9/Annexure 22), the Clause M-26 has been changed as M-24 and the above explanation could not be incorporated under the said Clause.

The matter was also considered in the meeting of Board of Research Studies held on 18.03.2025 and it was resolved that the explanation below the Clause No. M-26 as amended by the Academic Council vide Resolution No.-18- 14 Dated 03.08.2022 and by the Executive Council vide Resolution No. 30 (30-7) dated 18.08.2022 is required to be incorporated in the Ordinance- VI (2023).
