Subject:- Regarding CW Quota Priority-V, Change in nomenclature of President's Police Medal for Gallantry (PPMG) as President Medal of Gallantry (PMG) and Police medal for Gallantry (PMG) as Medal of Gallantry (GM) by the Government of India.

Respected Sir,

Please refer your letter No. Acad.I/Armed Forces/2025/72 dated 22.04.2025. On the subject cited above, it is to reiterate once again that President Secretariat vide Notification No. 88-Pers/2023 & NO.89-Pers/2023 dated 14.10.2023. has instituted two new medals namely (i) "President's Medal for Gallantry (PMG)" which replaces the previously awarded President's Police Medal for Gallantry (PPMG) /President Gallantry Medal for the Fire services personnel and (ii) "Police Medal for Gallantry (PGM) /Gallantry Medal for Fire services" which replaces the previously awarded police Medal of Gallantry (PMG). Consequently, It has been requested to update the Priority-V, sub Clause-X of the CW quota admission of the University of Delhi.

2. That Sir, Your goodself in your ibid letter under para 05 and 06 seeking confirmation regarding replacement of the entire sub clause- (vii) and entire sub clause- (x) under Priority-V with "President's Medal for Gallantry" and "Medal for Gallantry. This has been necessitated because the "President's Medal for Gallantry" and 'Medal for Gallantry" also include Fire Services alongwith Police Services.

3. In view of the above Para 2, the query raised by your goodself, it is to clarify that the Gallantry medal awarded to the recipients before 26.01.2024. i.e. PPMG/PMG shall continue to be considered as per your existing policy of Delhi university under the CW priority -v, sub clause -(vii) and sub clause -(x) as per edibility.

4. With reference to the Change in nomenclature of President's Police Medal for Gallantry (PPMG) as President Medal of Gallantry (PMG) and Police medal for Gallantry (PMG) as Medal of Gallantry (GM) by the Government of India w.e.f. 26.01.2024 onwards. It is now requested to introduce the two new sub Clauses (xi) and (xii) under CW Quota as under:-

- (a) Clause (xi) President Medal of Gallantry for CAPF, State Police, Fire services, Home Guard, Civil defence, and Commercial service.
- (b) Clause (xii) Medal of Gallantry for CAPF, State Police, Fire services, Home Guard, Civil defence, and Commercial service.

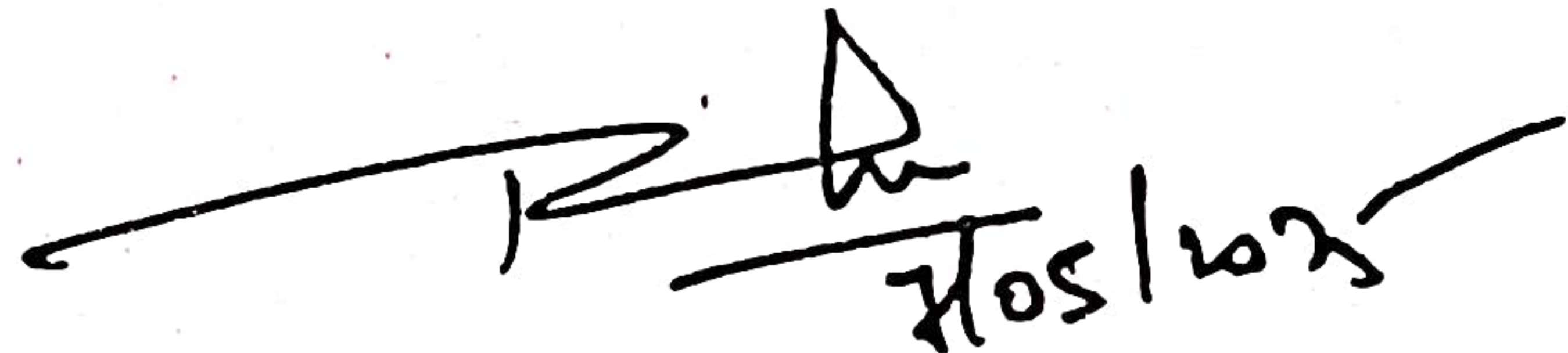
Or
Clause (xi) will be submerged in clause (vii) and Clause (xii) will be submerged in clause (x)

In view of the consideration enumerated above, it is requested to kindly incorporate two more sub clauses i.e (xi) and (xii) or they will be submerged in clause (vii) and clause (x) respectively for the wards of those Gallantry Medal awardees who were conferred Gallantry Medal on or after 26.01.2024 as mentioned and proposed in Para (4).
