A meeting of the Inspection Committee constituted by the Hon'ble Vice-Chancellor, University of Delhi in terms of Statute 30(1)(c)(iii) of the Statutes of the University was held on Monday, 11th November, 2024 at 10:30 a.m. in the office of the Director, G.B. Pant Institute of PG Education & Research (GIPMER) to conduct inspection to re-assess the availability of clinical and operative workload facilities and other infrastructure, teaching faculty, library, laboratories etc. for increasing seats from 2 to 4 in DM (Neuroanaesthesia) Course at GIPMER.

The Director, Govind Ballabh Pant Institute Postgraduate Medical Research Education & Research (GIPMER) welcomed the members and thereafter meeting was held in the Committee Room of the GIPMER.

A brief presentation was made by Prof. Priyanka Khurana, Professor, Department of Neuroanaesthesia, GIPMER regarding increasing seats from 2 to 4 in DM (Neuroanaesthesia)course under the Department of Microbiology at GIPMER as per the availability of equipment, workload, involvement in teaching programme, faculty members, resident doctors, technical staff and future plan of the Department

The Committee inspected the various wings of the Department of Neuroanaesthesia at GIPMER to re-assess the availability of clinical and operative workload facilities and other infrastructure, teaching faculty, library, laboratories etc. for increasing seats from 2 to 4 in DM (Neuroanaesthesia)Course at GIPMER.

A. The observations of the Inspection Committee

1.	Govind Ballabh Pant Institute Postgraduate Medical Research Education & Research (GIPMER), Delhi is presently imparting PG (MD/MS) and Super-specialty (DM/M.Ch) courses.	
2.	The Department of Neuroanesthesia is a separate department in GIPMER. The Department was created in 2016 and conducting DM (Neuroanaesthesia) Course (02 students from 2021). The Department having Six (06) regular faculty members (02 Director Professor, 02 Professor, 01 Assistant Professor and 01 Assistant Professor – Adlice).	
3.	The department has a separate library, journal club/seminar, demonstration hall and adequate workload of Laboratory investigations.	



Water State of State	The Department has the following regular faculty members in the Department of Neuroannesthesia for increasing seats from 2 to 4 in DM (Neuroannesthesia) Course:

(v)	Dr. Sagar Debbarman, Assistant Professor having more than 9 months teaching experience and 12 publications.

B. The Clinical facilities available in the Department of Neuroanaesthesia:

- Provides services for Neurosurgical OTs and ICUs, Neurology ICU Diagnostic & Interventional Neuro-Radiology, CT scan, MRI and ECT, Pain Clinic, PAC Clinic.
- Neurosciences infrastructure: Beds (Neurosurgery 86, Neurosurgical ICU 22, total 108 Beds, (Individual Unit I 54 Beds),
 Neurology 93, Neurology ICU 20 Total 113
- Emergency Neurology 6, Emergency Neurosurgery 13, Neurosurgery modular OT-5
 (4 major, 1 minor, 1 Neuro Intervention suite)
- OTs and ICUs are well stocked with upgraded surgical and anaesthesia equipment, adequate Neurosciences supportive service present.
- Adequate staff (nurses, technicians, orderlies, clerical and sanitation workers)

C. SUGGESTIONS:

(a) The Institution will obtain necessary permission of the concerned Regulatory Bodies, wherever required as per rules of the National Medical Commission/Ministry of Health & Family Welfare.

D. RECOMMENDATION:

Keeping in view the availability of sufficient infrastructure viz. required availability of clinical and operative workload facilities and other infrastructure, teaching faculty, library, laboratories etc., the Inspection Committee unanimously recommends that the seats be increased from 02 to 04 per year in DM (Neuroanaesthesia) Course at G.B. Pant Institute of Postgraduate Medical Education and Research (GIPMER) with effect from the academic year 2025-26 after approval of the regulatory body i.e. funding agency and National Medical Commission (NMC).
