Assistant Registrar (Academic) and Section Officer (Academic-I) assisted the committee in its deliberations.

The Committee was apprised about various requests received with respect to the fee structure of the programmes where it has not yet been finalized.

1. The proposal of the Head, Department of English with respect to the fee structure of the Ph.D programme of the Department of English was discussed in the meeting wherein the Head of the Department had proposed fee of Rs. 17,118/- for the Academic Session 2024-25 which is identical to the fee structure for the Academic Session 2023-24.

The committee after due deliberations recommended a total fee of Rs. 19,103/- for the Academic Session 2024-25, as per details mentioned below:

2. The proposal of the Head, Department of Anthropology with respect to the fee structure of one year (Semester I and Semester II) Certificate course in Forensic Science of the Department of English was discussed in the meeting wherein the Head of the Department had proposed a fee structure of Rs.6000/-for the Academic Session 2024-25 which is identical to the fee structure of Certificate Course in Hindi for the Academic Session 2024-25.



The committee after due deliberations recommended a total fee of Rs. 6000/- for the Academic Session 2024-25, as per details mentioned below:

- The issue of category wise calculation of fee structure of Five Year Integrated Law programmes based on various concessions extended to different categories of students based on income criteria and other parameters as proposed by the Dean, Faculty of Law was discussed in the meeting and it emerged that the Faculty of Law has already been provided with the fee structure for the programme under reference alongwith different categories of concessions to be extended to the desired category of students. The Faculty of Law may carry out the calculations at their level in consultation with the Finance Branch, if necessary.
- The proposed fee structure of the Post Graduate Diploma in Cyber Security and Law (PGDCSL) w.e.f Academic Session 2025-26 has been received from the OSD, PGDCSL through the Principal, Shaheed Sukhdev College of Business Studies of the University as the programme is run in a self-finance mode in the college. Since, the fee structure for the Academic Session 2025-26 is yet to be decided by the University for the programmes of study, it emerged that the University component of the fee will be communicated to the college after it is finalized for the Session 2025-26. However, the college may decide the other components of the fee structure as per the University Notification dated 02.08.2022.
- The request of Director, Institute of Home Economics (IHE) for refund of the DUSU fee was discussed in the meeting as the student enrolled with IHE are not members of the DUSU.  
  
The committee, after due deliberations, recommended that the Director, Institute of Home Economics may not charge DUSU fee with effect from the next Academic Session. However, it was decided that the request for refund of fee may not be considered at this stage.
- The issue of fee disparity among the various colleges of the University as highlighted by an application received from the students of Lady Irwin College through the College Branch of the University was placed in the meeting and it emerged that the fee structure are determined by the respective colleges with the approval of their respective Governing Bodies. Therefore, the college concerned can address this issue in an objective manner based on their fee structure.
