 - c)** In case of any damage which will arise due to all kind of natural calamities at the time of installation, then damage/maintenance of the procurement/installation of **video surveillance with CCTV** (NVR system) for college will be carried out by the firm during the warrant period at his own cost. The repair work to be completed within 15 days after reporting by College. If the firm does not rectify the damage/maintenance work, the action for black listing of firm will be initiated.
 - d)** All supply will be subject to approval by the Principal Bharati College. Supply will be delivered at the college premises (Consignee Location) at the cost of the firm including all taxes as per bid, which will be compared with quality and inspected with ibid specifications. **Damaged or inferior items will have to be replaced by the firm at their cost.** The items should be delivered at Bharati College as per Gem contract. In case of delay or failure, the liquidity charges will be applicable as 0.5% per week.

- d) The bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the bidder will release the indemnify the buyer and consignee against all liabilities arising out of such visit including death or injury, loss or damage to the property, and any other loss, damage, costs, and expenses incurred as a result of such visit.
- e) The Bidder shall not be entitled to hold any claim against buyer for non-compliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.
- f) The Principal Bharati College shall have the rights to terminate the contract in part or in full in any of the following cases:-
 - (i) By giving the contractor notice of 14 days advance without assigning any reason what so ever.

- (ii) The contractor is declared as bankrupt and become insolvent.
- (iii) The contractor utilizing the services of any Indian/foreign agent in getting this contract paying any commission to such individual /company etc.
- (iv) If the contractor assigns or sublets this contract or if the contract or attempted to do so.
- (v) If the contractor or any of his representatives or his employees are guilty of fraud in respect of the contract, directly or indirectly give or promise to give or offer any bribe, gift, loan reward or advantage, or otherwise to any officers or persons in employment of the Bharati College.
- (vi) If the Contractor declines, neglects or delays to comply with any demand or requisition or in any other way fails to perform or fulfill any condition of the contract.
- (vii) In case of difference in cost (lower cost) is observed the principal, Bharati College shall be entitled to recover from the supplier on demand, any extra expense he may put to in obtaining supplies hereby agreed to be supplied/ provisioned from elsewhere in any manner.
- (viii) Seller should ensure material, manual support, ladder and other requirement (if required) is to be managed by him.
- (g) Bidders are required to physically visit the College preferably within 10 days of this Tender's publication to accurately understand the requirements.
- (h) The "SVC" issued by the Competent Authority of Bharati College must be included with the Technical Bid, Failure to include this certificate will result in rejection of the technical Bid.
- (i) **Law:** the Contract shall be considered and made in accordance with the laws of the Republic of India, The Contract shall be governed by and interpreted in accordance with the laws of the republic of India.
- (j) **Non-disclosure of Contract documents:** Except with the written consent of the buyer, other party shall not disclose the contract or any provision , specification, plan, design, pattern, sample or information thereof of any third party.
- (k) **Penalty for Quality Assurance:** In case the contractor fails to commence/ execute the work as stipulated in the contract/ agreement or there is a breach of any terms and conditions of the contract the Bharati College reserves the right to impose the penalty as details below.
