Sub: Revision of UFM Guidelines.

It is stated that Hon'ble Vice Chancellor has constituted the Committee for the revision of Unfair means guidelines. The detail of the Committee is as under.

The Committee members discussed the matter in detail and the following guidelines are proposed. Copy of the same is enclosed.

PROCEDURE: I

- Superintendent /In-charge of the Examination shall initiate the case of UFM/Disorderly conduct of the student and submit to the Examination Branch.
- The Examination Branch of the University shall issue a notice to the concerned Students through email after receipt of the UFM case.
- Student may reply to the notice of his/her of UFM Case within Seven days from the date of issuance of the notice vide email.
- Electronic Device including Mobile Phone seized from the student under UFM, shall be returned to the student after final decision of the UFM case against him/her.
- Based on the Evidence/Material available on record related to the UFM Cases, Examination Branch shall place the case before the Examination Disciplinary Committee (EDC), along with the reply of the student, if received.
- The Penalty so awarded by the EDC in terms of punishment under Clause-II below shall be communicated to the concerned student by the Examination Branch.
- Any student who desires to get the punishment awarded to him/her reviewed; he/she will submit the request addressed to the Hon'ble Vice Chancellor for review
- All the request for review of punishment so awarded shall be placed before the Review Committee.
- The recommendations of the Review Committee shall be submitted to the Hon'ble Vice Chancellor for consideration.
- The Examination Branch shall communicate the final decision of the Hon'ble Vice Chancellor with respect to the review of the punishment awarded to the concerned student.

- Leaving the Examination Room before expiry of half an hour from the commencement of the examination without the permission of the Invigilator/Superintendent of the Examination and/or without signing the attendance sheet.
- 3. Keeping in possession of papers, books or notes; written notes on any material (admit card, old question paper or on any part of the clothes worn by him/her or on any part of his/her body or table or desk); any electronic device (mobile phone, smart watch, blue tooth, micro-scanner, micro-phone one, micro-camera, microspeaker, memory-based modules, Wienable modules, etc.) programmable calculator, the candidate has made actual use of such material or electronic device as unfair means to himself/herself or given assistance thereof to any other candidate during examination.
- 4. The statement of invigilator/superintendent of the examination alone will be considered as evidence along with circumstantial evidence.
- 5. Where the candidate takes assistance or attempts to take assistance from other candidate or any other person or from any book, paper, notes or other material (including exchange of answer book, question paper, admit card, electronic device, unauthorized material, etc.) in answering the question paper during the examination.
- 6. Where the answer book of the candidate show or otherwise established that he/she has received/given any help from/to another candidate in a malafied manner during the examination.

Note:

- (I) Having once made use of UFM or indulged in disorderly conduct in the examination, if the candidate repeats the act/conduct in any examination of the university of Delhi, thereafter, he/she shall be awarded the next higher punishment than the one prescribed for such act/conduct, keeping in view the severity of the act and or the number of times it has been committed.
- (II) Cases of use of UFM or disorderly conduct of the examination, for *charges* not covered by the foregoing provisions shall be decided by the Examination Disciplinary Committee on individual merits basis.
- (III) In case of UFM related with usage of Electronic device or where the evidence has been destroyed by the candidate, the statement of Invigilator and Superintendent of examination will be considered as sufficient evidence.
- (IV) The loss of academic year(s)of a student due to debarring from appearing in examination under UFM punishment will not be included for counting the Span period of his/her respective program/course of study.
- (v) Cases not falling under the ambit of UFM would be taken out of the purview of UFM rules and would be dealt with administratively.

In view of the above, it is requested that the above mentioned UFM Guidelines may be approved.
