The Dean, Faculty of Education, The Dean, Faculty of Music & Fine Arts, the Dean, Faculty of Management Studies, The Dean, Faculty of Open Learning, Prof. S.P. Aggarwal, Principal, Ramanujan College, Prof. Anju Srivastava, Principal, Hindu College could not attend the meeting due to other preoccupations.

After detailed deliberations on the Agenda, the following recommendations were made in the meeting:

#### Program Specific Eligibility of UG and PG programs for admissions for the Agenda 1. academic session 2023-24.

As per decision of the Executive Council in its meeting held on 8.12.2022 admissions in Under-graduate and Post-graduate level will be based on the Common University Entrance Test (CUET)-UG and Common University Entrance Test (CUET)-PG scores respectively. The Program-Specific Eligibility for all UG and PG programs will be based on the merit scores obtained through CUET only.

- (i) The Committee decided that there will no change in Program-Specific Eligibility for Undergraduate programs. The eligibility of admissions 2022-23 will be continued as it is for the academic session 2023-24.
- (ii) For Post-Graduate admissions 2023-24, the Admissions will be based solely on the scores of CUET-PG with following decisions.
  - 1. All candidates will have to appear in CUET (PG) 2023.
  - 2. Admissions will be based only on the scores obtained in CUET (PG) 2023.
  - There will be two categories in Program Specific eligibility. Category-1 will comprise of candidates with Bachelor's/Master's Degree from a recognized University. Category-2 will comprise of candidates with Bachelors in Honours /Bachelors with additional requirements from University of Delhi.
  - 50% seats (along with stipulated reservations) will be for Category-1 candidates. 50% seats (along with stipulated reservations) will be for Category-2 candidates.
  - Supernumerary seats will be as per past practice.
  - Since all admissions will be based on the merit obtained in CUET, it is advisable to keep the Program-Specific eligibility simple, inclusive, minimal and with no priorities.
  - Relaxations in minimum eligibility will be as per the University norms.

- 8. Candidates appearing in the qualifying degree examination are also eligible to appear in the respective Entrance test.
- 9. Candidates must have passed the qualifying examination/ Program Specific Eligibility at the time of Admissions.
- (iii) The program-specific eligibility for various Postgraduate programs was placed before the Committee and finalized as per details given in the Annexure-1.
- (iv) Along with Program-Specific eligibility, the respective CUET Test-paper as per the requirements of the Program were also decided as recommended by the respective departments. The final CUET Test Papers code may differ as per NTA. The Competent Authority was authorized to decide in this matter.
- (v) Regarding the matter of admissions to PG Diploma Cyber Security and Master of Physiotherapy in Amar Jyoti Institute, it was decided that the matter may be discussed with the Competent Authority and appropriate decision may be taken.

### Agenda 2. UG Admissions in NCWEB and School of Open Learning

It was decided that there shall be no change in the procedure of UG Admissions in NCWEB and School of Open Learning for the Academic year-2023-24.

### Agenda 3. PG Admissions in NCWEB and School of Open Learning

It was decided that the admissions in PG Courses in NCWEB shall be done through CUET Score whereas in School of Open Learning it shall be completed through merit basis as per DEB guidelines that states that Common University Entrance Test (CUET) is not applicable for admission to any ODL and Online programmes being offered at any level.

#### Agenda 4. Issuance of Minority Certificate

It was decided that for the candidates belonging to the Minority category, the certificate containing details of the Minority Status of the candidate issued by any Government Institution/Local Municipality/ Panchayat/ Education Board/ School Leaving Certificate including certificate issued by Delhi Sikh Gurudwara Management Committee (DSGMC)/ Delhi Minorities Commission (DMC) / Baptism Certificate/ Church membership certificate, as applicable, will be accepted.

The Standing Committee authorized the Hon'ble Vice Chancellor, University of Delhi to modify/amend any of the recommendations/decisions, in the larger interest of the candidates.

- 5. The Committee considered the recommendations of the Medical Courses Admission Committee (MCAC) for Postgraduate admissions (MD/MS/ Diploma and MDS) held on 23.07.2022 and 22.08.2022 which has approved the eligibility conditions and Bulletin of Information for admission to Postgraduate (MD/MS/ Diploma and MDS) courses for the session 2022-23 and resolved to approve the same.
- 6. The Committee considered the recommendations of the Medical Courses Admission Committee (MCAC) for admission in Undergraduate (MBBS/BDS) held on 09.09.2022, 16.09.2022 and 30.09.2022 which has approved the eligibility conditions and Bulletin of Information for admission to undergraduate (MBBS/BDS) Courses for the session 2022-2023 and resolved to approve the same.
- 7. The Committee considered the recommendation of the Homeopathic Medical Courses Admission Committee (HMCAC) for UG Course (BHMS) in its meeting held on 14.11.2022 and 21.11.2022 which has approved the eligibility condition for admission to Undergraduate (BHMS) Course for the Academic Session 2022-2023 and resolved to approve the same.

The Committee considered the recommendation of Joint Admission Committee of Ayurvedic and Unani Medicines for Undergraduate Courses (BAMS/BUMS) in its meeting held on 31.10:2022 and 14.11.2022 which has approved the eligibility condition for admission BAMS/BUMS courses for the academic session 2022-2023 and resolved to approve the same.

The Committee considered the recommendation of Joint Admission Committee (JAC) of Ayurvedic and Unani Medicines for Postgraduate Course (MD/MS) (Ayurveda & Unani Medicines) courses in its meeting held on 21.12.2022 which has approved the eligibility condition for admission to Postgraduate (MD/MS) (Ayurveda & Unani Medicines) courses for the academic session 2022-2023 and resolved to approved the same.
