The Executive Council was informed about the result of election of members to the Executive Council as per the provisions of **Statute 5(1)(xi)** of the Statutes of the University. The election was held on 09<sup>th</sup> February, 2023 and the counting took place on 10<sup>th</sup> February, 2023. The summary of result is as under:

**STATUTE 5(1)(xi)**

1. Mr. Sunil Kumar Sharma, Associate Professor, Dyal Singh College (Morning) secured 3482 votes and crossed the Quota in the first round of the counting itself and was declared elected.
2. The surplus of Shri Sunil Kumar Sharma was distributed, following which Dr. Seema Das also crossed the Quota as the total value remained 310661 (249600 of the first round and 61061, surplus of Shri Sunil Kumar Sharma) and was declared elected.
3. Dr. Deo Kumar, Associate Professor, Rajdhani College could not cross the Quota and remained unsuccessful.

The Council expressed condolence on the sad demise of Prof. Ashok Kumar Prasad who left for untimely heavenly abode on 08<sup>th</sup> February, 2023. Prof. Ashok Kumar Prasad was the Head, Department of Chemistry, Dean, Faculty of Science and Member of the Executive Council of the University when he left for heavenly abode at the age of 62 years. He did his PhD from University of Delhi in the year 1990 in the area of synthesis of Bioactive Polyphenolic Nature Products.

After spending about a decade as post-doctoral fellow / visiting Scientist at various prestigious institutions of the world, Dr. Ashok Kumar Prasad joined the Department of Chemistry as Reader in September, 2001 and subsequently became Professor in June, 2009. He was member of various National and International Professional societies.

Prof. Ashok Kumar Prasad was an excellent teacher and outstanding researcher, who contributed enormously to the field of Bio-organic Chemistry.

The Executive Council observed two minutes silence as a mark of respect for the departed soul.

1. The Executive Council in its 1261<sup>st</sup> meeting held on 30.5.2022 considered the common judgment passed by the Hon'ble Supreme court of India on 10.5.2022 in the matters related to CPF/GPF in respect of category -I (N.C. Bakshi batch) and Category-II (Shashi Kiran Batch) and resolved to implement the order dated 10.5.2022 of Hon'ble Supreme Court of India vide **E.C. Resolution No.4 of 30.5.2022**.
2. As resolved in the Executive council, a detailed directive have been issued to all the colleges to process the case files of the retired employees those who falling under category-I and Category-II and to forward the same to the University for fixation of pension vide University letter **No.Fin./Pen.Cell/CPF-GPF/SLP/2022 dated 06.06.2022**.
3. The decision of the Executive Council for implementation of Hon'ble Supreme court of India order dated 10.5.2022 has also been intimated to the Secretary, Ministry of Education, Govt. of India and the Secretary, UGC vide letters dated 4<sup>th</sup> June 2022.
4. The Ministry vide letter **No. F.No.4-9/2017-CU. II dated 20<sup>th</sup> December 2022** intimated that the matter has been taken up with Department of Expenditure which vide I.D. Note dated 20.12.2022 has communicated that the Department agrees to the proposal considering the fact that the Civil appeal arising out of SLP file in the case has been disposed of in favour of employees of Delhi University by Hon'ble Supreme Court in its judgment dated 10.5.2022. It is therefore requested to take necessary action to implement the above-mentioned judgment for the employees of Delhi University.
5. An excerpt of para 5 of the "Status Note on National Litigation policy of the Govt. of India" which was reflected in the agenda item in para-7 of the Executive Council meeting held on 30.5.2022 is as under:

*"In its 126<sup>th</sup> Report on "Government and Public Sector Undertaking Litigation policy and Strategies", the Law Commission expressed the need of having a Litigation Policy to avoid litigation or reduce it at any cost which will bring down the load on the court system resulting in reduction of expenses on judicial set up".*

6. In the light of above (sl.No.5), as deliberated and resolved the Executive Council in its 1261<sup>st</sup> meeting held on 30.5.2022 to implement the Hon'ble Supreme court of India order dated 10.5.2022 to the **non-litigants also since the number employees both in service as well as retired falling under Category-I and Category-II are substantial**.
7. Accordingly, the details of case files received from the various colleges and Establishment section of the University as on 1.3.2023 and the status of which are as under:

8. It could be seen from the above (Sl. No.5) that about 94% of the case files received from various Colleges have been processed and approval of the University has already been communicated to the respective colleges. The disbursement of pension to the pensioners is within the ambit of the Colleges as the colleges are receiving grant directly from the respective funding agencies.
9. With regard to the cases pertaining to the employees of the University Department, it is to submit that about 80% case files received from the Establishment have been finalized and their pension along with arrears of pension has been released.
10. In this connection it is pertinent to submit that the employees who have joined in the University/ College services prior to 1.1.2004 and retired on or after 1-2-1999 with CPF benefits have been considered under the GPF/Pension scheme since the opportunities were given by the University to switch over from CPF to GPF from time to time during the period from 1989 to 31.1.1999 and not falling under the scope of court of order.
11. It is further to submit the case files of the retired employees those who falling under category-I and Category-II which has been processed includes the employees who have retired on superannuation, Family pensioners and retired under VRS. The case files of the family pension & VRS have been processed as stipulated in the DoP&PW O.M.No.4/1/87-PIC dated 1-5-1987 read with Rule under 54 of CCS (Pension) Rules 1972 & Rule 50 of CCS (Pension) Rules 2021 and rule under F.R 56 read with Rule 48-A of CCS (Pension) Rules 1972.
