All the interested applicants fulfilling the criteria may submit application form on or before **Friday, 31st October 2025 at 05.00 pm** in the office of W.U.S. Health Centre.

1. Mode of Selection : By interview (the applications shall be scrutinized and interview shall be held at University of Delhi).
2. Last date of submission of application is **31st October 2025 upto 05.00 pm.**
3. Scope of work : Morning (08.00 am to 02.30 pm)/Evening (01.30 pm to 08.00 pm)/Night (08.00 pm to 08.00 am)
4. Duly completed applications in all respect (alongwith all supporting documents) must reach office of W.U.S. Health Centre by **31st October 2025 upto 05.00 pm.** Incomplete applications or application received late shall be summarily rejected.

The terms & conditions are as under:

- i. The engagement of Retired-Government Doctors as Medical Officer on contract basis shall be against the vacant sanctioned post.
- ii. The amount of monthly consolidated remuneration / fee in the case of retired government officials appointed as consultant shall be last pay drawn minus pension without applicable Dearness Allowance. His / her engagement as consultant shall not be considered as a case of re-employment.
- iii. The retired employee is required for undergoing medical examination. The engagement will be given only after the candidate is found medically fit.
- iv. The engagement can be terminated at any time (on either side) by giving one month's notice or by paying one month consolidated amount, without assigning any reason.
- v. The engagement of consultant will be initially for a period of six months or till regular appointment, whichever is earlier. However, it can be extended further subject to the satisfactory performance of the Doctor. The total period of engagement as consultant should not exceed five years. In no case the consultant should be allowed beyond 5 years. The maximum age limit of engagement shall be upto the attainment of age of 70 years.
- vi. The consultants shall not be entitled to any allowance such as House Rent Allowance, Reimbursement of call charges of residential telephone / mobile, transport facility, residential accommodation, personal staff, etc.

- vii. No government vehicle shall be provided to the consultants.
- viii. Consultants shall be eligible of 1.5 days of leave for each completed month of contractual service. Accumulation of leave beyond a term of contract may not be allowed. Therefore, a consultant shall not draw any remuneration in case of his / her absence beyond 9 days in six months. Also unavailed leave in a calendar year can not be carry forward to next calendar year.
- ix. The engagement of consultants is of a temporary nature and the engagement can be cancelled at any time by the department without assigning any reason.
- x. These retired employee shall not be entitled to LTC for the duration of the contract.
- xi. The appointee shall not be entitled to any TA/DA for interview / medical / joining.
- xii. The retired employee will not be entitled for leave of any kind for study during the contract period.
- xiii. The appointee shall bear full responsibility of the work as prescribed in the duties. In addition, he/she will also be required to discharge the duties as and when required by any authority so authorized.
