The Committee apprised that the contractual employees are working in the University and the Provident Fund officials are regularly pursuing to provide EPF Scheme to these contractual employees. To avoid any legal complications for non implementation of EPF Scheme, after due deliberations, the Committee unanimously considered to adopt and implement EPF Scheme of Govt. of India as amended from time to time for the contractual employees of the University of Delhi with effect from October 2024.

October, 2024 with an annual increase of 5% effective from 1st April every year. The other terms and conditions of appointment remain unchanged.

- 09/2 The Committee noted the MoE letter No. F.No.4-9/2023 - CU.II dated 26th September, 2024 in respect of notional increment and re-fixation of pensionary benefits in respect of retired employees of Delhi University.

As per aforesaid letter, "University of Delhi is a statutory autonomous organization established under an Act of Parliament and governed by the DU Act, 1922 and the Statutes and the Ordinances made there-under. All administrative and academic decisions are taken by the University with the approval of its statutory bodies such as EC, AC, and Court"

Accordingly, the Finance Committee considered and approved the grant of Notional Increment to retired employees of the University who retired on 30th

June/31st December respectively and recommends for approval of the Executive Council of the University.

The decision so taken by the Statutory Bodies of the University may be sent to the UGC for approval.

09/3 According to MoE letter No. F.No.4-9/2023-CU.II dated 26th September2024, "University of Delhi is a statutory autonomous organization established under an Act of Parliament and governed by the DU Act, 1922 and the Statutes and the Ordinances made there-under. All administrative and academic decisions are taken by the University with the approval of its statutory bodies such as EC, AC, and Court".

The FC considered and approved the extension of O.M. No.57/03/2022-P&PW (B)/8361 dated 26th October, 2022 issued by DoP&PW, Govt. of India to the University of Delhi for availing benefits under Old Pension Scheme on death of Government servant covered under National Pension Scheme during service and recommends for the approval of the Executive Council. The decision has been taken to avoid unnecessary litigation in the matter.

The decision so taken by the Statutory Bodies of the University may be sent to the UGC for approval.
