The Faculty after a detailed discussion approved the following partial amendments in the UG (MBBS) Ordinance 2019 onwards which would be applicable for all the batches 2019 onwards from the academic session 2023 onwards:



Subject: - Competency Based Medical Education Curriculum (CBME) Regulations, 2023- National Medical Commission.

Under Graduate Medical Education Board invited comments on draft Competency Based Medical Education Regulation 2023 vide Public Notice of even no. dated 23/06/2023.

2. After consideration of comments received, in exercise of powers conferred by the National Medical Commission Act, 2019 and particularly by sections 10, 24, 25, and 57 of the said Act, Under Graduate Medical Education Board publishes the Competency Based Medical Education Regulation 2023.

3. Regulation shall be effective from the date of its publication i.e.; 01/08/2023.

- For Practical /Clinical examinations, there shall be at least four examiners for every learner, out of whom not less than 50% must be external examiners. Of the four examiners, the senior-most internal examiner shall act as the Chairman and coordinator of the whole examination programme so that uniformity in the matter of assessment of candidates is maintained.
 - A University having more than one college shall have separate sets of examiners for each college, with internal examiners from the concerned college. External examiner may be from outside the college/ university/ state/ union territory.
 - There shall be a Chairman of the Board of paper-setters who shall be an internal examiner and shall moderate the questions.
 - All eligible examiners with requisite qualifications and experience can be appointed internal examiners by rotation in their subjects.
 - All theory paper assessment should be done as central assessment program (CAP) of concerned university.
 - Internal examiners shall be appointed from the same institution for unitary examination in the same institution. For pooled examinations at one centre, the approved internal examiners from same university may be appointed.
 - The Examiners for General Surgery and allied subjects as well as for General Medicine and allied subjects, shall be from General Surgery and General Medicine respectively.
 - There shall be no grace marks to be considered for passing in an examination.

ENTLY ASKED QUESTIONS RELATED TO CBME COURSE CURRICULUM

FAQs are in the nature of explanation for ease of understanding of the general public and cannot be upheld in a court of law. Please refer to the relevant Guidelines for legal validity.

Q1. Since when will these guidelines be applicable?

These guidelines are applicable since the date of publication i.e. from 1st August, 2023.

Q2. To whom are these guidelines applicable?

These guidelines are applicable for all stake holders, i.e. for every student of every batch admitted to MBBS course since 2019, presently pursuing MBBS course in a medical college/institution which is under the jurisdiction of NMC.

Q3. Whether a student can appear in the supplementary examination, if the attendance is inadequate at the time of annual examination?

No, if the student's attendance is less than 75% for theory and less than 80% for practical/ clinical training, the student cannot appear in supplementary examination following the regular annual examination. Such student is required to take classes with junior batch commencing in the next academic year to compensate for his attendance deficit, especially the course, he has missed. He will be eligible to appear in the examination in the next academic year only.

However, before the commencement of annual examination, the college authorities may arrange for additional classes to compensate for attendance deficit. It shall be at the discretion and purview of the college authorities to arrange for making up deficiencies.

Q4. Can a student be allowed to join the classes of the next academic year after appearing for the annual examination?

For 1st MBBS examination: Second MBBS classes/ clinical or practical training shall not start till the results of 1st MBBS are declared. Student shall only be allowed to join 2nd MBBS if he has successfully passed in all subjects in annual/ supplementary examination of 1st MBBS.

For 2nd MBBS: A candidate, who fails in the second Professional examination, shall be allowed to join the third Professional Part I training, however he shall not be allowed to appear for the examination unless he has passed second professional examination.

For Final MBBS: A candidate who fails in the third Professional (Part I) examination shall be allowed to join third Professional part II training, however he shall not be allowed to appear for the final examination/NExT unless he has passed final first professional examination.

Q6. What is the total course duration permitted for MBBS training?

Every student is required to undergo a minimum period of study extending over 4 ½ academic years, divided into four professional years from the date of commencement of course to the date of completion of examination which shall be followed by one year of compulsory rotating medical internship.

The maximum total duration of MBBS course permitted to complete the MBBS course, is ten (10) years including the period of Compulsory Rotating Medical Internship (CRMI).

Maximum permitted duration for completion of Internship is 2 years. This is applicable for all MBBS students admitted in 2019 and thereafter.

Q7. How are the 4 attempts/4 years counted for first year MBBS students?

No student shall be allowed more than four (04) attempts for first year (First Professional MBBS). In these four years, the maximum number of attempts permitted shall be four (4) which include supplementary examination also.

Q8. What if a candidate fails complete MBBS Course or mandatory Internship (CRMI) within a stipulated time limit?

If a candidate fails to qualify/complete the course / internship in prescribed time limit, he shall not be allowed to continue the MBBS Course under any circumstances.

Q9. How many marks have to be allotted for MCQ in the annual examination?

The maximum marks to be allotted for MCQ in the annual examination shall be 20. It shall be at the discretion of the University to work out the details.

Q10. What will be the marks required for theory examination for passing in the annual examination if there are two papers for a given subject?

The aggregate or sum-total of theory and practicals for a given subject shall be at least 50% to declare a student as having successfully cleared a subject, i.e. passed in a subject. However, the minimum score in theory/ practical examination shall be at least 40% of the allotted marks.

E.g., if the maximum allotted marks are 100, the student shall have to score at least 40 marks out of 100. When there are two papers of 100 marks each, the sum total of two

papers shall be 40%, which means that a student has to score a sum-total of 80 marks in both papers out of 200, to be declared as having passed in the subject; provided he scores at least 60% in practical examination. Vice versa shall also be applicable.

Q11. Will there be any grace marks in university examination?

There shall be no grace marks in the university examination.

Q12. How many examiners shall be required to be appointed for annual examination?

Each student shall be examined by a set of four examiners, 2 internal and 2 external. Thus even if a supplementary examination is to be conducted for small number of students, 4 examiners are mandatorily required for the student's evaluation/ performance.

Q13. Do the external examiners have to be from outside the university or can they be appointed even if they are from the same university?

Any faculty who is not from the college where the students are to be examined, shall be treated as external, even if he is from the same university. However, if possible, examiners from outside the university and preferably from outside the state may be appointed as external examiners. This shall widen the horizons of students and examiners and students across the whole country shall be evaluated more equitably.

Q14. Whether the non-medico faculty members (without MBBS/MD/MS Qualifications) can be appointed as examiners?

No. Only MBBS faculty with required qualifications mentioned in guidelines shall be eligible to be appointed as examiners for UG examination at all stages, i.e. both internal examination and final university examinations.

Q15. From which batch is the family adoption program mandatory?

Family adoption program through village outreach is mandatory from MBBS batch admitted in the year 2023-24. Those batches who have introduced FAP shall assess the students as per the assessment module displayed on the website. It is mandatory for all colleges to follow the guidelines mentioned in family adoption program.

Q16. Whether a student can take transfer/migration from one medical college to another medical college?

No student once designated to a Medical Institution shall be allowed to seek transfer/migration to any other Medical Institution under any circumstances.

Subject: Clarification in regard to "Competency Based Medical Curriculum" (CBME) Regulations, 2023.

Dear Sir,

With reference to your letters Ref. No. MUHS/X-1/8262/ 2023 dated 28.12.2023 and 08.09.2023 regarding seeking comments on "Competency Based Medical Curriculum" (CBME) Regulations, 2023. In this regards, comments on the following points are submitted as under:-

1. "Competency Based Medical Education Curriculum" (CBME) Regulations, 2023 is published on 01.08.2023. Therefore, it is anticipated that said Regulation is applicable with effect from the Batch of students admitted to 1st year MBBS Program in academic year 2023-24 and onwards.
- The academic calendar year of every batch published from time to time is to be followed for CBME curriculum accordingly.
- 2) Further, you are requested to illuminate whether Grace Marks are applicable for older batch of MBBS students (i.e. 2019, 2020, 2021 & 2022) or for only those admitted in academic year 2023-24 and onwards.
- No Grace Marks will be given to any student appearing in any examination conducted after the publication of these regulations and MSR-2023 guidelines published on 16 Aug, 2023.
- 3) You are further requested to guide whether the Internal Assessment shall be considered as separate head of passing for University Examination or not.
- Internal Assessment will not be counted as separate head of passing for University Examination. However, the student has to be declared

as eligible to appear for the University Examination based on the Internal Assessment made by the college authorities (formative and summative).

4. The supplementary Examination is applicable for all years (i.e. 1st to final year MBBS) or only for 1st year MBBS.

- Supplementary Examination is applicable for all years.

5) The students admitted in 2019 batch are pursuing their final MBBS, and students admitted in 2020 Batch are pursuing their Third (I) MBBS and 2021 Batch are pursuing their second MBBS.

a) Will the Phase-wise duration of 12 months and 18 months be applicable to these batches.

- Phase-wise duration will be followed as per the academic calendar of respective batches.

b) is the clinical posting schedule provided in CBME Regulations, 2023 is applicable to these batches.

- Clinical posting schedule shall be followed as given for each batch.

c) Will the internal assignment scheme provided in the CBME Regulations, 2023 is applicable to these batches.

- Internal assignment scheme may be made applicable from 2023-'24 batch.

d) Will the passing criteria of 50% aggregate in theory and practical in University exam and 40:60/ 60:40 scheme and 40% in theory (both papers together) be applicable to these batches.

- Passing criteria of 50% aggregate in theory and practical, (and minimum 40% in each, to achieve aggregate 50 %) , shall be applicable from the date of publication of the regulations and guidelines.

e) Will the appointment of examiners (Medical post graduate degree after MBBS) as per criteria mentioned in CBME Regulations 2023 be applicable to these batches.

- Appointment of examiners as per the criteria mentioned in CBME Regulations 2023 shall be applicable to all batches who go for examination after the publication of these guidelines and regulations

f) Will the Competency distribution of AETCOM Module for training and assignment mentioned in the Annexure be applicable to these batches or only for those admitted in the 2023-24 and onwards.

- AETCOM Module for training and assignment mentioned in these Annexure shall be applicable to 2023 Batch onwards. The previous batches shall be following AETCOM Module designed for them.
