02/ At the outset, the Registrar read out the following welcome note, introducing and welcoming Professor Yogesh Singh who had joined as Vice-Chancellor of the University of Delhi on 08.10.2021:

It is indeed an honour to inform the Council that Hon'ble Visitor (The President of India) has appointed Professor Yogesh Singh as the Vice Chancellor of the University of Delhi. Professor Yogesh Singh assumed the charge of the Vice Chancellor on 8th October, 2021 (A/N). Prior to that he was the Vice Chancellor of Delhi Technological University and had previously served as the Director of Netaji Subhas Institute of Technology, Delhi (December 31, 2014 to July 24, 2017) and Vice Chancellor of Maharaja Sayajirao University of Baroda, Gujarat (July 07, 2011 to December 29, 2014). Government of Gujarat had given him the second term of Vice Chancellor, Maharaja Sayajirao University of Baroda, which he continued up till December 29, 2014.

He received his M.Tech. (Electronics & Communication Engineering) and Ph.D. (Computer Engineering) degrees from National Institute of Technology, Kurukshetra, Haryana. He has supervised 23 Ph.Ds in the area of Software Engineering. He has more than 250 publications in International and National Journals/Conferences.

He wrote a book on "Software Testing" published by Cambridge University Press, England (2011). He has also co-authored books on Software Engineering published by New Age International Delhi (2002), and Object Oriented Software Engineering published by PHI Learning, Delhi (2012). Prof. Yogesh Singh participated in YALE-INDIA LEADERSHIP PROGRAMME in Yale University, USA (2011).

He is a member of the Executive Committee of National Assessment and Accreditation Council (NAAC) with effect from October 03, 2019. He is also an independent Director of Gujarat State Petro Net Ltd. and Gujarat State Petroleum Corporations Ltd. (Government of Gujarat Undertakings) since May, 2013 and March, 2015 respectively. He is appointed as the Additional

Director (Non-Executive, Independent Director) on the Board of Director of Gujarat Gas for the tenure of 5 years w.e.f. from 15 August, 2021. Prof. Yogesh Singh is the Chairman of Governing Board of Information and Library Network (INFLIBNET) Centre, Gandhinagar, an Autonomous Inter-University Centre (IUC) of University Grants Commission, New Delhi (Ministry of Education, Govt. of India).

Prof. Singh was the Chairman, Central Regional Committee, All India Council for Technical Education, Bhopal (covering States of Madhya Pradesh, Chhattisgarh & Gujarat) from December 2011 to May 2014. He was member of the General Council of National Assessment and Accreditation Council (NAAC) and was also the member of the Governing Council of Association of Indian Universities.

He has served as Dean, University School of Information Technology (2001-2006), Controller of Examinations (2006-2011) and Director Students Welfare of Guru Gobind Singh Indraprastha University, Delhi.

On behalf of the University Court, I have the privilege and honour to welcome Professor Yogesh Singh as the Vice-Chancellor of this University and as the Chairman of the University Court as per the provisions of Statute 2(1)(iii).

Prof. Vanita Tripathi

Prof. Vanita Tripathi passed away on 31st August, 2021.

Prof. Vanita Tripathi joined the Department of Commerce, Delhi School of Economics as Assistant Professor in 2004 and thereafter completed her doctoral degree in the year 2005 from the Department of Commerce, Delhi School of Economics, University of Delhi. She was appointed as Associate Professor in Department of Commerce, Delhi School of Economics in 2011 and in the year 2015 she became Professor in Department of Commerce. Prof. Vanita Tripathi was the recipient of many prestigious Academic Awards and distinctions in her field. She has completed several Research Projects in the field of finance and published several books, research papers and articles among others.

Prof. Bhairabi Prasad Sahu

Prof. B.P. Sahu passed away on 3rd March, 2022.

Prof. Sahu was a distinguished alumni and faculty of the Department of History. He started his academic career as a Lecturer in the Sri Venkateshwara College, University of Delhi in the year 1983 and obtained his doctorate degree in the year 1985. He was appointed as a Professor in Department of History in the year 1985.

As an ethically committed academic administrator, Prof. Bhairabi Prasad Sahu left his mark as the Head, Department of History, University of Delhi from 2004-2007, Dean, International Relations, University of Delhi (2007-11) and Dean, Examinations (2011-12). He published ten books and over fifty research articles on wide ranging themes on the history of ancient and early medieval India with special reference to Odisha. His Research and specialization field was Historiography, Political Processes and Structure of Politics in Pre-modern-India, Society and Economy in Ancient and Early Medieval India among other such areas.

Prof. I.S. Marwah

Prof. I.S. Marwah passed away on 21st February, 2022.

Prof. I.S. Marwah joined Department of Anthropology as Lecturer in the year 1967 and promoted as Reader in the year 1983 and Professor in the year 1993. Prof. Marwah served the department for more than 36 years. Before joining the Department he held the position of Anthropologist at the Government of India's Tribal Orientation and Research Center, Udaipur. He published in some of the best known journals of the discipline and was highly respected for his scholarship and commitment to academics. He had undertaken a pioneering study on the

cultural change among the Meos of Haryana. He was also awarded with the Teachers Fellowship at the Center for Advanced Studies in Sociology in 1976-77.

Prof. Jitendra Paul Khurana

Prof. Jitendra Paul Khurana passed away on 27.10.2021.

Prof. Jitendra Paul Khurana obtained his B.Sc degree from University of Delhi in the year 1973 and M.Sc from Kurukshetra University in the year 1975. He completed his Ph.D. in the year 1982. Following a short stint as Scientist at University of Delhi from the year 1983 to 1985, he joined as a post-doctoral fellow, first at Smithsonian Institution, Washington D.C., USA from the year 1985 to 1986 and then at Michigan State University, USA from the year 1986 to 1988. He joined University of Delhi as an Associate Professor in Department of Plant Molecular Biology in the year 1988 and promoted as Professor in the year 1996. Under his supervision, 30 students were awarded Ph.D and 10 students were awarded M.Phil.

The significant research achievements of Prof. Khurana include

- chromosome-based sequencing of the wheat genome,
- squencing, assembly and annotation of tomato genomes, sequencing
- assembly of rice chromosome 11
- · identification of a large number of hormone-inducible genes in rice plants

Prof. Khurana served as Director, University of Delhi South Campus and Pro-Vice-Chancellor (Interim), University of Delhi from 2016-2019. He also served as Dean of Colleges, University of Delhi (2018-2019). Prof. Khurana also served as member of the Academic Council (1995-1998; 2001-2004; 2013-2016); Dean, Faculty of Inter-disciplinary & Applied Sciences (2014-2015); Chairman, Board of Research Studies, FIAS, UDSC (2003-2006; 2014-2015); Head of the Department (1995-1998; 2001-2004; 2014-2016); Coordinator (UGC-SAP, DRS; 2002-2007; 2007-2012; 2013-2018) and Director, Interdisciplinary Centre for Plant Genomics (ICPG), University of Delhi (2009-2019).

Prof. Khurana superannuated from active service at University of Delhi on 31.10.2019.

Prof. Debu Chaudhuri

Prof. Debu Chaudhuri passed away on 1st May, 2021.

Padma Bhushan Pandit Devabrata Chaudhuri, Popularly known as Pt. Debu Chaudhuri or 'Debu da', was an internationally famed Sitar maestro. Born 30th May, 1935, he received his early training from the late Pt. Panchu Gopal Datta and later from the legendary Sitar maestro - Ustad Mushtaq Ali Kha, of the Senia Gharana for a long period of 38 years. He made his public deput at the age of 13 and his first broadcast for All India Radio was broadcast in the year 1948. This he was associated with it for more than 70 years. He was an accomplished artiste with several notable performances across all the globe.

He was the creator of eight new ragas, such as Bisweswari, Kalyani Bilawal and Prabhati Manjari etc. and also authored eight books.

Pt. Debu Chaudhuri was one of the founding fathers of the Deptt. of Music, University of Delhi, that was established in 1960 and had the unique distinction of being the Dean & Head, Faculty of Music & Fine Arts, University of Delhi on three occasions He superannuated in the year 1999.

Prof. Prateek Chaudhuri

Prof. Prateek Chaudhuri passed away on 07th May, 2021.

Prof. Prateek Chaudhuri was born on 7th September, 1971 in a respected music loving family of Pt. Debu Chaudhuri. He completed his Master's Degree in the year 1994 and Ph.D. in the year 2001 from the Faculty of Music and Fine Arts, University of Delhi. He was one of the outstanding names in the field of Hindustani Classical Music. He was bestowed with several distinguished awards for his outstanding contribution in the field of Music and fine Arts such as Sangeet Ratna Award, Delhi State Award, Yuva Ratna Award among others.

A Sitar Exponent of International repute and Eminence of the country. Graded as a "Top Grade" Artist of the country by the All India Radio and Doordarshan, Govt. of India. Graded as an "Outstanding Artist" by the Ministry of Culture, Govt. of India and as also as an "Outstanding Artiste" of the country by the Indian Council for Cultural Relations. He was a Professor in the Faculty of Music & Fine Arts of the University at the time of his sad demise. Under his guidance, 05 students were awarded Ph.D. and 09 students were awarded M.Phil. He published several books, articles, presented papers and attended several conferences as a part of his academic endeavour.

Prof. Vinay Gupta

Prof. Vinay Gupta passed away on 09th May, 2021.

Prof. Vinay Gupta completed his post graduation in the year 1989 and Ph.D. in the year 1995 from Department of Physics and Astro-Physics of the University of Delhi. He started his career as a Lecuter in Deen Dayal Upadhyaya College of the University in the year 1995. Prof. Vinay Gupta joined the Department of Physics and Astro-Physics of the University as a Reader in the year 2003 and was promoted as a Professor in the year 2009. He was the Dean (Examinations) of the University for more than 04 year w.e.f May, 2016. His area of specialization were Electronics Materials and Devices. Under his able guidance 20 students were awarded Ph.D. and he was a mentor to 18 post-graduate fellows among others. He had, to his credit, around 500 publications and applied for several patents as technology breakthrough. He has held several distinguished positions in various scientific bodies like the DRDO, DST, IUAC among others.

Prof. K. K. Sharma

Prof. K. K. Sharma passed away on 15th May, 2021.

Prof. K. K. Sharma was an excellent academician and an able administrator. He joined University College of Medical Sciences (UCMS) in the year 1976 and went on to become Professor in the year 1987. He has held the position of Head, Department of Pharmacology. He served for approximately 34 years at UCMS.

Prof. Sharma was awarded Travel Fellowship Award in 1984; Indo-USSR Cooperation in Medical Sciences Research Award in 1988; Distinguished Teacher Award from UCMS Alumni Association in 1994; Sir Shriram Memorial Oration Award in 2004-2005; Dr. Govind Achari oration Award by Indian Pharmacological Society in 2005-2006 and Dr. Y. K. Gupta oration Award by KG Medical University in 2011-2012.

Prof. Sharma has served the National Academic of Medical Sciences as the Council Member and Chairman of the Academic Activities and CME Co-ordinator and the Editor of the Annals of National Academy of Medical Sciences.

He superannuated from the University services on 30thApril, 2010.

Prof. Arun Goval

Professor Arun Goyal passed away on 28th August, 2021.

Professor Goyal, an excellent academician and an able administrator, joined the Department of E.N.T. (Oto-Rhino-Laryngology) in the year 1995 and was promoted as Professor and redesignated as Director-Professor in the year 2010. He has worked as Head of the Department of E.N.T. He had taken Voluntary Retirement from his services on 26th August, 2021. Prof. Arun Goyal served UCMS for approximately 26 years.

National Assessment and Accreditation Council (NAAC)

The University of Delhi completed the process of assessment and accreditation conducted by the National Assessment and Accreditation Council (NAAC) in the First Cycle in 2018. This accreditation is as per the Revised Framework of NAAC, which was implemented in 2017. The primary focus of the revised framework shifted from qualitative peer judgment only (old framework) to data based quantitative evaluation (70%) and peer judgment (30%).

The University of Delhi was accredited with a CGPA score of 3.28 with A⁺ grade in its First Cycle, which is valid for a period of 5 years from November 30, 2018. This grade is highest among all the Central Universities which have gone through the first cycle of assessment accreditation under the new framework till September 2019.

Institution of Eminence (IoE)

The University of Delhi was recognized as an Institution of Eminence (IoE) by the Ministry of Education (MoE) (earlier Ministry of Human Resource Development), Government of India, vide its communication dated 4th September 2019. The MoE subsequently issued a notification on 2nd March 2020 declaring the University of Delhi as an "Institution of Eminence".

The Executive Council of the University approved three new schools in addition to the existing two, in Ordinance XX under the IoE. The schools have envisaged theme-based multi-disciplinary and interdisciplinary research programmes with national and global relevance. The IoE, along with different stakeholders has identified broad areas of research that are relevant to societal needs and have the potential to catapult the University into higher global rankings through high-quality publications and research collaborations. The Governing Bodies of these Schools comprise distinguished and internationally well-known educationists/academics /researchers/public affairs experts to boost the quality of research output and engagement with various organs of the Society.

The IoE under Faculty Research Programme sanctioned projects to the tune of approximately Rs. 5.00 crores to more than 160 faculty members of the University/Colleges across various disciplines in 2020. The IoE has embarked on strengthening University Science Instrumentation Centre (USIC) at North Campus and Central Instrumentation Facility (CIF) at South Campus to facilitate operations and maintenance of sophisticated instruments and make these available to our researchers for which they had to depend on other institutions/facilities.

The Building Committee of the University has approved the construction of Academic/Administrative Building and hostel cum transit accommodation for IoE to NBCC.

HIGHLIGHTS OF SOME RECENT INITIATIVES AND ACHIEVEMENTS

ESTABLISHMENT OF NEW CENTRES

It has been a continuous objective of the University of Delhi to seek to facilitate the development of new research initiatives that cut across traditional disciplinary boundaries. In line with this broad goal, a new study and research Centre - Centre for Himalayan Studies, was inaugurated by the University:

Centre for Himalayan Studies

The establishment of the Centre was approved on the 8th December 2020 by the Executive Council of the University. The Centre for Himalayan Studies aims to study and conduct research on all aspects of the Himalayas. A Himalayan Museum is also proposed to be established on the campus soon. This Centre will work in collaboration with various national and international organizations, as well as with the people at the grassroots level in the different Himalayan states.

ONEDU Programme

Online teaching and learning have become an integral part of education worldwide owing to the unprecedented pandemic situation. The University of Delhi has also adopted online teaching and 89th Annual University Court/29.03.2022

learning from 2020, whereby students were taught through various online platforms. The OneDU programme is a unique initiative of the University where an amalgamation of several e-learning resources offered by the varsity is made available on a single platform. Guidelines and Protocols were formulated for the smooth functioning of the teaching-learning process during the pandemic. The OneDU platform is aimed at promoting online education across teaching departments, colleges, centres, and other affiliated bodies.

The objectives of OneDU initiatives are:

To formulate protocol for online education for teaching and other academic activities.

To facilitate technical support to the Departments, Colleges, Centres, and other academic bodies of the University.

To suggest implementable best practices in the field of online education and provide other constructive inputs from time to time depending upon operational requirements.

To facilitate the preparation of user-friendly short videos and FAQs to meet the objectives of online education, by identifying resources available in various Departments, Centres, Colleges, and other affiliating bodies of the University.

To identify and encourage faculty members to prepare syllabi-specific e-resources tailor-made for the use of the University community.

The said effort is aimed at empowering the University in its unwavering commitment to impart continuity in academic endeavours.

Vidya Vistar Scheme

The University of Delhi has taken up a special initiative called the Vidya Vistar (V2) Scheme for developing academic cooperative bonding between colleges of the University with colleges of fellow universities, and Departments of the University with the Departments of fellow universities, which are situated in remote areas of the country. The aim of the Vidya Vistar Scheme is to maximize the contribution of higher educational institutions to nation building through optimum utilization of existing resources and potentials. Through this Scheme, the University of Delhi proposes to open its faculties, library, and other academic facilities available in its Departments and Colleges to partner institutions for academic cooperation and collaboration.

The main objectives of V2 Scheme are as follows:

Online/offline lectures, workshops, trainings, meetings, and other such programmes aimed at capacity building of the faculty members of both the institutions will be initiated. To the extent possible, visits of faculties will be facilitated for this purpose.

The teachers and researchers of selected colleges and university departments will be associated in research activities of the departments of the University of Delhi and/or its colleges and will be invited to be co-investigators in the research programmes submitted to funding agencies.

The University will facilitate joint publication by teachers/researchers of University and the selected colleges and University of Delhi departments.

Library resources for providing support in capacity building and for improvement of teaching and research skills of the faculty will be strengthened in selected colleges and University departments.

Mutually beneficial linkages will be forged with partners through various platforms such as Cluster Innovation Centre, Electropreneur Park etc. to initiate and assist innovation activities and boost start-ups.

Feeling of brotherhood will be cultivated among the youth of the two institutions through sports and extracurricular activities.

The bonding envisaged under V2 Scheme is based on the principle of mutual respect, cooperation and sharing between the two colleges of the universities as equal partners. Such symbiotic relation between the two shall enrich both the academic institutions in more ways than what each could achieve solitarily.

MoU with Indian Council for Cultural Research (ICCR)

On 12th January 2021, on the occasion of Swami Vivekananda Jayanti, also celebrated as the National Youth Day, the Indian Council for Cultural Research, Ministry of External Affairs, Government of India, entered into an MoU with the University of Delhi for establishing an ICCR Centre for catering to the needs of the overseas students who come to the University on the ICCR scholarship.

ICCR proposes to conduct various academic, cultural, and extra-curricular programmes to enhance the academic environment and cultural exchange in the University. Furthermore, it plans to facilitate the academic exchange for overseas scholars and teachers and support visiting faculties in the University from overseas academic institutions. The Registrar signed the MoU on behalf of the University in the presence of the Director-General, ICCR, Shri Dinesh Pattnaik. Consequently, on 4th March 2021, Shri V. Muraleedharan, Hon'ble Minister of State for External Affairs, inaugurated the ICCR Centre in the University.

NOTABLE EVENTS/ANNUAL PROGRAMMES

National Unity Day

The University on the occasion of National Unity Day, commemorating the birth anniversary of Sardar Vallabhbhai Patel, organized a programme at Gandhi Bhawan, University of Delhi on 31st October 2020, presided by Prof. P.C. Joshi, Vice Chancellor (Acting). Sarva Dharma Prarthana by Sushri Kusum Behan and Sushri Radha Behan of Gandhi Hindustani Sahitya Sabha, Rajghat, New Delhi, was organized. It was followed by a musical programme on the theme 'National Integrity' by the students of Faculty of Music & Fine Arts, University of Delhi. Pledge taking ceremony was also held during the programme.

MoU with Indian Council for Cultural Research (ICCR)

On 12th January 2021, on the occasion of Swami Vivekananda Jayanti, also celebrated as the National Youth Day, the Indian Council for Cultural Research, Ministry of External Affairs, Government of India, entered into an MoU with the University of Delhi for establishing an ICCR Centre for catering to the needs of the overseas students who come to the University on the ICCR scholarship.

ICCR proposes to conduct various academic, cultural, and extra-curricular programmes to enhance the academic environment and cultural exchange in the University. Furthermore, it plans to facilitate the academic exchange for overseas scholars and teachers and support visiting faculties in the University from overseas academic institutions. The Registrar signed the MoU on

behalf of the University in the presence of the Director-General, ICCR, Shri Dinesh Pattnaik. Consequently, on 4th March 2021, Shri V. Muraleedharan, Hon'ble Minister of State for External Affairs, inaugurated the ICCR Centre in the University.

Conference on National Education Policy 2020

The University of Delhi in collaboration with Shikha Sanskriti Utthan Nyas organized a conference on National Education Policy (NEP) 2020 and its implementation on 15th January 2021. Approximately, sixty Principals of various colleges of the University of Delhi attended the conference. Prof. P.C. Joshi, Vice-Chancellor (Acting), announced the constitution of the 48-member NEP implementation Committee. The Vice-Chancellor of Chaudhary Bansi Lal University, Prof. R. K. Mittal, presided over the conference and shared theplans for implementation of NEP 2020.

97th CONVOCATION CEREMONY

The University organized its 97th Annual Convocation on 27th February 2021. The Hon'ble Minister of Education, Sh. Ramesh Pokhriyal was the Chief Guest and Sh. P. K. Joshi, Chairman, Union Public Service Commission was the Guest of Honour. Prof. P. C. Joshi, Vice-Chancellor (Acting), presided over the function. Prof. Balaram Pani, Dean of Colleges, Prof. Suman Kundu, Director South Campus, and Dr. Vikas Gupta, Registrar graced the ceremony.

For the first time, digital degrees to the tune of 1,78,719 for the year 2020 were conferred online by the Hon'ble Minister of Education. Efforts of the University in resolving the challenges posed by the pandemic, such as conducting Open Book Examination (OBE), issuance of Digital Degrees, etc., were appreciated by the Chief Guest and the Guest of Honour.

The University's Brochure was released which had a dedicated section on Resilience to COVID – 19. The Vice Chancellor, during his address, shared with immense pride that the University has launched the Vidya Vistar Scheme (V2 Scheme) to support institutions in t remote areas. Under the V2 scheme, the University will offer the expertise of the faculty members, library resources and other academic facilities to the partner institutions. Establishment of new Centres of learning – Delhi School of Public Health, the Delhi School of Climate Change & Sustainability, the Delhi School of Skill Enhancement & Entrepreneurship Development were also announced by him

63rd Annual Flower Show

The 63rd Annual Flower Show of the University was organized on 5th March 2021 at the Mughal Garden of the University. The event was inaugurated by Prof. D. P. Singh, Chairman, University Grants Commission, in the presence of Prof. P.C. Joshi, Hon'ble Vice-Chancellor (Acting), Prof. Balaram Pani, Dean of Colleges, Prof. Suman Kundu, Director of South Campus; Dr. Vikas Gupta, Registrar, Shri Girish Ranjan, Finance Officer and other dignitaries of the University. In a first of its kind, programme of the traditional floral splendour of the Flower show was webcasted on the website of the University.

Commemoration of 'Shaheed Diwas'

The University organized a programme to pay homage and to commemorate 90 years of martyrdom of our national icons of the Indian National Movement – Shaheed Bhagat Singh, Sukhdev Thapar and Shivaram Rajguru on 'Shaheed Diwas' on 23rd March 2021.

Homage was paid to Shaheed Bhagat Singh in the Chamber located in the basement of the Viceregal Lodge of the University where he was imprisoned. On this occasion, Shaheed Bhagat Singh Smarak was inaugurated by the Hon'ble Minister of Education, Dr. Ramesh Pokhriyal, virtually. The existing collection of books on freedom fighters in the Bhagat Singh Smarak has been announced to be converted into "Shaheed Smriti Pustakalaya" by the Hon'ble Minister of Education. Tribute was paid to Shaheed Bhagat Singh and his associates through patriotic songs presented by the Faculty of Music. Various competitions - poetry, song, slogan and essay writing were also organized in the colleges of the University.

Webinar on 'Covid-19 and the Challenges of the Visually Impaired'

The University of Delhi organized a three-hour-long webinar on 'Covid-19 and the Challenges of the Visually Impaired' on 27th April 2020, which was presided over by the Hon'ble Vice-Chancellor Prof. Yogesh Tyagi. Since the outbreak of the pandemic, the University which has nearly 3,000 students with disabilities, has been reaching out to such students through various initiatives. Based on the feedback regarding the challenges faced by them, particularly the visually impaired, it was decided to organize a focused webinar on various problems faced by such students during the present unprecedented crisis.

Ms. Shakuntala D. Gamlin, Secretary, Disability Affairs, Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment, Government of India, and Dr. Prabodh Seth, Joint Secretary, Department of Empowerment of Persons with Disabilities, Ministry of Social Justice & Empowerment, Government of India; delivered their addresses in the Webinar. Presentations were also made by Dr. Nachiketa Rout, Officiating Director, National Institute for Empowerment of Persons with Visual Disabilities (NIEPVD), Dehradun and Mr Dipender Manocha, President, National Association for the Blind (Delhi) and Director, Developing Countries Programme, Daisy Consortium, Managing Trustee, Saksham Trust.

SOCIAL OUTREACH

Community Outreach under the Unnat Bharat Abhiyan (UBA) Initiative

The University continued with its efforts to actualize its endeavor to evolve as a "University beyond Campus" and an institution of higher learning that is alive to the critical realities of contemporary times. The Unnat Bharat Abhiyan Initiative of the MHRD is intended to usher in transformational change in community development processes by leveraging knowledge institutions to help build the architecture of an Inclusive India. The University of Delhi has adopted five villages having low socio-economic indicators namely Badarpur Khadar, Chaulian Patti, Jagatpur, Mukundpur and Jharoda; for community development initiatives under the UBA. Since the year 2016, a team of students under the guidance of faculty members have been taking up need based, planned and sustainable community initiatives in the five communities. The teams participate in the joint identification of the problems and felt needs of the particular village; chalk out intervention plans; and then engage in participatory community initiatives to address the same.

Work under this programme continued, albeit with a temporary change in format, arising out of the challenges posed by COVID 19. As teaching-learning shifted to the online mode, and most students shifted to their hometowns, volunteer participation in community work also had to be re-planned. The students and faculty engaged themselves in forming online groups of community members and community leaders to provide online support to three communities during difficult

times. Student volunteers prepared online resource material on government schemes and civil society support and circulated it among the community members through nodal persons such as anganwari workers, ASHA Workers and community leaders. Support and facilitation was also provided to school children to gain access to the online platform for educational attainment. Initiatives in vaccine advocacy were also undertaken to remove and mitigate myths and misconceptions about vaccines and encourage people to get vaccinated.

The UBA Team also initiated training programmes for NSS volunteers with the aim of preparing a cadre of workers to assume community work in the coming times. Seventy students from the colleges of the University were trained in diverse dimensions of participatory and need based community work. Several expert resource persons contributed their input to hold interactive sessions with student volunteers. Captain Parminder Sehgal, the NSS In-charge at the University played an immensely valuable role in facilitating this initiative. Subsequent to the cessation of the deadly second wave of COVID, work in the offline mode was gradually resumed on a limited basis. An afforestation programme was organized in collaboration with a local voluntary organization. Community groups were rejuvenated to enable residents to resume normal life. Work with children on non-formal education, recreation, health and nutrition was resumed. A veterinary camp was organized in response to community needs. Work on dengue prevention and awareness generation on health and sanitation was undertaken. More community participatory programmes are in the process of being planned, after a renewed needs assessment of communities in contemporary times.

RESILIENCE OF UNIVERSITY OF DELHI DURING THE PANDEMIC

The University of Delhi during the Covid-19 Pandemic demonstrated its resilience and adapted itself in accordance to changing circumstances. The University of Delhi was at the forefront to ensure the wellbeing of students and staff members. Several decisive and proactive measures were taken.

A Covid-19 Task Force was constituted on 28th March 2020. The responsibilities of the Task Force were the following:

Carrying out administrative activities in the duration of the lockdown.

Looking after the welfare of the resident students.

Monitoring and coordinating e-learning avenues in order to ensure the continuation of academic learning in an accessible manner.

The University also initiated an online counseling facility for fostering mental health and wellbeing of the students and staff of the University during the pandemic. Another initiative titled "Care for the Neighbours" made provisions of ration packages to vulnerable fellow citizens in the vicinity of the University campus.

During the Covid-19 Lockdown, the University initiated OneDU Programme for promoting online education. The University Library services were updated to give remote access to the complete digital resources through the University VPN and Remote Login. Digital library services were made available to all the users and DULS also facilitated access to books/ articles not available in digital collection by collating from other sources. The DULS also continued plagiarism verification of M.Phil. dissertations and Ph.D. thesis in online mode. The Dean, Students' Welfare (DSW) office organized weekly webinars with TELERANG for skill bridging and up-skilling every Monday from 5.00 p.m. – 6.00 p.m. The event was open to both UG and PG students and around 800 students of the University attended these webinars.

The Hostels of the University also faced an unprecedented situation during the Covid-19 pandemic and several students left the hostels during the lockdown periods. For hostellers, who stayed back and/or could not return home due to lockdown restrictions, all possible arrangements were made to ensure their safety and security. In consultation with the University officials and District health officials, COVID readiness plan was prepared, including rooms for quarantine/isolation ward, continuous sanitation of hostel premises, training of staff and residents about good practices to avoid the risk of transmission.

ADMISSIONS

The admission process in the University for the Under-graduate (UG) admissions to 237 Merit-based and 07 Entrance-based courses in 67 colleges and departments of the University commenced on 12th October 2020 and closed on 31st December 2020 while for the Post-Graduate (PG) admissions to 74 courses commenced on 18th Nov 2020 and closed on 31st December 2020.

Admissions to all courses were 100% online and contact-less. Centralized admissions were done for all courses. This helped the applicants in terms of movements within cut-offs (for UG Courses)/ admission lists (for PG Courses) in different colleges and courses in a time-bound manner. For UG admissions, there was one registration form for all colleges. No additional fee was taken from the applicants for applying to the colleges.

A group of 18 volunteers involved as Helpdesk, handled all queries and helped the aspirants round the clock through their dedicated mobiles and emails. The Helpdesk was active from the commencement of admissions till the end of it. List of Departmental/College Nodal officers and Helpdesks were prominently displayed on the University and respective Department/College websites.

Six webinars were organized by the branch to help applicants understand the entire process of admissions including filling out the form, uploading documents, reservation policies, updating their records, and other aspects related to admissions. Videos were also made and prominently published on the website to help the applicants fill the forms.

Guidelines were released on a regular basis with each cut-off/ admission list to help students. Admissions under CW/ ECA/ Sports categories were also completely done online.

Data related to admission is as under:

Number of applicants registered for UG Courses: 3,35,434

Number of admissions in UG Courses (including merit, entrance, NCWEB,

Sports, ECA but excluding SOL): 85,163

Number of applicants registered for PG Courses: 1,46,994

Number of admissions in PG Courses (including NCWEB but excluding SOL): 10,796

Number of applicants registered for M.Phil./ Ph.D. Courses: 21,699

A separate grievance committee was also constituted to handle any grievance related to admissions. The Grievance Committee worked in close association with the branch to resolve the cases in a time bound manner. Redressal of grievances was also completely online.

STUDENT ENROLLMENT

As per 2020-21 data, the University has 2,11,590 undergraduate and 29,651 Postgraduate students, including those enrolled for M.Phil./Ph.D. A total of 5,948 students are on the rolls in Certificate/Diploma/PG Diploma courses. The total number of students enrolled in conventional

mode is 2,47,189. Additionally, as many as 3,26,830 students are enrolled in the distance learning and 32,209 non-collegiate women students also form part of this mammoth University. The total enrolment across conventional and distance learning mode in all programmes was 6,06,228 during 2020-21.

Out of the total enrolled students, more than 50 percent belong to states other than the home state of NCT of Delhi. This diversity clearly indicates the academic outreach of the University across the nation and its popularity among the student community as a chosen destination for pursuing higher education.

YUKTI (Young India Combating COVID with Knowledge, Technology and Innovation) Portal

The Ministry of Education had launched a web-portal YUKTI (Young India Combating COVID with Knowledge, Technology and Innovation) on 12th April 2020. The portal intends to cover the different dimensions of COVID-19 challenges in a very holistic and comprehensive way. It covered the various initiatives and efforts of the institutions in academics, research primarily related to COVID, social initiatives by institutions, and the measures taken for the betterment of the total wellbeing of the students. In compliance with the objectives of YUKTI portal, the University of Delhi has taken all adequate steps to ensure comprehensive e-learning, providing support for placement and internships, physical and mental health of the students. Despite the tough times, the University did not lose its focus on strengthening research. The necessary data has been provided and updated on the portal from time to time.

EXAMINATIONS

The University of Delhi became the first Higher Education Institution of the country to successfully conduct the Open Book Examination (OBE) for the final semester/year regular, NCWEB and SOL students during the COVID-19 pandemic, keeping their health and safety at the highest priority. The Open Book Examination received a wide participation and support of the faculty and students.

Confidential results were issued to 650 students to enable them to pursue higher studies.

Digital Initiatives of the Examination

Online provisional certificate: An online portal was developed in December 2020 using which more than 5,000 students were issued digital provisional certificates at their registered email.

Online System for Transcript Application: A system of online receipt of Transcript Application was started in February 2021 to simplify and quicken the process. The 'Fast Track' option facilitates the applicant to receive the transcript in about 10 working days.

Digital Degree: The University of Delhi became the first institution in the country to award "Digital Degrees" to its 1,78,719 students at the 97th Annual Convocation. This provision of issuing Digital Degrees was initiated in September 2020 using which approximately 15,000 digital degrees were issued to the students before the Convocation.

ADMINISTRATIVE AND FINANCIAL PROCESS

The University is ardently following a policy of zero tolerance against corrupt practices through observance of maximum transparency and accountability leading to good governance. The University is at the forefront in implementation of various statutory provisions of the transparency legislation and has always upheld the ethos of interactive processes in the governance structure through appropriate consultation and coordination among the various stakeholders from time to time.

The University meticulously adheres to various rules, processes and norms as per the Government of India policy as communicated from time to time by the University Grant Commission which includes various online initiatives like online payment of fees, eprocurement through GeM, research project management, scholarship disbursement, initiative of Samarth ERP, inventory management, time-table & attendance management, faculty profile management, student grievance redressal and similar such multifarious initiatives over a period of time. It would be an honest endeavour of the University to further pursue the realms of e-governance doing away with paper-intensive existing structure to make it more environment-friendly and to reflect it as a green initiative.

LIBRARY SYSTEM

Besides improving e-Shodh Sindhu, J-Gate@e-Shodh Sindhu, Internet Access Facility, and Electronic Databases, the following digital initiatives have been introduced in the DU library system:

Accessible resources for Visually Impaired

Digital Collection of Ph.D. theses

Plagiarism Detection Software (PDS) - TURNITIN; URKUND through INFLIBNET

The Central Library checks all the Ph.D. thesis through PDS software and provides a verification certificate before final submission of the thesis for award of degree to maintain the required standard.

CAMPUS CONNECT PROJECT AND VALUE-ADDED SERVICES

The University has signed a Memorandum of Understanding with the Ministry of Education (MoE and formerly, MHRD), UGC, and National Informatics Centre Services Inc. (NICSI) for the establishment of a campus-wide Wi-Fi network. This project would augment the existing Wi-Fi connectivity in more than 150 departments/academic units/centres/administrative units and about 20 hostels with a concurrent user base of approximately 30,000 users. RESEARCH HIGHLIGHTS

The University has an unwavering commitment to excellence in teaching, research, and social outreach, which has made it a role model and a benchmark for other universities in the country. Our commitment to distinction in research is evident from numerous publications in the high-ranking peer-reviewed international Journals, including *Nature* and *Science*, and a high h-index. The University's impact and influence on research is also reflected in the citations illustrated by SCOPUS/Web of Science - multidisciplinary scholarly databases. As a research-intensive university, the University of Delhi constantly strives to achieve distinction internationally through excellence in research and innovation to address global, national, and societal challenges.

The rich academic milieu of the University is adequately reflected in the research endeavours of faculty members across disciplines and recognition of their research initiatives and outcomes, both at the national and international level, through recognitions in terms of patenting, funding by prestigious research funding entities amongst others.

Extramural research Grants from some of the notable funding agencies like the DBT, DST, IFICAR, UGC, MOEF, IAEA, ICAR, DRDO, CSIR, MOES, ICMR, MNRE, World Bank, TERI, Indo-USSTF, GAIL, IUAC, ICSSR, MCIT, NUST, University of Norway, University of Turkey, ISRO, SDTT, Vigyan Prasar, DST-SERB, Japan Foundation, SEWA-THDC, MOSJ&E, DAE, MWCD, INSA, TISS-DU, Leverhulme Trust UK, ICHR, clearly showcases the expanse and depth of research initiatives.

If quantum of research grant is a parameter of the expanse of the research initiatives by the faculty members of the is University, it is notable that more than 28 faculty members have ongoing Research Projects with more than Rupees One Crore research grant each. The mandated mission of UBA is inspired by the vision of transformational change in community development processes by leveraging knowledge institutions to help build the architecture of an Inclusive India. The work in the five villages adopted under the programme moved to its fifth year with new teams of students being placed there for field work. Villages having low socio-economic indicators namely Badarpur Khadar, Chauhan Patti, Jagatpur, Mukundpur and Jharoda have been chosen for community development initiatives under the UBA. A team of students under the guidance of faculty members have been taking up need based, planned and sustainable community initiatives in the five communities. The Department of Social Work is playing a lead role in organising community based developmental activities on an ongoing basis and is assisted by other departments from time to time. The teams participate in the joint identification of the problems and felt needs of the particular village; chalk out intervention plans; and then engage in participatory community initiatives to address the same. In the five villages adopted by University of Delhi, sanitation and health are the primary work agenda of the UBA teams. The following programmes formed the core of the UBA outreach of the University:

Activities under Swachh Bharat Abhiyan under the aegis of Unnat Bharat Abhiyan

The School of Open Learning, University of Delhi graciously agreed to fund this initiative of the Unnat Bharat Abhiyan, undertaken by the UBA Team. Under its auspices, a number of programmes were undertaken in all five villages to create awareness regarding the long-term hazards of using 'single-use plastics'. Apart from sensitising people about the items which fall in the hazardous waste category, 'single-use plastic free' drives were organised in the communities, wherein residents were motivated to discard single-use plastics and adopt alternative means such as paper, cloth and jute bags. In these door-to-door campaigns, people were asked to discard all single use plastic from their houses. Student teams collected plastic bags and other objects from the households and distributed cloth bags to facilitate people to switch over to environmentfriendly ways of living. To spread the message students mobilized children of the community holding banners and urging not to use 'single-use plastics" Village teams comprising of students and faculty worked with youth groups too. Women of the community were also mobilised while visiting their homes for asking the 'single- use plastic' waste. They were made aware about the hazardous impact of plastic on their lives and the environment. Principles of community practice like community planning and implementation and full participation of community groups were assiduously applied through students and faculty facilitators.

Camps were organised through which children and women were taught to make paper bags which could be used as an easy substitute for single-use plastic bags. Used newspapers were collected by the students for this purpose. The bags were distributed among families and shops.

This activity was carried out in all the villages under the UBA following the plastic free awareness campaign, so that sustainable alternatives were popularised and made available to the people.

Poster making and slogan writing competitions were also organized in community schools. These generated a diversity of creative outcomes and widespread sensitisation of children on hygiene, sanitation, health and environmental well-being. Children took pledge in which they vowed to abstain from using single-use plastics and to encourage others to do the same. An exhibition on the life of Gandhi was organised by the community children, together with a quiz on the life and values of Gandhi. In the overall context, the active participation of the women, youth and children of the five communities was a sight to behold. The enthusiasm and zeal of community groups were laudable in this movement.

Aadhar Card Camps & India Post Payment Bank Account Camps

This was another vital component of work undertaken under the UBA banner. These camps were organised under the auspices of the National Backward Classes Finance and Development Corporation. UIDAI and India Posts also collaborated for these camps. As all of the communities articulated the widespread problem of errors in Aadhar cards and that many people were still without Aadhar cards, these camps were organised.

The camps provisioned the much-needed opportunity to make new Aadhar cards and to rectify the errors in the existing cards. Before conducting the camp, a survey was conducted in which the prospective beneficiaries were identified. The India Post Payments Bank also organised bank account opening camps wherein accounts for community members were opened. India Posts has initiated banking facilities with the idea of promoting 'Financial inclusion'. The camps were undertaken to promote the habit of savings in the community people.

Health Camps

Health Camps were also organised with the support of Fortis hospital and Netram Eye Foundation. The Department of Social Work volunteered for these camps in all five communities. The student trainees were instrumental in mobilizing people for participation in all phases of the camps. People's participation was overwhelming as they availed the facilities of general physiology, eye check-ups, ear nose throat (ENT) check-ups, measurement of blood pressure and blood sugar levels and disbursement of free medicines.

The student trainees in the five villages have also worked on multiple dimensions of physical, psychological/mental and social health of community constituents over the entire year. They have been involved in strengthening the ICDS programme and transforming the Anganwadi centres from being merely food distribution centers to being nodal resource centers for comprehensive psychological, physical and social development of children. They initiated children centric learning activities with children. In order to make the effort sustainable, they involved adolescent boys and girls who have dropped out from school and trained them to handhold these young ones and guide them towards formal schooling. This has been done on a pilot basis in a few anganwadi centres, and the success of this effort is leading to its replication in other centres. Environmental Consciousness through Street Theatre or Nukkad Nataks were organised in all the communities. The Sukhmanch Theatre group, a renowned group of theatre artists from all over India was mobilised to collaborate for this initiative. There was immense participation by all community groups, including women and youth. A large number of schoolgoing children came to watch the nukkad nataks after their school hours. The theatre group focussed on diverse environmental issues and presented powerful messages like pressing for a 39/

complete ban on plastic use, planting more trees, using public transport, sanitation and healthy living, waste segregation, and many others. The Nigam Parishad also appreciated the work of the entire team of UBA. The team members of the Sukhmanch Theatre Group interacted with the community people and asked for their suggestions and other issues they could include in future performances.

PLACEMENT ACTIVITIES

Placement & Internship Opportunity: - It is indeed an established fact that the world of academia reflects a hub of boundless ideas and possible inventions and innovations. However, the path from research laboratory or classrooms to the market is often unbelievably long, uncertain, undefined and stress- provoking. In this competitive global era, it is often seen that resources are not distributed in an equitable manner, and as a result it becomes an arduous exercise to tap expertise in any predetermined or specified area. In order to bridge the gap between industry and education, the University of Delhi set up Central Placement Cell (CPC) in 2008 under the aegis of the Dean, Students Welfare Office. The main endeavour of CPC is to get students placed in reputed multinationals, government organizations, NGO's and the private sector.

The Central Placement Cell has entered the thirteenth year of its inception. All the previous batches registered with CPC in the past have duly benefited from the industry- students' interaction. Corporate houses from different sectors have participated in the endeavour and recruited a substantial number of students from the university and its colleges during these years. The CPC has extended its database to include Ph.D./Postgraduate/Undergraduate students along with the students from the School of Open Learning and Non-Collegiate Women Education Board. This pool extends to all Colleges and Post Graduate Departments of the University. The CPC certainly ensures a wider choice for recruiters in terms of number and quality of students available on a single platform. The CPC also provides opportunities to the students of 1st & IInd year by encouraging them to participate in Internship Programme. The University of Delhi acknowledges the support and contribution of the corporates in their efforts to encourage and facilitate the recruitment of Differently Abled Students.

In the academic year 2020-21 the placement cell organized recruitments, mega sessions on stress management, counselling and meditation sessions through various digital platforms to rejuvenate and relax students as well as faculty members.
